


WISCONSIN AGRICULTURAL EXPORTS - 2023 FULL YEAR

\$3.87 billion

- Net gain 2021-2023: \$210 million, or 5.3%
- Top 10 products: 68% of total
- Largest product: sauces and yeasts, up 3.4%
 - Meat cuts: up 21.8%
 - Soybeans: up 11.5%

USDA forecast projects a decline in agricultural exports by the end of 2024.





WISCONSIN AGRICULTURAL EXPORTS - 2023 FULL YEAR

3rd highest year on record

- Top 10 markets: 78% of total
 - Mexico: up 38.7%, record level
 - # 7 Netherlands up
 - □ #8 Australia up
- Wisconsin is 11th in U.S. agricultural exports, year to date
- 13th in 2022






WISCONSIN AGRICULTURAL EXPORTS, FULL YEAR 2023 - DAIRY

Dairy exports: \$518 million

- Top 5 countries: 64% of total
- Next 5 of top 10:
 - India up 147%
 - Australia up 18%
 - Brazil up 34%
 - Vietnam and Netherlands down
- Lactose up; all other dairy products down






WISCONSIN AGRICULTURAL EXPORTS, 2023 FULL YEAR - MEAT

Meat exports: \$591 million


- Top 5 countries: 70% of total
 - Korea up 22%
- Japan up 38%
- Mexico up 21%
- Next 5 of top 10: Finland, Germany, UK, Taiwan, Hong Kong
- Germany, UK, Taiwan up double digits





WISCONSIN AGRICULTURAL EXPORTS, 2023 FULL YEAR - CROP

- Crop exports: \$2.58 billion
- Top 5 countries: 70% of total
 - Mexico up 54%; 382% in soybeans
 - Netherlands up 12%, double digits in soybeans
- Next 5 of top 10: Korea, Japan, Australia (up 5%), UK, Italy
- Soybeans and flavoring ingredients up double digits

A Possible Opportunity

to Improve Wisconsin's Expensive Export Transportation Costs

Quality Wisconsin Products go all over the world.

We appreciate the good help from Wisconsin DATCP and Wisconsin Economic Development. Their work supports our sales effort.



For shipping long distance, especially for export, most everyone uses these.

Shipping containers. The world does its business with these metal, intermodal boxes.

On any given day, there are about 90,000,000 of these shipping containers on the ocean going from suppliers to customers

Wisconsin exporters rely on good movement of these Intermodal shipping containers.



To bring the intermodal shipping containers to us, most Wisconsin producers need the containers trucked in from the railroad yard

We load the containers, then send them back by truck to the railroad Intermodal yard. At the railroad Intermodal yard, the containers are loaded onto a Class I railroad. Class I railroads are the big railroads that can take the containers from the Intermodal rail yard to the export ports on the east and west coasts.



Trains can be a super efficient way to move cargo. They can haul miles-long trains full of containers with very few workers.



There is an expensive problem for Wisconsin shippers.

My company, Krueger Lumber, is paying \$1,600 to \$1,700 per container to truck these Intermodal shipping container from the railroad yard to our facility so we can load them. We are located about a 3 hour's drive from the railroad Intermodal yard.

Exporters further away are paying much more. Their truck drivers are limited by how far they can travel in a day, so have to be hired for more than one day.

One of my Chinese customers buys product from all over the eastern half of the USA. He told me the most expensive state to ship from is Wisconsin.

We pay more to truck these containers from the railyards to our sawmill, than we pay from the railyard to China.

These very high container trucking costs put Wisconsin at a competitive disadvantage.




Why oh why does it cost so much to ship containers in Wisconsin?

There are a number of reasons why we Wisconsin exporters pay so much to ship our products.

There is currently only one, publicly accessible Intermodal container railroad yard in Wisconsin. It is in the northwest part of our state in Chippewa Falls

Since there is only one public option in our state for our shipping containers, most containers come from the Chicago area. Only a limited number of trucking companies are allowed to pick up the containers at the Chicago area rail yard. And it is not cheap. It is also overcrowded.



What if we had another Railroad Intermodal yard option in our state?

I have participated in, read, and been to seminars on 3 different Wisconsin Intermodal railroad studies over the past 5 years. Wisconsin DOT does a good job of recognizing how important improving our Intermodal shipping is for our state. Unfortunately, none of these studies has resulted in improvement. To make Intermodal work, you need a large, Class I railroad interested in moving our containers from Wisconsin to the export ports on the east and west coasts.

If we had a Class I railroad's help, we could get a new Intermodal rail yard in Wisconsin. It would give us another option for loading the shipping containers onto the railroad right here in Wisconsin. It could dramatically lower our Wisconsin export transportation costs.

So how do you interest a Class I railroad to help the Intermodal container business in Wisconsin?



You offer to help the railroad make a good profit and still save the shippers of Wisconsin money.

The previous Wisconsin Intermodal studies reported that the Intermodal yard in Green Bay used to "lift" 26,000 containers a year. That Intermodal yard was closed 20 years ago, after our Wisconsin railroad system was bought by the Canadian National Railroad (CN). Container business has grown a lot in the past 20 years.

I was at a railroad conference and spoke to representatives from the Canadian Pacific Kansas City Railroad (CPKCR). They are a Class I railroad competitor of the CN. We discussed the old level of container business that was done out of Green Bay and the high cost to truck the containers to rail yards. Why couldn't the CPKC Railroad take some of that \$1,600 per container truck cost and ship the containers by rail out of Wisconsin?



Oshkosh Intermodal, a potential quick, easy, low-cost solution

With the high number of containers that used to be shipped in Green Bay, and the outrageous trucking costs the exporters of Wisconsin are paying, the CPKC Railroad said they might be interested in giving us some rail service. Why pay the trucking companies all that money when the CPKC Railroad could ship the containers by rail, right here in Wisconsin. But where to put the Intermodal rail yard?


Wisconsin has a relatively new rail transload yard in Oshkosh. Upgraded to help serve the Oshkosh Corp, (think Oshkosh Truck).

That yard is on rail track owned by the state of Wisconsin. It connects to track run by the CPKC Railroad in Milwaukee. Plus, at Oshkosh, we could ask the short line railroad, WATCO, who already run some tracks in Wisconsin, to operate this new, Intermodal rail yard. The representative of CPKC Railroad said they preferred a 3rd party, like WATCO, to operate the Intermodal yard.



Do we try to take advantage of this CPKC Railroad opportunity ?

The representative from CPKC Railroad said they would be willing to sit down with the shippers of Wisconsin, with no firm commitment on their part, to discuss the Oshkosh Intermodal idea. In particular, they want to speak with not only us exporters, but with Wisconsin importers as well. Turns out the importers of containers pay about 3 times as much per containers, as us exporters do.



Improved Intermodal container shipping is critical for our Wisconsin Exports, and more.

A few positives about the Oshkosh Intermodal idea:

- Make our Wisconsin exports more competitive.
- Increase our export sales.
- Reduce truck /dray costs of bringing containers to Intermodal rail yards.
- By loading containers onto railroad here in Wisconsin, we have the potential to load the containers heavy, without paying the overweight fees.
- It would stop the trucking of 10,000's of containers on our highways. Ship them by rail instead.
- Reduced carbon footprint of rail shipping vs truck shipping.
- Avoid the congestion and often poor service of existing Intermodal options.
- There is room at the existing Oshkosh rail transload yard.
- Oshkosh is a relatively low cost and speedy option for our Intermodal problem.
- Oshkosh is in WISCONSIN. It would create jobs here.

WEDC/DATCP Wisconsin Initiative for Agriculture Exports FY'24 Update

WIAE International Market Access Grants

- Through the IMAG, Wisconsin companies can be reimbursed for specific short-term expenses associated with a targeted export project that will help to grow their presence in their identified international market(s).
- WEDC continues to work closely with DATCP to engage Wisconsin agriculture companies to utilize these grant dollars for projects focused on accelerating their export strategy.
- WEDC's current IMAG grant window will close March 15th.

Grant Description

- Up to \$25,000 can be awarded and the company must provide 30% match
- Can be used for export education, trade shows/missions, marketing & promotion, consulting services and product design for export
- Requires 35% of the value of the product or service is composed of Wisconsin inputs
