**SUBJECT:** Ch. ATCP 75– Retail Food Establishments and ATCP 75 Appendix, the  
*Wisconsin Food Code*; Final Rule Draft

**PRESENTED BY:** Dr. Steve Ingham

**REQUESTED ACTION:**

At the January 25, 2018 Board meeting, the Department of Agriculture, Trade and Consumer Protection (“Department”), will ask the Board to approve the final rule (copy attached) related to retail food establishments and the Wisconsin Food Code.

**SUMMARY:**

***Background***

The Department proposes to repeal and recreate Wis. Admin. Code ch. ATCP 75 (Retail Food Establishments) and its Appendix (*Wisconsin Food Code*). This rule will bring Wisconsin into substantial accord with the U.S. Food and Drug Administration’s (FDA) 2013 *Model Food Code*, currently in use.

Normally, the Department updates the *Wisconsin Food Code* every four years, but this cycle, the Department is also updating Wis. Admin. Code ch. ATCP 75 due to the merger of the Department’s Division of Food Safety with the Department of Health Service’s (DHS) Food Safety and Recreational Licensing section in July of 2016. The current Division of Food and Recreational Safety (DFRS) must merge, clarify, and update the rules regulating all retail food establishments, both meal-serving (restaurants) and non-meal serving, as DFRS now oversees licensing and inspection of both business types.

***Rule Content***

With the interagency merger, changes were necessary to merge the different rules used by the two agencies. New language clarifies the responsibilities of food retailers who take advantage of the exemption from the requirement to hold a food processing plant license under Wis. Admin. Code ch. ATCP 70 and wholesale up to 25% of their gross food sales. In addition, the proposed Wis. Admin. Code ch. ATCP 75 will incorporate, for the first time, specific definitions for

“wholesaling” and “retailing” which are now incorporated into Wis. Admin. Code chs. ATCP 70 and ATCP 55 to provide guidance, clarity, and uniformity for food processors and retailers in Wisconsin.

The rule is intended to ensure that all persons doing similar business activities are similarly regulated, but also ensures that all businesses selling at remote locations have the enhanced food safety processes in place, such as a written recall plan and a written food safety production plan as required by rules in Wis. Admin. Code ch. ATCP 70.

The Department worked to combine the duties, activities, and expectations of both the merged agencies in a way that eliminates duplication, clarifies expectations, and, to the extent possible, ensures that multiple licenses are not needed. The Department has, however, balanced these objectives with its responsibility to the public and its mission as food safety regulators to ensure that all food in commerce is produced according to law and under some form of inspection. In order to achieve that goal, this rule proposes that persons holding either a meat establishment license issued by the Department or a grant of meat / poultry inspection from the federal government also obtain a retail food establishment license if they manufacture any meat or poultry products that do not bear an inspection legend for retail sale. Prior to this rule, those meat establishments were allowed to retail up to 25% of *total* meat sales without a retail license because of the frequent state or federal inspection of meat processing overall. However, it was determined during recent discussions with meat inspection staff that meat and poultry products sold at retail without the state or federal mark of inspection, and other aspects of a retail food establishment, were not being inspected by meat inspection staff. Because of this oversight, those establishments should only be able to retail products bearing the inspection legend. With the rule proposal, those meat establishments will be allowed to also obtain a retail food establishment license, and it will be possible for them to continue to sell a full line of products while assuring the consuming public that the food products were subject to a proper inspection. It also levels the playing field for businesses already licensed as retail food establishments to produce meat and poultry products only for retail sale.

The rule focuses on defining and clarifying the rules for micro-markets, vending machines, and the commissaries that serve both of those business types. The commissaries for both micro-markets and vending machines will be licensed as food processing plants, which reflects the operations of these commissaries. In addition, micro-markets are defined with the recognition that they operate without a person in charge at all times in overseeing their operations, which is a requirement for other types of retail food establishments.

Greater clarification is also given to the Department’s rules for Hazard Analysis Critical Control Point (“HACCP”) Plans and HACCP variances, including the procedure for variance applications. New language also simplifies the protocols that establishments must follow for doing vacuum packing and sous-vide processing.

A significant change in the *Wisconsin Food Code* appendix deals with cheese curds. The Department proposes to include language that references a process authority study on cheese curds, which validates the 24-hour at-room temperature limit for display of cheese curds, and,

moreover, allows the Department to meet Standard 1 of the FDA's Retail Food Regulatory Standards Program.

In response to industry comments, requirements for making recent inspection results available to the public have been added, along with a prohibition against any grading or scoring of retail food establishments based on inspections reports or other criteria. The intent of these requirements is to prevent inconsistency and confusion that would result if different jurisdictions used different grading or scoring systems, or if some jurisdictions used a grading system and others did not. The Department feels that providing consumers with the actual inspection report, which is more informative than a grade or score, allows consumers to make their own decision about retail food establishment acceptability.

This proposed rule also harmonizes the different licensing rules used by DHS and the Department for mobile retail food establishment bases. The application of the different sets of rules created a licensing inequity between those operations, depending on the overseeing agency. These inconsistencies have now been eliminated, and the proposed rule also clarifies the rules for using those bases.

The Department renumbered and consolidated many provisions in the *Wisconsin Food Code* to achieve greater ease in use and to allow for the incorporation of rules for micro-markets and vending machines. The Department has also revisited the criteria for licensing fees, changing from income-and-sales-volume-based fees to primarily risk-complexity-based fees.

Other clarifications, changes, and additions include the following:

- Language and terminology are standardized and clarified between the two merged programs.
- The definitions section is expanded to facilitate understanding of the merged language and the new programs.
- The *Wisconsin Food Code* is rearranged to help clarify its contents and applications. It is also expanded to stay current with recent federal and state initiatives.

#### ***Fiscal Impact***

This rule is not anticipated to have a fiscal effect on state resources. It does not require additional staff specifically to enforce the proposed rule. The Department will train staff on the new requirements.

#### ***Business Impact***

The Small Business Regulatory Review Board did not issue a report on this rule. The rule should not have a major economic effect on retail food establishments since it mainly replaces and updates current rules.

For those retail food establishments requiring a licensed base, already-licensed mobile retail food establishments serving meals will see no change in requirements because their bases were

licensed under the DHS rules that were transferred to the Department. Mobile retail food establishments that operate at special events or at temporary events will not need a licensed base, just as mobile retail food establishments serving meals operating at temporary events (such as farmers' markets) currently do not need a licensed base.

For those operators with a base serving mobile retail food establishments that only sell non-perishable packaged foods, the effect will also be minimal. The only operators who may face increased regulatory requirements, and the associated expenses to meet them, are those operators who are also doing complex processing and preparation of potentially hazardous food. Some activities performed in those settings must also be done under the HACCP system, such as fish processing that would require implementation of a Seafood HACCP system (as required in 21 CFR part 123, as cited in s. ATCP 70.44), juice processing that would require implementation of a Juice HACCP system (as required in 21 CFR part 120, as cited in s. ATCP 70.60), or the processing and/or repacking of marine shellfish that would require compliance with the HACCP-based Marine Shellfish Program (found in s. ATCP 70.50).

The proposed ch. ATCP 75 changes the criteria for assigning license fees. The rule more realistically ties the cost of the license to the complexity and food safety hazards of the processing activities going on and not solely to the size of the establishment and dollar volume of sales. In many cases, larger establishments that may have been paying a higher license fee because of the sales volume will now pay a lower fee if their processing is not complex or hazardous. The Department's analyses suggest that the overall change in total license fees charged will be negligible. The proposed licensing fee criteria more fairly reflect the time and personnel costs to the Department for inspection.

The requirement to obtain a retail food establishment license in order to conduct retail sales of meat or poultry products that do not bear an inspection legend should not pose a major fiscal impact on meat establishments operating under state or federal meat inspection programs. Both meat inspection programs require all inspected products to be produced under HACCP. The retail program accepts state or federal HACCP plans for cured or shelf-stable products, and already requires HACCP plans for such products made only under a retail food establishment license. If the proposed rule is not approved, it may not be possible for establishments operating only under federal or Wisconsin meat inspection programs to continue to operate unlicensed, uninspected retail food establishments.

No comments were received during the economic impact comment period held August 8, 2017 - September 7, 2017. However, feedback on the rule was solicited from members of the Food Safety Advisory Council (FSAC), a group comprised of business and local health department agent representatives.

### ***Environmental Impact***

This rule will have essentially no environmental impact.

### ***Federal and Surrounding State Programs***

The FDA does not directly regulate retail food safety, and thus, it does not have a retail inspection or regulation program. The FDA promulgates the *Model Food Code* which is presented as a guide that is generally used in formulating state regulations or directly adopted by state programs.

This rule is generally consistent with rules in neighboring states. Surrounding states have all adopted various versions of the FDA *Model Food Code*. The criteria for retail food establishment license fees differ somewhat from those in surrounding states, in the emphasis placed on complexity and risk of food safety hazards.

- Retail food establishments in Illinois are licensed at the county or municipal level. Cook County does not have a separate category for mobile retail food establishment bases. Licensing fees for retail food establishments are based on whether the establishment has seats for customers and if not, the total area occupied by the business. Chicago differentiates licenses for mobile food dispensers and mobile food preparers.
- Minnesota has different license categories for mobile and stationary retail food businesses, with the fee based on sales volume. There is no separate Minnesota license category for mobile retail food establishment bases. Retail food establishments (not restaurants) in Minnesota are primarily regulated by the Department of Agriculture. Minnesota restaurants are primarily regulated by county or municipal agencies. Hennepin County, for example, sets license fees based on menu breadth, degree of hazard of menu items, and size of operation, with separate categories for mobile and itinerant businesses.
- Iowa has a separate license category for a commissary serving a mobile retail food establishment. The retail food establishment category in Iowa includes restaurants.
- Michigan includes restaurants as a type of retail food establishment and has separate categories for mobile and mobile commissary operations.

### *Changes from the Hearing Draft*

The Department incorporated all technical corrections suggested by the Legislative Council Rules Clearinghouse. Changes based on the public hearings and comments sent to the Department are listed in **Appendix A**.

### *Next Steps*

If the Board and the Governor approve this rule, the Department will transmit the final rule to the Legislature for review by the appropriate legislative committees. If the Legislature approves the rule, the Secretary will sign the final rulemaking order and transmit it for publication.

4. Plain Language Analysis of the Rule, its Impact on the Policy Problem that Justified its Creation and Changes in Technology, Economic Conditions or Other Factors Since Promulgation that alter the need for or effectiveness of the Rule.

The Department is updating Wis. Admin. Code ch. ATCP 75 by incorporating large parts of repealed Wis. Admin. Code ch. DHS 196 (Restaurants) and repealing rules in ch. ATCP 75 dealing with agent programs. These agent program rules are now found in the new Wis. Admin. Code ch. ATCP 74 (Local Agents and Regulation) which also incorporates provisions from the repealed Wis. Admin. Code ch. DHS 193.

With the transfer of the Food Safety and Recreational Licensing section from Department of Health Services to the Department in July 2016, changes were made to merge the rules used by the two agencies. New language clarifies the responsibilities of food retailers who take advantage of the exemption from the requirement to hold a food processing plant license under ch. ATCP 70 but wholesale up to 25% of their gross food sales. In addition, the proposed Wis. Admin. Code ch. ATCP 75 will incorporate, for the first time, specific definitions for “wholesaling” and “retailing” which are now being incorporated into Wis. Admin. Code chs. ATCP 70 and ATCP 55 to provide guidance, clarity, and uniformity for food processors and retailers in Wisconsin.

The proposed rule is intended to ensure that all persons doing similar business activities are similarly regulated. The proposed rule also ensures that all businesses selling at remote locations have the enhanced food safety processes in place, such as a written recall plan and a written food safety production plan as required by rules in Wis. Admin. Code ch. ATCP 70.

The Department worked to combine the duties, activities, and expectations of both the merged agencies in a way that eliminates duplication, clarifies expectations, and, to the extent possible, ensures that multiple licenses are not needed. The Department has, however, balanced these objectives with its responsibility to the public and its mission as food safety regulators to ensure that all food in commerce is produced according to law and under some form of inspection. In order to achieve that goal, this rule proposes that persons holding either a meat establishment license issued by the Department or a grant of meat / poultry inspection from the federal government also obtain a retail food establishment license if they manufacture any meat or poultry products that do not bear an inspection legend for retail sale. Prior to this rule, those meat establishments were allowed to retail up to 25% of total meat sales without a retail license because of the frequent state or federal inspection of meat processing overall. However, it was determined during recent discussions with meat inspection staff that meat and poultry products sold at retail without the state or federal mark of inspection, and other aspects of a retail food establishment, were not being inspected by meat inspection staff. Because of this oversight, those establishments should only be able to retail products bearing the inspection legend. With the rule proposal, those meat establishments will be allowed to also obtain a retail food establishment license, and it will be possible for them to continue to sell a full line of products while assuring the consuming public that the food products were subject to a proper inspection. It also levels the playing field for businesses already licensed as retail food establishments to produce meat and poultry products only for retail sale.

---

The rule focuses on defining and clarifying the rules for micro-markets, vending machines, and the commissaries that

serve both of those business types. The commissaries for both micro-markets and vending machines will be licensed as food processing plants, which reflects the operations of these commissaries. In addition, micro-markets are defined with the recognition that they operate without a person in charge at all times in overseeing their operations, which is a requirement for other types of retail food establishments.

Greater clarification is also given to the Department's rules for Hazard Analysis Critical Control Point ("HACCP") Plans and HAACP variances, including the procedure for variance applications. New language also simplifies the protocols that establishments must follow for doing vacuum packing and sous-vide processing.

A significant change in the Wisconsin Food Code appendix deals with cheese curds. The Department proposes to include language that references a process authority study on cheese curds, which validates the 24-hour at-room temperature limit for display of cheese curds and, moreover, allows the Department to meet Standard 1 of the FDA's Retail Food Regulatory Standards Program.

In response to industry comments, requirements for making recent inspection results available to the public have been added, along with a prohibition against any grading or scoring of retail food establishments based on inspection reports or other criteria. The intent of these requirements is to prevent inconsistency and confusion that would result if different jurisdictions used different grading or scoring systems, or if some jurisdictions used a grading system and others did not. The Department feels that providing consumers with the actual inspection report, which is more informative than a grade or score, allows consumers to make their own decision about retail food establishment acceptability.

This proposed rule also harmonizes the different licensing rules used by DHS and the Department for mobile retail food establishment bases. The application of the different sets of rules created a licensing inequity between those operations, depending on the overseeing agency. These inconsistencies have now been eliminated, and the proposed rule also clarifies the rules for using those bases.

The Department renumbered and consolidated many provisions in the Wisconsin Food Code to achieve greater ease in use and to allow for the incorporation of rules on micro-markets and vending machines. The Department has also revisited the criteria for licensing fees, changing from income-and-sales-volume-based fees to primarily risk-complexity-based fees.

Other clarifications, changes, and additions include the following:

- Language and terminology are standardized and clarified between the two merged programs.
- The definitions section is expanded to facilitate understanding of the merged language and the new programs.
- The Wisconsin Food Code is rearranged to help clarify its contents and applications. It is also expanded to stay current with recent federal and state initiatives.

### 5. Describe the Rule's Enforcement Provisions and Mechanisms

The Department has broad general authority, pursuant to s. 93.07 (1), Stats., to adopt rules to implement programs under its jurisdiction. The Department also has general authority, pursuant to s. 97.09 (4), Stats., to adopt rules specifying standards to protect the public from the sale of adulterated or misbranded foods. The Department has specific authority, pursuant to s. 97.30 (5), Stats., to adopt rules dealing with fees; setting facility construction and maintenance standards; setting rules for the design, installation, maintenance, and cleaning of equipment and utensils; personnel standards; food handling and storage; sanitary production and processing of food; food sources and food labeling.

7. Summary of the Impacts, including Compliance Costs, identifying any Unnecessary Burdens the Rule places on the ability of Small Business to conduct their Affairs.

The rule should not have a major economic effect on retail food establishments since it mainly replaces and updates current rules.

For those retail food establishments requiring a licensed base, already-licensed mobile retail food establishments serving meals will see no change in requirements because their bases were licensed under the DHS rules that were transferred to the Department. Mobile retail food establishments that operate at special events or at temporary events will not need a licensed base, just as mobile retail food establishments serving meals operating at temporary events (such as farmers' markets) currently do not need a licensed base.

For those operators with a base serving mobile retail food establishments that only sell non-perishable packaged foods, the effect will also be minimal. The only operators who may face increased regulatory requirements, and the associated expenses to meet them, are those operators who are also doing complex processing and preparation of potentially hazardous food. Some activities performed in those settings must also be done under the HACCP system, such as fish processing that would require implementation of a Seafood HACCP system (as required in 21 CFR part 123, as cited in Wis. Admin. Code s. ATCP 70.44), juice processing that would require implementation of a Juice HACCP system (as required in 21 CFR part 120, as cited in Wis. Admin. Code s. ATCP 70.60), or the processing and/or repacking of marine shellfish that would require compliance with the HACCP-based Marine Shellfish Program (found in Wis. Admin. Code s. ATCP 70.50).

The proposed Wis. Admin. Code ch. ATCP 75 changes the criteria for assigning license fees. The rule more realistically ties the cost of the license to the complexity and food safety hazards of the processing activities going on and not solely on the size of the establishment and dollar volume of sales. In many cases, larger establishments that may have been paying a higher license fee because of the sales volume will now pay a lower fee if their processing is not complex or hazardous. The Department's analyses suggest that the overall change in total license fees charged will be negligible. The proposed licensing fee criteria more fairly reflect the time and personnel costs to the Department for the inspection.

The requirement to obtain a retail food establishment license in order to conduct retail sales of meat or poultry products that do not bear an inspection legend should not pose a major fiscal impact on meat establishments operating under state or federal meat inspection programs. Both meat inspection programs require all inspected products to be produced under HACCP. The retail program accepts state or federal HACCP plans for cured or shelf-stable products, and already requires HACCP plans for such products made only a retail food establishment license. If the proposed rule is not approved, it may not be possible for establishments operating under federal or Wisconsin meat inspection programs to continue to operate unlicensed, uninspected retail food establishments.

The proposed changes in criteria for license fees were tested by applying the criteria to businesses in a representative county and evaluating the license fee change to each retail food establishment in that county.

Local Governmental Units and Public Utility Rate Payers:

The rule may have an impact on local governmental units because it defines licensing categories that may or may not be used by local agent health programs. There will be no impact to public utility rate payers. Overall, this is an update of existing regulations.

### Fiscal Impact:

Because food processing plants are already regulated by the Department, this rule will not have a significant fiscal impact on state government, and the Department will absorb any costs with current budget and staff.

The Department anticipates a slight loss in retail food establishment licensing revenue (<5%) because of the revisions to the licensing category tables in the rule. However, it is possible that the loss in revenue would be balanced by potential revenue from new licensing of mobile restaurant bases and shifting many mobile restaurant bases and vending commissary licenses from agent programs to the Department. Some of those entities were operating as wholesalers and were not eligible for licensure by agent programs.

The FDA does not have a retail food inspection or regulation program. The FDA promulgates the Model Food Code, a guide used in formulating state regulations or adopted by state programs to promote a uniform level of food safety throughout the nation.

This rule is generally consistent with rules in neighboring states. Surrounding states have all adopted various versions of the FDA's Model Food Code. IL: Retail food establishments in Illinois are licensed at the county or municipal level. Cook County does not have a separate category for mobile retail food establishment bases. Chicago differentiates licenses for mobile food dispensers and mobile food preparers.

MN: Minnesota has different license categories for mobile and stationary retail food businesses, with the fee based on sales volume. Retail food establishments (not restaurants) in Minnesota are primarily regulated by the Department of Agriculture. Minnesota restaurants are primarily regulated by county or municipal agencies. Hennepin County, for example, sets license fees based on menu breadth, degree of hazard of menu items, and size of operation, with separate categories for mobile and itinerant businesses.

IA: Iowa has a separate license category for a commissary serving a mobile retail food establishment. The retail food establishment category in Iowa includes restaurants.

MI: Michigan includes restaurants as a type of retail food establishment and has separate categories for mobile and mobile commissary operations.

***Rule Summary***

The Department is updating Wis. Admin. Code ch. ATCP 75 by incorporating large parts of repealed Wis. Admin. Code ch. DHS 196 (Restaurants) and repealing rules in Wis. Admin. Code ch. ATCP 75 dealing with agent programs. These agent program rules are now found in the new Wis. Admin. Code ch. ATCP 74 (Local Agents and Regulation), which also incorporates rules from the repealed Wis. Admin. Code ch. DHS 192.

With the transfer of the Food Safety and Recreational Licensing section from Department of Health Services (DHS) to the Department in July 2016, changes were made to merge the rules used by the two agencies. New language clarifies the responsibilities of food retailers who take advantage of the exemption from the requirement to hold a food processing plant license under Wis. Admin. Code ch. ATCP 70 but wholesale up to 25% of their gross food sales. In addition, the proposed Wis. Admin. Code ch. ATCP 75 will incorporate, for the first time, specific definitions for “wholesaling” and “retailing” which are now being incorporated into Wis. Admin. Code chs. ATCP 70 and ATCP 55 to provide guidance, clarity, and uniformity for food processors and retailers in Wisconsin.

The rule is intended to ensure that all persons doing similar business activities are similarly regulated, but also ensures that all businesses selling at remote locations have the enhanced food safety processes in place, such as a written recall plan and a written food safety production plan as required by rules in Wis. Admin. Code ch. ATCP 70.

The Department worked to combine the duties, activities, and expectations of both the merged agencies in a way that eliminates duplication, clarifies expectations, and, to the extent possible, ensures that multiple licenses are not needed. The Department has, however, balanced these objectives with its responsibility to the public and its mission as food safety regulators to ensure that all food in commerce is produced according to law and under some form of inspection. In order to achieve that goal, this rule proposes that persons holding either a meat establishment license issued by the Department or a grant of meat / poultry inspection from the federal government also obtain a retail food establishment license if they manufacture any meat or poultry products that do not bear an inspection legend for retail sale. Prior to this rule, those meat establishments were allowed to retail up to 25% of *total* meat sales without a retail license because of the

frequent state or federal inspection of meat processing overall. However, it was determined during recent discussions with meat inspection staff that meat and poultry products sold at retail without the state or federal mark of inspection, and other aspects of a retail food establishment, were not being inspected by meat inspection staff. Because of this oversight, those establishments should only be able to retail products bearing the inspection legend. With the rule proposal, those meat establishments will be allowed to also obtain a retail food establishment license, and it will be possible for them to continue to sell a full line of products while assuring the consuming public that the food products were subject to a proper inspection. It also levels the playing field for businesses already licensed as retail food establishments to produce meat and poultry products only for retail sale.

The rule focuses on defining and clarifying the rules for micro-markets, vending machines, and the commissaries that serve both of those business types. The commissaries for both micro-markets and vending machines will be licensed as food processing plants, which reflects the operations of these commissaries. In addition, micro-markets are defined with the recognition that they operate without a person in charge at all times in overseeing their operations, which is a requirement for other types of retail food establishments.

Greater clarification is also given to the Department's rules for Hazard Analysis Critical Control Point ("HACCP") Plans and HACCP variances, including the procedure for variance applications. New language also simplifies the protocols that establishments must follow for doing vacuum packing and sous-vide processing.

A significant change in the *Wisconsin Food Code* appendix deals with cheese curds. The Department proposes to include language that references a process authority study on cheese curds, which validates the 24-hour at-room temperature limit for display of cheese curds, and, moreover, allows the Department to meet Standard 1 of the FDA's Retail Food Regulatory Standards Program.

In response to industry comments, requirements for making recent inspection results available to the public have been added, along with a prohibition against any grading or scoring of retail food establishments based on inspections reports or other criteria. The intent of these requirements is to prevent inconsistency and confusion that would result if different jurisdictions used different grading or scoring systems, or if some jurisdictions used a grading system and others did not. The Department feels that providing consumers with the actual inspection report, which is more informative than a grade or score, allows consumers to make their own decision about retail food establishment acceptability.

This proposed rule also harmonizes the different licensing rules used by DHS and the Department for mobile retail food establishment bases. The application of the different sets of rules created a licensing inequity between those operations, depending on the overseeing agency. These inconsistencies have now been eliminated, and the proposed rule also clarifies the rules for using those bases.



The Department renumbered and consolidated many provisions in the *Wisconsin Food Code* to achieve greater ease in use and to allow for the incorporation of rules for micro-markets and vending machines. The Department has also revisited the criteria for licensing fees, changing from income-and-sales-volume-based fees to primarily risk-complexity-based fees.

Other clarifications, changes, and additions include the following:

- Language and terminology are standardized and clarified between the two merged programs.
- The definitions section is expanded to facilitate understanding of the merged language and the new programs.
- The *Wisconsin Food Code* is rearranged to help clarify its contents and applications. It is also expanded to stay current with recent federal and state initiatives.

### ***Small Businesses Affected***

The rule should not have a major economic effect on retail food establishments since it mainly replaces and updates current rules. No comments were received during the economic impact comment period held August 8, 2017 - September 7, 2017. However, feedback on the rule was solicited from members of the Food Safety Advisory Council (FSAC), a group comprised of business and local health department agent representatives.

For those retail food establishments requiring a licensed base, already-licensed mobile retail food establishments serving meals will see no change in requirements because their bases were licensed under the DHS rules that were transferred to the Department. Mobile retail food establishments that operate at special events or at temporary events will not need a licensed base, just as mobile retail food establishments serving meals operating at temporary events (such as farmers' markets) currently do not need a licensed base.

For those operators with a base serving mobile retail food establishments that only sell non-perishable packaged foods, the effect will also be minimal. The only operators who may face increased regulatory requirements, and the associated expenses to meet them, are those operators who are also doing complex processing and preparation of potentially hazardous food. Some activities performed in those settings must also be done under the HACCP system, such as fish processing that would require implementation of a Seafood HACCP system (as required in 21 CFR part 123, as cited in Wis. Admin Code s. ATCP 70.44), juice processing that would require implementation of a Juice HACCP system (as required in 21 CFR part 120, as cited in Wis. Admin. Code s. ATCP 70.60), or the processing and/or repacking of marine shellfish that would require compliance with the HACCP-based Marine Shellfish Program (found in Wis. Admin. Code s. ATCP 70.50).

The proposed Wis. Admin. Code ch. ATCP 75 changes the criteria for assigning license fees. The rule more realistically ties the cost of the license to the complexity and food safety hazards of the processing activities going on and not solely to the size of the establishment and dollar volume of sales. In many cases, larger establishments that may have been paying a higher license fee because of the sales volume will now pay a lower fee if their processing is not complex or hazardous. The Department's analyses suggest that the overall change in total license fees charged will be negligible. The proposed licensing fee criteria more fairly reflects the time and personnel costs to the Department for the inspection.

The requirement to obtain a retail food establishment license in order to conduct retail sales of meat or poultry products that do not bear an inspection legend should not pose a major fiscal impact on meat establishments operating under state or federal meat inspection programs. Both meat inspection programs require all inspected products to be produced under HACCP. The retail program accepts state or federal HACCP plans for cured or shelf-stable products, and already requires HACCP plans for such products made only under a retail food establishment license. If the proposed rule is not approved, it may not be possible for establishments operating under federal or Wisconsin meat inspection programs to continue to operate unlicensed, uninspected retail food establishments.

#### ***Reporting, Bookkeeping and other Procedures***

The proposed rule would not require any additional reporting, bookkeeping, or other procedures.

#### ***Professional Skills Required***

The proposed rule does not require any new professional skills by small businesses.

#### ***Accommodation for Small Business***

This rule does not actually make an accommodation for the *size* of the business as much as it makes accommodation for the *complexity* of the business. The rule more realistically ties the cost of a retail food establishment license to the complexity of the processing activities going on and the food safety risk of those activities. In some cases, larger establishments that may have been paying a higher license fee because of the sales volume will now have that fee reduced if their processing is not complex.

The FDA does not make accommodations for food safety practices based on size, so Wisconsin does not do so either. Non-complex operations of any size are now charged less for a license than a complex operation even if the dollar volume of sales is much higher for the non-complex. The proposed licensing fee criteria more fairly reflects the time and personnel costs to the Department for the inspection.

As noted, feedback on the rule was solicited from members of FSAC. The proposed changes in criteria for license fees were tested by applying the criteria to businesses familiar to FSAC members and by evaluating the license fee change to each retail food establishment in a representative county.

***Conclusion***

The provisions in the rule will benefit Wisconsin's retail food industry and are expected to impose very limited additional costs. It is quite possible that many large, non-complex establishments will actually see a reduction in cost since they are no longer charged for a license based on size and dollar volume of sales.

This rule will not have a significant adverse effect on "small business" and is not subject to the delayed "small business" effective date provided in s. 227.22(2)(e), Stats.

DATCP will, to the maximum extent feasible, seek voluntary compliance with this rule.

**Analysis Prepared by the Department of Agriculture, Trade and Consumer Protection**

The Wisconsin Department of Agriculture, Trade and Consumer Protection (“Department”) proposes to repeal and recreate Wis. Admin. Code ch. ATCP 75 (Retail Food Establishments) and also repeal and recreate Wis. Admin. Code ch. ATCP 75, Appendix (*Wisconsin Food Code*). This rule is necessary to update the *Wisconsin Food Code*, as the Department is currently operating on the Wisconsin version of the 2009 Federal Food and Drug Administration (FDA) *Model Food Code*. This rule will bring Wisconsin into substantial accord with the FDA 2013 *Model Food Code*, currently in use.

Normally, the Department updates the *Wisconsin Food Code* every four years, but this cycle, the Department is also updating Wis. Admin. Code ch. ATCP 75 due to the merger of the Department’s Division of Food Safety with the Department of Health Service’s (DHS) Food Safety and Recreational Licensing section in July of 2016. The current Division of Food and Recreational Safety (DFRS) must merge, clarify, and update the rules regulating all retail food establishments, both meal-serving (restaurants) and non-meal serving, as DFRS now oversees licensing and inspection of both business types.

***Statutes Interpreted***

Statutes Interpreted: ss. 97.30, Stats., “Retail food establishments”; 97.29, Stats., “Food processing plants”; 97.42, Stats., “Compulsory inspection of livestock or poultry, and meat and poultry products; 97.605, Stats., “Lodging and vending licenses”; and 97.61, Stats, “Vending machine commissary outside the state”.

The Department worked to combine the duties, activities, and expectations of both DHS and DATCP in a way that eliminates duplication, clarifies expectations, and, to the extent possible, ensures that multiple licenses are not needed for small businesses. The Department has also revisited the criteria for licensing fees, changing from income-and-sales-volume-based fees to primarily risk-complexity-based fees. The fiscal effect of these changes was tested by applying the criteria to businesses in a representative county and evaluating the license fee change to each retail food establishment.

### ***Effect on Small Business***

The rule should not have a major economic effect on retail food establishments since it mainly replaces and updates current rules. For those retail food establishments requiring a licensed base, already-licensed mobile retail food establishments serving meals will see no change in requirements because their bases were licensed under the DHS rules that were transferred to the Department. Mobile retail food establishments that operate at special events or at temporary events will not need a licensed base, just as mobile retail food establishments serving meals operating at temporary events (such as farmers' markets) currently do not need a licensed base.

For those operators with a base serving mobile retail food establishments that only sell non-perishable packaged foods, the effect will also be minimal. The only operators who may face

increased regulatory requirements, and the associated expenses to meet them, are those operators who are also doing complex processing and preparation of potentially hazardous food. Some activities performed in those settings must also be done under the HACCP system, such as fish processing that would require implementation of a Seafood HACCP system (as required in 21 CFR part 123, as cited in Wis. Admin. Code s. ATCP 70.44), juice processing that would require implementation of a Juice HACCP system (as required in 21 CFR part 120, as cited in Wis. Admin. Code s. ATCP 70.60), or the processing and/or repacking of marine shellfish that would require compliance with the HACCP-based Marine Shellfish Program (found in Wis. Admin. Code s. ATCP 70.50).

The proposed Wis. Admin. Code ch. ATCP 75 rule changes the criteria for assigning license fees. The rule more realistically ties the cost of the license to the complexity and food safety hazards of the processing activities going on and not solely on the size of the establishment and dollar volume of sales. In many cases, larger establishments that may have been paying a higher license fee because of the sales volume will now pay a lower fee if their processing is not complex or hazardous. The Department's analyses suggest that the overall change in total license fees charged will be negligible. The proposed licensing fee criteria more fairly reflects the time and personnel costs to the Department for the inspection.

The requirement to obtain a retail food establishment license in order to conduct retail sales of meat or poultry products that do not bear an inspection legend should not pose a major fiscal impact on meat establishments operating under state or federal meat inspection programs. Both meat inspection programs require all inspected products to be produced under HACCP. The retail program accepts state or federal HACCP plans for cured or shelf-stable products, and already requires HACCP plans for such products made only under a retail food establishment license. If the proposed rule is not approved, it may not be possible for establishments operating only under federal or Wisconsin meat inspection programs to continue to operate unlicensed, uninspected retail food establishments.

### ***Standards Incorporated by Reference***

Substantial sections of the 2013 FDA *Model Food Code* were incorporated where the provisions did not conflict with the Department's compliance and enforcement programs.

41 **Subchapter I — Definitions and General Provisions**

42 **ATCP 75.01 Authority and purpose.**

43 **(1)** The department licenses and regulates retail food establishments as defined in this  
44 chapter under s. 97.30, Stats. Under s. 97.41 (1m), Stats., the department may also authorize

45 local health departments as local agents of the department to license and regulate retail food  
46 establishments.

47 (2) The department has adopted this chapter under authority provided in ss. 93.07 (1), 97.12,  
48 97.30 (5), 97.33, 97.613, 97.62, 97.625, 97.65 and 227.14 (1s), Stats., which authorizes the  
49 department to prescribe rules for retail food establishments and to enforce those rules for the  
50 purpose of protecting public health and safety. This chapter, including ch. ATCP 75 Appendix,  
51 establishes definitions; sets standards for management and personnel and for safe food  
52 operations, equipment, and facilities; provides for retail food establishment plan review, license  
53 issuance, inspection, and enforcement actions; and requires food protection practices certification  
54 for retail food establishment operators.

55 (3) During an inspection to evaluate compliance with this chapter and the appendix, the  
56 department or its agent shall assess existing facilities or equipment that were in use before the  
57 effective date of this chapter and the appendix....[LRB inserts date] based on all of the following  
58 considerations:

59 (a) Compliance with food-contact surface requirements in 4-101; ch. ATCP 75 Appendix.

60 (b) Compliance with requirements for cooling, heating, and holding temperature capability in  
61 equipment under 4-301.11; ch. ATCP 75 Appendix.

62 **ATCP 75.02 Applicability.**

63 (1) The provisions of this chapter, including ch. ATCP 75 Appendix, apply to any retail food  
64 establishment as defined in this chapter.

65 (2) A business or an organization operating as a retail food establishment that is exempt from  
66 licensing as a retail food establishment shall still meet the requirements as specified under sub.

67 (1).

68        **ATCP 75.03 Adoption of Wisconsin food code.** As permitted by s. 227.14 (1s), Stats., an  
69 amended version of the 2013 U.S. food and drug administration (FDA) recommended model  
70 food code, adopted as ch. ATCP 75 Appendix, is adopted and retitled the Wisconsin food code  
71 and is in the format of the FDA–recommended food code to ensure uniformity.

72        **ATCP 75.04 Definitions.** In this chapter:

73        (1) “Active managerial control” means the purposeful incorporation of systems in a retail  
74 food establishment that proactively reduce the risk of foodborne illness hazards through  
75 monitoring and verification.

76        (2) “Additional area” means a non-contiguous, separately located area that is on the same  
77 premises, but that is not a part of the primary food processing or warewashing operation, but  
78 contributes to the overall food operation. “Additional area” includes but is not limited to a  
79 banquet staging area, bakery preparation area, produce preparation area, or outdoor cooking area.

80        (3) “Adulterated” has the meaning specified in 21 USC 342.

81        (4) “Agent” means the city, county, village, or consortium designated by the department in  
82 accordance with s. 97.41 Stats., to issue licenses and make investigations and inspections of  
83 retail food establishments under this chapter.

84        (5) “Amenable” means animal species or products made from animal species subject to  
85 mandatory inspection under state or federal meat and poultry inspection regulations.

86        (6) “Catering” means contracting for the preparation and service of a defined amount of food  
87 at a specific location other than the licensed retail food establishment to a defined set of guests at  
88 a wedding or similar event, or to participants in an organized group or activity. Catering does not  
89 include sale of individual meals directly to the consumer.

90 (7) “Cold holding” means maintaining a time/temperature controlled for safety food (TCS)  
91 under refrigeration at a temperature of 41°F or below.

92 (8) “Concession stand” means a food stand that serves meals in connection with a youth  
93 sporting event, and is operated exclusively for the benefit of a participating youth sports team or  
94 program, or the governing youth sports organization.

95 (9) “Condiment” means a non-meal food item added to food to enhance flavor or enjoyment.

96 **Note:** Sauces, dressings, relishes and spices are examples of condiments.

97 (10) “Contract cook” is a person who is under contract to only prepare food onsite, with  
98 food provided by the contractor, for a private occasion to the contractor or the contractor’s  
99 guests.

100 (11) “Cooling” means the process of reducing the temperature of a TCS food by refrigeration  
101 or alternate methods to a temperature of 41°F or below within a defined time period. Cooling  
102 does not include removing a TCS food from refrigeration during processing at ambient air  
103 temperature and then immediately returning the food to refrigeration.

104 (12) “Department” means the Wisconsin department of agriculture, trade, and consumer  
105 protection.

106 (13) “Division” means the division of food and recreational safety.

107 (14) “Extensively remodeled” means the condition of an existing retail food establishment  
108 that has undergone reconstruction or repair that altered the design or operation of the food  
109 service area, beyond redecorating, cosmetic refurbishing, replacing like equipment, or altering  
110 seating design or capacity.

111 (15) “Food” has the meaning given in s. 97.01 (6), Stats.

112 (16) “General public” means any person choosing to patronize a retail food establishment  
113 including, but not limited to employees, members, guests, customers, or occupants of private

114 clubs, industrial plants, offices, or businesses. “General public” does not include any of the  
115 following:

116 (a) Members of a household or personal guests in a private home, who are served a meal  
117 prepared by a member of the household.

118 (b) Persons who are served a free meal by a religious or other nonprofit charitable  
119 organization, as defined under 26 USC 501 (c), at a kitchen, shelter or similar location where  
120 meals are served to the needy.

121 (c) Members and guests of a religious organization, such as a church, synagogue, temple, or  
122 mosque, who are served a meal in conjunction with a religious service or celebration when the  
123 meal is prepared by members of the religious organization.

124 (d) Members and guests of a fraternal, patriotic, or service organization who are served a  
125 meal prepared by the organization’s members or affiliates, when the meal is part of, or incidental  
126 to, a meeting of the organization.

127 (e) Employees attending an occasional meal prepared by their coworkers for the purpose of  
128 expressing appreciation or building workplace morale.

129 (f) Guests attending a meal served in connection with a birthday, anniversary, or similar  
130 celebration if the food is prepared by persons participating in the celebration.

131 (g) Residents, patients, employees, or visitors of patients or residents of a health care  
132 facility, defined in s. 150.84 (2), Stats.

133 (h) Residents, clients, employees, or visitors of residents or clients of a facility licensed  
134 under ch. 48, Stats.



135 (i) Inmates, residents, employees, or guests of inmates or residents of a prison, defined in s.  
136 302.01, Stats., a county jail, defined in s. 302.30, Stats., a juvenile correctional facility, defined  
137 in s. 938.02 (10p), Stats., or a juvenile detention facility, defined in s. 938.02 (10r), Stats.

138 (17) “Health department” has the meaning given it in s. 250.01 (4), Stats.

139 (18) “Hot holding” means maintaining a TCS food at a temperature of 135°F. or above after  
140 cooking or reheating.

141 (19) “Imminent health hazard” means a condition that presents a substantial likelihood to  
142 cause severe adverse health consequences or death.

143 (20) “Locally sponsored sporting event” means a competitive game, taking place inside or  
144 outside, specifically for youth, that is organized or sponsored by one or more local business,  
145 governmental, or other civic organization, or by parents of the youth, including a  
146 school-sponsored interscholastic sports competition.

147 (21) “Meal” means food that is ordered, prepared for, or served to a customer with or without  
148 a beverage and is obtained from the establishment in a ready-to-eat form with the expectation of  
149 immediate consumption, although consumption may occur at another location. “Meal” does not  
150 include single-bite sized free food samples or an equivalent portion given away to demonstrate  
151 the characteristics of the food.

152 (22) “Micro Market” means an unstaffed, self-service area located within an existing  
153 business, office, or employee break area that is not accessible to the general public and is  
154 accessible only to persons authorized by the person in control of the premises, where a customer  
155 may obtain one or more unit servings of food or beverage, that may be a TCS food, either in bulk  
156 or in a package before payment is made at an automated kiosk or by other automated method,

157 without the necessity of replenishing the food accessibility area between each transaction. A  
158 micro market is not considered a vending machine.

159 (23) “Micro market operator” means the owner or operator responsible for the operation of  
160 one or more micro markets.

161 (24) “Mobile retail food establishment” has the meaning of “mobile food establishment”  
162 given in 1-201.10 (B); ch. ATCP 75 Appendix.

163 (25) “Mobile or transient retail food establishment-not serving meals” means any of the  
164 following:

165 (a) A mobile retail food establishment as defined in sub. (24) or a transient retail food  
166 establishment as defined in sub. (39) where food processing is conducted primarily for direct  
167 retail sale of “time/temperature control for safety food” to consumers at the mobile or transient  
168 facility, and does not prepare, serve, or sell any meals.

169 (b) A mobile retail food establishment as defined in sub. (24) or a transient retail food  
170 establishment as defined in sub. (39) from which food is sold to consumers at retail, whether or  
171 not that mobile or transient facility sells “time/temperature control for safety food” or processes  
172 food, and does not prepare, serve, or sell any meals.

173 (26) “Mobile or transient retail food establishment-serving meals” means a mobile retail food  
174 establishment as defined in sub. (24) or a transient retail food establishment as defined in sub.  
175 (39) that prepares, serves, or sells any meals.

176 (27) “New retail food establishment” means a retail food establishment not previously  
177 operated by the current license applicant.

178 (28) “Occasional” or “occasionally” means not more than 12 days for non-meal food  
179 sales and not more than 3 days for meal food sales during any licensing year.

180       **(29)**     “Person” has the meaning in 1-201.10; ch. ATCP 75 Appendix.

181       **(30)** “Personal Chef” means an individual who is hired to prepare meals in a person’s private  
182 home for that individual, their family, or non-paying guests.

183       **(31)** “Potluck” means an event to which all of the following conditions apply:

184       (a) Attendees of the event provide food and beverages to be shared with other attendees and  
185 consumed at the event.

186       (b) No compensation is provided to any person who conducts or assists in providing the  
187 event or who provides food and beverages to be shared at the event, and no compensation is paid  
188 by any person for consumption of food or beverages at the event.

189       (c) The event is sponsored by any of the following:

- 190           1. A church.
- 191           2. A religious, fraternal, youth, or patriotic organization or service club.
- 192           3. A civic organization.
- 193           4. A parent–teacher organization.
- 194           5. A senior citizen center or organization.
- 195           6. An adult day care center.

196       **(32)**     “Retail” means selling food or food products directly to any consumer only for  
197 consumption by the consumer or the consumer’s immediate family or non-paying guests.

198       **(33)** “Retail food establishment” includes all of the following:

- 199       (a) Retail food establishment- not serving meals as defined in sub. (34).
- 200       (b) Retail food establishment- serving meals as defined in sub. (35).
- 201       (c) Vending machine as defined in sub. (40).
- 202       (d) Micro-Market as defined in sub. (22).

203 (e) Mobile or transient retail food establishment-not serving meals as defined in sub. (25).

204 (f) Mobile or transient retail food establishment-serving meals as defined in sub. (26).

205 (g) Retail food establishment serving prepackaged meals as defined in sub. (36).

206 **(34)** “Retail food establishment- not serving meals” means any of the following:

207 (a) A permanent retail food establishment where food processing is conducted primarily for  
208 direct retail sale of “time/temperature controlled for safety food” to consumers at the facility, and  
209 the total non-meal sales exceed 51% of all retail food sales.

210 (b) A permanent retail food establishment from which food is sold to consumers at retail,  
211 whether or not that facility sells “time/temperature controlled for safety food” or processes food,  
212 and the total non-meal sales exceed 51% of all retail food sales.

213 **(35)** “Retail food establishment- serving meals” means a permanent retail food establishment  
214 operating as a restaurant where the total meal sales exceed 51% of all retail food sales. A retail  
215 food establishment- serving meals includes any building, room, or place where meals are  
216 prepared, served, or sold to the general public and all places used in connection with the  
217 building, room, or place; and any public or private school lunchroom for which food service is  
218 provided by contract. A retail food establishment- serving meals does not include any of the  
219 following:

220 (a) Taverns that serve free lunches consisting of popcorn, cheese, crackers, pretzels, cold  
221 sausage, cured fish, or bread and butter.

222 (b) Non-profit organizations under 26 USC 501 (c), that include churches; religious,  
223 fraternal, youth, or patriotic organizations; service clubs; and civic organizations that  
224 occasionally prepare, serve, or sell meals to transients or the general public.

225 (c) Any public or private school lunchroom for which food service is directly provided by  
226 the school.

227 (d) Bed and breakfast establishments.

228 (e) A licensed vending machine that serves food or beverages.

229 (f) Any college campus as defined in s. 36.05 (6m), Stats., institution as defined in s.  
230 36.51 (1) (b), Stats., or technical college that serves meals only to the students enrolled in the  
231 college campus, institution, or school or to authorized elderly persons under s. 36.51 or 38.36,  
232 Stats.

233 (g) A concession stand at a locally sponsored sporting event, such as a little league game.

234 (h) A potluck event.

235 **(36)** “Retail food establishment serving prepackaged meals” means a retail food establishment  
236 – serving meals that only serves individually wrapped single food servings that are prepared and  
237 packaged off-premises by a food processing plant or retail food establishment licensed under  
238 s. ATCP 75.06 (1), with preparation at the retail food establishment limited to heating and  
239 serving by establishment personnel.

240 **(37)** “Special event” means (a) A department-recognized event that is sponsored, planned,  
241 organized, and publicly advertised by organizations that include the following:

242 1. Neighborhood associations.

243 2. Religious groups.

244 3. Cultural groups.

245 4. Political parties.

246 5. Churches.

247 6. Schools.

248 7. Sports teams.

249 8. Fraternal organizations.

250 9. Non-profit organizations.

251 10. City, county, state or federal governments.

252 (b) Special events are limited to gatherings of people for concerts; sporting events; trade  
253 shows; flea markets or farmers markets; public exhibitions by artists, craftsman, or vehicle  
254 enthusiasts; a fair, carnival, circus, or governmentally recognized celebration based on a specific  
255 calendar date such as a holiday or anniversary; or any other event approved by the regulatory  
256 agency. A “potluck” is not a “special event”.

257 (38) “Time/temperature control for safety food” or “TCS food” has the meaning given in 1-  
258 201.10 (B); ch. ATP 75 Appendix.

259 (39) “Transient retail food establishment” means a temporary retail food establishment that  
260 operates at a fixed location in conjunction with a special event and sells or serves food for a  
261 period of no more than 14 consecutive days or in conjunction with an occasional sales  
262 promotion.

263 (40) “Vending machine” means any self-service device offered for public use which, upon  
264 insertion of a coin or token, or by other means, dispenses unit servings of food or beverage either  
265 in bulk or in package, without the necessity of replenishing the device between each vending  
266 operation. “Vending machine” does not include a device which dispenses only bottled,  
267 prepackaged or canned soft drinks, a one cent vending device, a vending machine dispensing  
268 only candy, gum, nuts, nut meats, cookies, or crackers, or a vending machine dispensing only  
269 prepackaged grade A pasteurized milk or milk products.

270 (41) “Vending machine location” has the meaning in s. 97.01 (15w), Stats.

271 (42) “Vending machine operator” has the meaning prescribed in s. 97.01 (15y), Stats.

272 (43) “Wholesale” means the transfer of any food to a person or commercial entity who will  
273 either re-sell it, distribute it, or use it as an ingredient in a product that will be then offered for  
274 sale or distribution. Wholesale also means the transfer of food from the point of production to  
275 another location for sale even if the other location is adjacent to the point of production.

276 **Subchapter II – Licensing and Fees**

277 **ATCP 75.06 Retail food establishments; licensing.**

278 (1) LICENSE REQUIRED. Except as provided under s. ATCP 75.063, no person may operate a  
279 retail food establishment without a valid license issued by the department or its agent. Issuance  
280 of a retail food establishment license shall be done in accordance with all of the following:

281 (a) Each retail food establishment shall have a separate license.

282 (b) The current retail food establishment license issued by the department or its agent shall  
283 be posted in a place visible to the general public. A license may not be altered or defaced.

284 (c) A retail food establishment license is not transferable between persons or establishments.

285 **Note:** Local health departments that are agents for the department in an area that is regulated by the local health  
286 department have authority under s. 97.615 (2) (d), Stats., to establish and collect fees for licenses issued by the local  
287 health department. The operator of a retail food establishment licensed by a local health department should contact  
288 the local health department for its license fee schedule.

289  
290 (2) LICENSE DURATION AND RENEWAL.

291 (a) Each license issued under this subchapter expires on June 30, except that a license  
292 initially issued during the period beginning on April 1 and ending on June 30 expires on June 30  
293 of the following year, except when any of the following conditions exist:

294 1. The local health department of a city of the 1st class that has entered into an agreement  
295 with the department under s. 97.41 (1m), Stats., may issue to a retail food establishment the

296 license required under sub. (1) at any time during the year. A license issued under this  
297 subdivision shall expire one year from the date of its issuance.

298 2. A retail food establishment may request an extension to the term of a license issued under  
299 par. (a) by the local health department of a city of the 1st class that has entered into an agreement  
300 with the department under s. 97.41 (1m), Stats., for the purpose of aligning the annual term of  
301 any other license or permit issued to that retail food establishment with the annual term of a  
302 license to be issued to that retail food establishment under subd. 1. The local health department  
303 may require a retail food establishment that receives an extension under this subdivision to pay a  
304 prorated fee in an amount determined by dividing the license fee imposed under s. 97.41 (4),  
305 Stats., by 12 and multiplying the quotient by the number of months by which the license issued  
306 under par. (a) is extended under this subdivision.

307 (b) Each license shall be renewed annually as provided in sub. (3).

308 (c) Transient retail food establishment licenses shall be valid for a period not to exceed 14  
309 days in conjunction with a specific special event.

310 **(3) LICENSE APPLICATION AND RENEWAL.** (a) *Initial license.* A person applying for a retail  
311 food establishment license shall apply on a form provided by the department or its agent. The  
312 application form shall be properly completed and be accompanied by all applicable fees required  
313 under this section and any previous fees due to the department.

314 Note: To obtain a copy of the retail food establishment license application form, or to determine which agent to  
315 contact for an application form, call (608) 224-4923 or send an email to [datcpdfslicensing@wi.gov](mailto:datcpdfslicensing@wi.gov).

316 (b) *License renewal.* To renew the license of a retail food establishment, the license fee  
317 specified under s. ATP 75.08 Table B, shall be paid to the department before the license  
318 expires. If the payment to renew the license of a retail food establishment is not made to the  
319



320 department before the license expiration date, the late fee specified under s. ATCP 75.08 Table B  
321 shall be paid in addition to the license fee.

322 Note: Contact the department at (608) 224-4720 for questions regarding a retail food establishment license  
323 renewal or to determine which agent to contact.

324  
325 (c) *Refusal of license issuance or renewal.* The department or its agent may refuse to issue or  
326 renew a license to operate a retail food establishment under any of the following circumstances:

327 1. The department or its agent has not conducted a pre-licensing inspection of a new retail  
328 food establishment.

329 2. The owner of a retail food establishment has not corrected a violation for which the  
330 department or agent has issued a written health or safety related order.

331 3. All applicable fees under s. ATCP 75.08 have not been paid, including the permit fee,  
332 pre-licensing fee, reinspection fee, or other applicable fees.

333 4. The operator or applicant has modified, repaired, or maintained the retail food  
334 establishment in a manner that does not comply with ch. ATCP 75 Appendix.

335 5. The operator or applicant has violated ch. 97, Stats., ch. ATCP 75, or any order,  
336 ordinance, or regulation created by a village, city, county, or local board of health having  
337 jurisdiction, provided such violation is related to the operation of the retail food establishment.

338 **(4) ACTION ON LICENSE APPLICATION.** Within 30 business days after the department or its  
339 agent receives a complete license application, the department or its agent shall do one of the  
340 following:

341 (a) Grant the application.

342 (b) Deny the application. If the department or its agent denies the application it shall give the  
343 applicant written notice specifying the reasons for the denial.

344 (5) PRE-LICENSING INSPECTION. Except as specified in pars. (a) and (b), the department or its  
345 agent may not issue a license for a new retail food establishment until it conducts a pre-licensing  
346 inspection of the new retail food establishment for compliance with this chapter and all fees in s.  
347 ATCP 75.08 Table B have been paid, including any applicable pre-licensing fee.

348 (a) A pre-licensing inspection may not be conducted for a transient retail food establishment,  
349 vending machine, or vending machine operator.

350 (b) A pre-licensing inspection may not be conducted and a pre-licensing fee may not be  
351 charged under any of the following conditions:

352 1. An individual transfers ownership of the retail food establishment to an immediate family  
353 member, as defined in s. 97.605 (4) (a) 2., Stats.

354 2. A retail food establishment remains at the location for which the license was issued and at  
355 least one individual who had an ownership interest in the sole proprietorship or business entity to  
356 which the license was issued retains an ownership interest in the newly formed sole  
357 proprietorship or business entity.

358 3. A mobile retail food establishment without change in ownership transfers from an agent-  
359 issued license to a State-issued license.

360 (6) CONDITIONAL LICENSE. Except as provided in s. 93.135, Stats., the initial issuance,  
361 renewal, or continued validity of a license issued under this section may be conditioned upon the  
362 requirement that the license holder correct a violation of this chapter and its Appendix, s. 97.605,  
363 Stats., or ordinances adopted under s. 97.615 (2) (g), Stats., within a period of time specified by  
364 the department or its agent. If the condition is not met within the specified time or after an  
365 extension of time as approved by the department or its agent, the license is void. No person may  
366 operate a retail food establishment after a license has been voided under this paragraph, and any

367 person who does so shall be subject to the penalties under ss. 97.72 and 97.73, Stats. An operator  
368 whose license is voided under this paragraph may appeal the decision under s. ATCP 75.14 or s.  
369 ATCP 75.16. The operator may reapply for a new license when they have met requirements  
370 under this chapter.

371 **(7) VOIDED LICENSE FOR FAILURE TO PAY FEES.** If an applicant or owner fails to pay all  
372 applicable fees, late fees, and processing charges under s. ATCP 75.08 (3) within 15 days after  
373 the applicant or owner receives notice of an insufficiency or within 45 days after the expiration  
374 of the license, whichever occurs first, the license is void. An owner whose license is voided  
375 under this subsection may appeal the decision under s. ATCP 75.14 or s. ATCP 75.16. In an  
376 appeal concerning a voided license under this subsection, the burden of proof is on the license  
377 applicant or owner to show that all applicable fees, late fees, and processing charges have been  
378 paid. During any appeal process concerning a payment dispute, operation of the retail food  
379 establishment is deemed to be operation without a license and is subject to the fees under s.  
380 ATCP 75.08 (3) (e) in addition to the fees otherwise due, unless the applicant or owner meets its  
381 burden of proof under this subsection.

382 **(8) LICENSE HOLDER QUALIFICATIONS.** To qualify for a license, an applicant shall do all of  
383 the following:

384 (a) Be an owner of the retail food establishment or an officer of the legal entity owning the  
385 retail food establishment.

386 (b) Comply with the requirements of this chapter.

387 (c) Allow authorized representatives of the department or its agent access to the retail food  
388 establishment and to provide required information to those authorized representatives.

389 (d) Pay the applicable license fees at the time the application is submitted.

390 **ATCP 75.063 Retail food establishments; license exemptions.** A retail food establishment  
391 license is not required under s. 97.30 (2) (b), Stats., or this section for any of the following:

392 (1) A retail food establishment that sells only packaged foods or fresh fruits and vegetables,  
393 provided the establishment does not sell “time/temperature control for safety food” and does not  
394 engage in food processing.

395 (2) A retail food establishment operated by a person holding a food processing plant license  
396 under s. 97.29, Stats., if all the following apply:

397 (a) The person operates the retail food establishment at the same location as the licensed  
398 food processing plant.

399 (b) Sales from the retail food establishment are included in the computation of the food  
400 processing plant license fee under s. ATCP 70.06.

401 (c) Retail food sales from that location comprise no more than 25% by dollar volume of all  
402 food sales from that location.

403 (d) The operator of the food processing plant is not engaged in the activity of a retail food  
404 establishment – serving meals.

405 (3) A retail food establishment operated by a person holding a dairy plant license under s.  
406 97.20, Stats., if all the following apply:

407 (a) The person operates the retail food establishment at the same location as the licensed  
408 dairy plant.

409 (b) Food sales from that location, other than sales of dairy products produced at that  
410 location, comprise no more than 25% by dollar volume of all dairy and nondairy food sales from  
411 that location.

412 (c) The operator of the dairy plant is not engaged in the activity of a retail food  
413 establishment – serving meals.

414 (4) A vending machine commissary, micro-market commissary, vending machine warehouse  
415 or micro-market warehouse that is licensed under chs. ATCP 70 and 71.

416 (5) A retail food establishment primarily engaged in selling honey, cider, sorghum, or maple  
417 syrup produced by the operator of the retail food establishment if no other food processing  
418 activities are conducted at that retail food establishment.

419 (6) A retail food establishment – not serving meals, operated occasionally by a religious,  
420 charitable or nonprofit organization as defined under 26 USC 501 (c).

421 (7) A retail food establishment – serving meals, operated by a church; religious, fraternal,  
422 youth, or patriotic organization; service club; or civic organization as defined under 26 USC 501  
423 (c), that occasionally prepares, serves, or sells meals to transients or the general public.

424 (8) A contract cook who does all of the following:

425 (a) Is paid for his or her service, culinary skills, technique, or expertise.

426 (b) Uses the food provided by the contractor employing the cook's services.

427 (c) Does not prepare or store food in quantities sufficient for use at multiple sites or for  
428 meals served to the general public. If a contract cook prepares or stores food in bulk quantities  
429 for use at multiple sites or for meals served to the general public, the contract cook shall obtain a  
430 food processing plant license.

431 (d) Does not transport any portion of a meal prepared by the contract cook from one location  
432 to another location. If a contract cook transports any portion of a meal prepared by the contract  
433 cook from one location to another location, the contract cook shall obtain a food processing plant  
434 license.

435 (9) A personal chef who does all of the following:

436 (a) Is paid for his or her service, culinary skills, technique, or expertise.

437 (b) Either uses food provided by the contractor employing the chef's services or the chef  
438 shops for food from a list provided by the contractor.

439 (c) Uses only the home kitchen of the contractor to prepare food for the contractor,  
440 contractor's family, or contractor's non-paying guests.

441 (d) Does not prepare or store food in quantities sufficient for use at multiple sites or for  
442 meals served to the general public. If a personal chef prepares or stores food in bulk quantities  
443 for use at multiple sites or for meals served to the general public, the personal chef shall obtain a  
444 food processing plant license.

445 (e) Does not transport any portion of a meal prepared by the personal chef from one location  
446 to another location. If a personal chef transports any portion of a meal prepared by the personal  
447 chef from one location to another location, the personal chef shall obtain a food processing plant  
448 license.

449 (10) The location where a caterer is serving food that was prepared at the caterer's licensed  
450 retail food establishment.

451 **ATCP 75.065 Retail food establishments; license exemption for food processing. (1) A**  
452 licensed retail food establishment may wholesale up to 25% of the gross annual sales of food that  
453 is manufactured and used in the retail food establishment without obtaining an additional food  
454 processing plant license under ch. ATCP 70. This exemption does not allow the manufacturing  
455 for wholesale or distribution of any of the following:

456 (a) Food that must be processed in compliance with 21 CFR Parts 108, 113, 114, 120, or 123;  
457 or high acid food products in hermetically sealed containers.

458 (b) Dairy products or amenable meat and poultry products.

459 (c) Food processed at a mobile or transient retail food establishment.

460 (2) A retail food establishment engaging in activities under sub. (1) is not exempt from the  
461 requirements in ch. ATCP 70.

462 **ATCP 75.067 License holder responsibilities.** Upon acceptance of the license issued by  
463 the department or its agent, the license holder in order to retain the license shall do all of the  
464 following:

465 (1) Comply with the provisions of this chapter and its Appendix, including the conditions of  
466 a variance granted as specified under 1-106.14; ch. ATCP 75 Appendix.

467 (2) If a retail food establishment is required under 1-106.11; ch. ATCP 75 Appendix to  
468 operate under a HACCP plan, comply with the plan as specified under 1-106.14; ch. ATCP 75  
469 Appendix.

470 (3) Immediately contact the department or its agent to report an illness of a food employee  
471 or conditional employee as specified under 2-201.11(B); ch. ATCP 75 Appendix.

472 (4) Immediately discontinue operations and notify the department or its agent if an imminent  
473 health hazard may exist.

474 (5) Replace existing facilities and equipment that no longer comply with the criteria set forth  
475 in ch. ATCP 75 Appendix.

476 (6) Comply with directives of the department or its agent including deadlines for taking  
477 corrective actions specified in inspection reports, notices, orders, warnings, and other directives  
478 issued by the department or its agent in regard to the license holder's retail food establishment or  
479 in response to community emergencies.

480 (7) Accept notices issued and served by the department or its agent according to law.

481 (8) Be subject to the administrative, civil, injunctive, and criminal remedies authorized in  
482 law for failure to comply with ch. ATCP 75 Appendix, and any other directive of the department  
483 or its agent, including deadlines for corrective actions specified in inspection reports, notices,  
484 orders, warnings, and other directives.

485 **ATCP 75.07 Mobile retail food establishment base; licensing. (1)** Except for a mobile  
486 retail food establishment that operates only as a transient retail food establishment, all mobile  
487 retail food establishments shall have a base with its own license. A copy of the base license shall  
488 be submitted to the department or its agent upon application for a mobile retail food  
489 establishment license.

490 (2) The base shall be appropriate to support all the activities that will occur at the mobile  
491 retail food establishment, such as food preparation activities, cleaning and sanitization, storage,  
492 water, and waste water handling and disposal.

493 (3) A copy of the base license shall be posted in a visible location in the mobile retail food  
494 establishment.

495 (4) A regulatory authority inspection report from the last 12 months for the base location  
496 shall be provided upon request by the department or its agent.

497 (5) A copy of the schedule for the use of the base shall be provided to the department or its  
498 agent upon request.

499 (6) The department or its agent shall, upon request, be provided with details showing how the  
500 food will be stored, prepared, and held for service on the mobile retail food establishment.

501 (7) The department and its agent shall honor a current base license from another state if the  
502 relevant conditions under this section are met.



503 (8) The department may grant a variance as specified in 1-104.11; ch. ATCP 75 Appendix  
504 for a mobile food establishment to operate without a licensed base.

505 **ATCP 75.075 Plan review.** An operator of a new or extensively remodeled retail food  
506 establishment shall submit a retail food establishment plan to the department or its agent. The  
507 department or its agent may require an operator to submit this documentation when a change of  
508 ownership has occurred.

509 (1) APPROVAL REQUIRED. An operator shall obtain plan approval from the department or its  
510 agent before any of the following occurs:

- 511 (a) The operator begins construction of a retail food establishment.
- 512 (b) The operator modifies or extensively remodels a retail food establishment.

513 (2) APPLICATION FOR PLAN APPROVAL. (a) An applicant for plan approval shall submit all of  
514 the following to the department or its agent:

- 515 1. A fully and accurately completed, signed, and dated application for plan approval on a  
516 form provided by the department or its agent.
- 517 2. Equipment layout plans.
- 518 3. Equipment schedules.
- 519 4. Detailed descriptions of food processing operations.
- 520 5. Menus.
- 521 6. Copies of other state, county, or municipal approvals relating to the operation of the retail  
522 food establishment.
- 523 7. A copy of the plans and specifications drawn to scale or a drawing indicating distance of  
524 separation measured in feet in accordance with the applicable requirements of this chapter.

525 8. Any other information required by the department or its agent regarding the operation of  
526 the retail food establishment as it relates to the health, safety, and welfare of the public.

529 (b) If the department or its agent receives a plan or application that is not completed as  
530 specified in par. (a), the department shall contact the operator to seek additional information.

531 (c) Within 30 days after receipt of complete information under par. (a) or any additional  
532 information requested under par. (b), the department or its agent shall approve or deny the plan.

533 If the department or its agent approves the plan, the department or its agent shall issue a plan  
534 approval letter to the operator. If the department or its agent denies a plan, the applicant shall be  
535 given the reason, in writing, for the denial. The applicant may appeal the decision made by the  
536 department or its agent under ss. ATCP 75.14 and 75.16.

537 **ATCP 75.08 Retail food establishment fees. (1) RETAIL FOOD ESTABLISHMENT LICENSE**  
538 **CATEGORY ASSIGNMENT.**

539 (a) *Criteria.*

540 1. Except for a retail food establishment serving only prepackaged foods or meals, a  
541 transient retail food establishment, a vending machine, a micro market, or a mobile retail food  
542 establishment base with no food preparation, the department shall assign a retail food  
543 establishment to a license category by evaluating the complexity of the retail food establishment  
544 based on the criteria specified in Table A in this section.

545 2. A retail food establishment whose point value is not greater than 2, shall be assigned to  
546 the simple license category.

547 3. A retail food establishment whose point value is at least 3 but not greater than 4 shall be  
548 assigned to the moderate license category.

549 4. A retail food establishment whose point value is 5 or more shall be assigned to the  
 550 complex license category.

551 5. A retail food establishment that has been ordered closed by the department or its agent or  
 552 that has caused a foodborne illness outbreak shall immediately have their license assigned to the  
 553 complex category for the current and following licensing year. If no further outbreaks or  
 554 closures occur, the license may be reduced to the appropriate license category assignment.

555 **Note:** The cause of a foodborne illness outbreak is determined using standard epidemiological practices.

556  
 557 (b) *Point values for determining factors for assigning a retail food establishment license*

567 (c) *Request for different license category assignment.* The operator of a retail food  
568 establishment may ask the department to reconsider the retail food establishment license  
569 category assignment within 30 days of the category assignment.

578           **Note:** A person applying for an annual retail food establishment license may be required to pay, in addition to  
579 the license fee listed in Table B, a weights and measures inspection fee under s. ATCP 92.12.

581           **(3) TYPES OF FEES. (a) *Pre-licensing inspection fee.*** The owner of a retail food establishment  
582 shall pay to the department the applicable pre-licensing inspection fee listed in Table B in this  
583 section before a license is issued to a new retail food establishment under s. ATCP 75.06.

584           **(b) *License fee.***

585           1. Except as specified in subd. 2., the operator of a retail food establishment shall pay an  
586 annual license fee to the department as listed in Table B in this section for each retail food  
587 establishment that the operator applies for a license to operate under s. ATCP 75.06. The annual  
588 license fee shall be based on the point values assigned to the retail food establishment under  
589 Table A in this section.

590           2. Table A in this section does not apply to a retail food establishment serving prepackaged  
591 meals or a retail food establishment - not serving meals with only prepackaged foods, a transient  
592 retail food establishment, a mobile retail food establishment base with no food service or  
593 processing activities, a vending machine and vending machine operator, or a micro market. Fees  
594 for these retail food establishments are listed separately in Table B of this section.

595           **(c) *Late fee.*** If the license fee for a license renewal is not paid before the expiration date of the  
596 license, the owner of the retail food establishment shall pay to the department the applicable late  
597 fee as indicated in Table B in this section in addition to the renewal license fee.

598           **(d) *Reinspection fee.*** If the department reinspects a retail food establishment because the  
599 department has found a violation of ch. 97, Stats., this chapter, or its Appendix during the  
600 preceding inspection, the department shall charge the retail food establishment operator the  
601 reinspection fee specified in Table B in this section. A reinspection fee is payable when the  
602 reinspection is completed, and is due upon written demand from the department. The department

603 may issue a demand for payment if it issues a license renewal application form to the retail food  
604 establishment operator. If an additional reinspection is required to correct violations of ch. 97,  
605 Stats., this chapter, or its Appendix, the department shall assess an additional reinspection fee as  
606 listed in Table B in this section.

607 (e) *Operating without a license fee.* Any retail food establishment found to be operating  
608 without a license shall pay to the department the applicable fee indicated in Table B in this  
609 section for their designated license category. For any vending machine found to be operating  
610 without a license, the operator shall pay to the department 3 times the annual vending machine  
611 license fee listed in Table B in this section in addition to all applicable fees.

612 **Note:** Anyone operating a retail food establishment without a license is also subject to a fine of not less than  
613 \$100 nor more than \$1,000 under s. 97.72, Stats.

614 (f) *Fees for special condition inspections.* For each inspection or consultation activity that is  
615 not directly related to the department's licensing responsibilities, the department may charge the  
616 operator or the entity requesting the inspection or consultation \$175.  
617

618 (g) *Fee for operating without a Certified Food Manager.* The department shall charge the  
619 operator of a retail food establishment \$150 for operating without a Certified Food Manager as  
620 required in s. 97.33 Stats.

621 **Note:** Certified Food Manager requirements may be found in Chapter 12 of ch. ATPC 75 Appendix.

622 (4) **METHOD OF PAYMENT.** If the payment for a retail food establishment license is by check  
623 or other draft drawn upon an account containing insufficient funds, the applicant or owner shall,  
624 within 15 days after receipt of notice from the department of the insufficiency, pay all applicable  
625 fees and the financial institution's processing charges by cashier's check or other certified draft,  
626 or money order.  
627

628 **Subchapter III – Enforcement and Appeals**

629           **ATCP 75.10 Enforcement. (1)** INSPECTIONS AND ACCESS TO THE PREMISES.

630           (a) *Inspections.* Under s. 97.12 (1) Stats., for the purpose of enforcing this chapter, the  
631 department and its agents may, at reasonable hours, enter and inspect any premises for which a  
632 license is required under this chapter or any farm, factory, warehouse, building, room,  
633 establishment or place at or in which foods are manufactured, processed, packed, packaged,  
634 stored or held for sale, and may enter any vehicle, including a vehicle used to transport or hold  
635 foods in commerce. The department and its agents may also secure samples or specimens,  
636 including samples or specimens of food and any product or substance that may affect food,  
637 examine and copy relevant documents and records, and obtain photographic and other evidence  
638 needed to enforce this chapter or a rule promulgated under this chapter. The department shall  
639 examine any samples secured and shall conduct other inspections and examinations needed to  
640 determine whether there is a violation of this chapter. The department shall pay or offer to pay  
641 the market value of samples taken.

642           (b) *Reinspections.* The department or its agent may re-inspect a retail food establishment  
643 whenever an inspection or the investigation of a complaint reveals the existence of a violation  
644 that is potentially hazardous to the health and welfare of patrons or employees of the retail food  
645 establishment. The time between an inspection, investigation, and a reinspection shall be  
646 sufficient to allow the owner time to correct the deficiencies. A reinspection fee shall be charged  
647 for the reinspection according to s. ATCP 75.08, Table B, or the applicable charges as  
648 determined by an agent of the department. If an additional reinspection is required because a  
649 violation has not been corrected, the department shall assess the owner an additional reinspection  
650 fee according to s. ATCP 75.08, Table B, or the applicable charges as determined by an agent of



651 the department. The department may order the owner to show just cause why the license should  
652 not be suspended or revoked under s. ATCP 75.12.

653 **(2) GENERAL ORDERS TO CORRECT VIOLATIONS.** (a) If upon inspection of a retail food  
654 establishment, the department or agent finds that the retail food establishment is not designed,  
655 constructed, equipped or operated as required under ch. 97 Stat., ch. ATCP 75, or its Appendix,  
656 the department or agent shall issue a written order to correct the violation. The order shall  
657 specify the correction needed for compliance and the deadline by which the correction shall be  
658 made. The deadline specified in the order may be extended at the discretion of the department or  
659 agent.

660 (b) If the requirements of an order to correct violations are not met by the deadline stated in  
661 the order, or any extension of time granted for compliance, the department or agent may issue an  
662 order under s. ATCP 75.12 to suspend or revoke the license to operate the retail food  
663 establishment.

664 (c) Under s. 97.12 (5), Stats., any person who fails to comply with an order of the  
665 department shall forfeit \$50 for each day of noncompliance after the order is served upon or  
666 directed to the person. A person may appeal a forfeiture under s. ATCP 75.14.

667 **(3) HOLD ORDERS.** As specified under s. 97.12 (2) Stats.:

668 (a) Whenever any duly authorized inspector of the department has reasonable cause to  
669 believe that any food examined by him or her is adulterated or misbranded and is dangerous to  
670 health or misleading to the injury or damage of the purchaser or consumer, the inspector shall  
671 issue and deliver to the owner or custodian of the food a holding order prohibiting the sale or  
672 movement of the food for any purpose until the analysis or examination of the sample obtained  
673 has been completed. A holding order may be effective for a period of no longer than 14 days

674 from the time of its delivery and it may be reissued for one additional 14-day period if necessary  
675 to complete the analysis or examination of the food.

676 (b) No food described in a holding order issued and delivered under par. (a) may be sold or  
677 moved for any purpose without the approval of the department until such analysis or examination  
678 has been completed within the time specified in par. (a). Upon completion of the analysis or  
679 examination either of the following may apply:

680 1. If the department upon completed analysis or examination determines that the food  
681 described in such holding order is not adulterated or misbranded, then the owner or custodian  
682 thereof shall be promptly notified in writing, and such holding order shall terminate upon  
683 notification.

684 2. Where the analysis or examination shows that the food is adulterated or misbranded and  
685 is dangerous to health or misleading to the injury or damage of the purchaser or consumer, the  
686 owner or custodian of the food shall be notified in writing within the effective time of the  
687 holding order. Such notice has the effect of a special order issued under s. 93.18, Stats. Upon  
688 receipt of a notice, the food subject to the holding order may not be sold, moved, disposed of or  
689 brought into compliance with applicable standards without the approval of the department. If  
690 such food is not brought into compliance, sold, moved, or disposed of within 30 days, or other  
691 agreed upon period of time, from the date the owner or custodian received notice that the food  
692 was adulterated or misbranded, the department may issue an order directing the disposition of the  
693 food. Such an order has the effect of a special order issued under s. 93.18, Stats.

694 (c) Any person violating an order issued under this subsection may be fined not more than  
695 the maximum amount or imprisoned not more than one year in the county jail or both. The

696 maximum fine under this paragraph equals \$10,000 plus the retail value of the product moved,  
697 sold, or disposed of in violation of the order issued under this subsection.

698 **(4) SPECIAL ORDERS AND ORDERS TO ABATE A DANGER TO PUBLIC HEALTH.** As specified  
699 under s. 97.12 (3), Stats.:

700 (a) The department may issue a special order as provided under s. 93.18 Stats., to any  
701 person engaged in the production, processing, sale, or distribution of food if the department finds  
702 a violation of this chapter or the rules promulgated under this chapter. An order shall state the  
703 violations found and shall specify a deadline for correction.

704 (b) If the department finds that a piece of equipment, a facility, or a practice used is a  
705 danger to public health, it may order that the situation be abated or eliminated immediately and  
706 that the equipment, facility or practice not be used until the violation is corrected and the  
707 correction is confirmed by the department. The department may, instead of issuing an order,  
708 accept written agreements of voluntary compliance which have the effect of an order.

709 **ATCP 75.12 Suspension or revocation of license.** The department may, by summary  
710 order and without prior notice or hearing, suspend a license issued under this chapter if the  
711 department finds that there has been a substantial failure to comply with the applicable  
712 requirements of this chapter and the rules promulgated under this chapter and that the  
713 continuation of the violations constitutes a serious danger to public health. The order shall be in  
714 writing, have the force and effect of an order issued under s. 93.18, Stats., and is subject to right  
715 of hearing before the department, if requested within 10 days after date of service.

716 **ATCP 75.14 Appeals of actions by the department; right of hearing.** If requested in  
717 writing within 10-days after date of the service of an order, a hearing shall be conducted within

718 10 days after receipt of a request for a hearing. Enforcement of the order shall not be stayed  
719 pending action on the hearing.

720 **ATCP 75.16 Appeals of actions by agent health departments.** If an agent issues a  
721 license under this chapter, the agent shall create and follow enforcement and appeal procedures  
722 under s. 66.0417 Stats.

723 **Subchapter IV – Standards for Retail Food Establishments**

724 **ATCP 75.18 Qualifications of an authorized representative conducting inspections.** An  
725 authorized representative of the department or its agent who inspects a retail food establishment  
726 or conducts a plan review for compliance with ch. ATCP 75 and its Appendix shall meet the  
727 staffing qualification requirements set forth in s. ATCP 74.08.

728 **ATCP 75.20 Inspections. (1) REFUSED INSPECTION; PROCESS.** If a person denies access to the  
729 department or its agent, the department or its agent shall inform the person of all the following  
730 conditions:

731 (a) The license holder is required to allow access to the department or its agent as specified  
732 under s. ATCP 75.10 (1).

733 (b) Access is a condition of the acceptance and retention of a retail food establishment  
734 license to operate as specified under s. ATCP 75.06 (3) (c).

735 (c) If access to a retail food establishment is denied to an authorized representative of the  
736 department or its agent, the department or its agent may apply for an inspection warrant to allow  
737 access as provided in law under s. 66.0119, Stats.

738 **(2) REPORTING OF REFUSED ACCESS.** If the person in charge continues to refuse access after  
739 the department or its agent presents credentials and explains the conditions under sub. (1),  
740 explains the authority upon which access is requested, and makes a final request for access, the

741 department or its agent shall document details of the denial of access on an inspection report  
742 form.

743 **(3) FREQUENCY OF INSPECTION.** (a) The department or its agent shall inspect a retail food  
744 establishment at least once during the licensing period.

745 (b) The department may approve, upon request, an increase in the interval between  
746 inspections beyond 12 months if any of the following conditions exist:

747 1. The retail food establishment licensed by the department or its agent is fully operating  
748 under a department approved HACCP plan as specified under 1-106.14; ch. ATCP 75 Appendix.

749 2. A plan is submitted to the department detailing an inspection frequency based on the risk  
750 of food establishment operations using criteria under s. ATCP 75.08 (1) (a) and (b). The total  
751 number of inspections performed shall equal the number of licenses issued.

752 **Note:** The intent of this provision is to allow greater inspection frequency for high-risk retail food  
753 establishments by decreasing inspection frequency for low-risk retail food establishments.

754 **(4) INSPECTION DOCUMENTATION.** The department or its agent shall document all of the  
755 following on an inspection report form:

757 (a) Administrative information about the retail food establishment's legal identity, street and  
758 mailing addresses, type of establishment and operation, inspection date, and other information  
759 such as type of water supply and sewage disposal, status of the license, and personnel certificates  
760 that may be required at the retail food establishment.

761 (b) The conditions or other violations from this chapter and ch. ATCP 75 Appendix, that  
762 require corrective action by the license holder. An accompanying narrative shall contain all of  
763 the following:

764 1. A factual description of the violation observed, including location of the observed  
765 violation.

766 2. Citation and a brief description of the statute, administrative code, or local ordinance for  
767 which noncompliance was observed.

768 3. A statement indicating what corrective action the licensee has taken, or shall take, to  
769 regain compliance with the administrative rule, statute, or local ordinance.

770 4. Unless otherwise indicated on the inspection report, each violation shall be provided with a  
771 corrective action deadline. The corrective action deadline shall be based on the following  
772 criteria:

773 a. The nature of the potential hazard involved and the complexity of the corrective action  
774 needed. The department or its agent may agree to or specify a longer time frame, not to exceed  
775 72 hours after the inspection, for the license holder to correct violations of a priority item.

776 b. A maximum time of 10 calendar days may elapse after the inspection for the license holder  
777 to correct violations of a priority foundation item or HACCP Plan deviation as defined in ch.  
778 ATCP 75 Appendix.

779 c. Core items, as defined in ch. ATCP 75 Appendix, shall be corrected by a deadline agreed  
780 to or specified by the department or its agent but no later than 90 calendar days after the  
781 inspection. The department or its agent may approve a written compliance schedule that extends  
782 beyond 90 calendar days if a written schedule of compliance is submitted by the license holder  
783 and no health hazard exists or will result from allowing an extended schedule for compliance.

784 **(5) ISSUING A REPORT AND OBTAINING ACKNOWLEDGMENT OF RECEIPT.** At the conclusion of  
785 the inspection, an authorized representative of the department shall sign the completed inspection  
786 report. The department or its agent shall then perform an exit interview and obtain a signature on  
787 the inspection report from the licensee's designated person in charge. A copy of the inspection

788 report shall be left with the person in charge at the completion of the inspection or emailed or  
789 otherwise presented within 2 business days after completion of the inspection.

790 (6) REFUSAL TO SIGN INSPECTION REPORT. If the licensee's designated person in charge  
791 refuses to sign the inspection report, the department or its agent shall do all of the following:

792 (a) Inform the person who declines to sign the inspection report that a written  
793 acknowledgment of receipt is not an agreement with findings.

794 (b) Inform the person that refusal to sign the inspection report will not affect the license  
795 holder's obligation to correct the violations noted in the inspection report by the deadlines  
796 specified.

797 (c) Document the refusal to sign in the inspection report.

798 (7) POSTING OF INSPECTION REPORTS. (a) Inspection reports shall be made available to the  
799 public through a web-based portal.

800 (b) The department or its agent may not apply grades or scores to retail food establishments  
801 based on inspection reports or other criteria.

## 802 **Subchapter V – Vending Machines**

803 **ATCP 75.30 Applicability.** (1) In addition to the specific requirements of ch. ATCP 75,  
804 vending machines shall meet applicable requirements in chapters 1 to 7 in ch. ATCP 75  
805 Appendix.

806 (2) The provisions of this chapter apply to any vending machine offered for public use,  
807 except a vending machine which dispenses only pastry items which have a pH level of 4.6 or  
808 below or a water activity (aw) value of 0.85 or less under standard conditions or are otherwise  
809 not time/temperature control for safety foods, or prepackaged Grade A pasteurized milk or milk  
810 products.

811 **ATCP 75.32 Approval of vending machines and related equipment. (1)** APPROVAL  
812 AUTHORITY. All vending machines and related equipment used at a vending machine location  
813 shall be approved by the department, on the basis of construction criteria developed by the  
814 National Sanitation Foundation (NSF) or the National Automatic Merchandising Association  
815 (NAMA).

816 **(2) INSPECTION FOR EVIDENCE OF APPROVAL.** Whenever an authorized representative or agent  
817 of the department inspects a vending machine and finds that the vending machine does not  
818 contain an identifiable license as required under s. ATCP 75.06, the authorized representative or  
819 agent of the department shall place the vending machine in a non-vend position by sealing the  
820 money or credit card insert slot, as applicable. Failure of the operator to maintain a non-vend  
821 condition until an authorized representative or agent of the department is satisfied that the  
822 vending machine is properly approved and identified shall be cause for an action under ss. 97.65,  
823 97.72, and 97.73, Stats.

824 **ATCP 75.34 Vending machine records. (1)** A vending machine location record shall be  
825 maintained on file at the operator's place of business within the State. That record shall include  
826 all of the following location information for each machine:

- 827 (a) Complete street address of the building.
- 828 (b) The floor level in the building.
- 829 (c) The room or area on the floor.

830 **(2)** The entry under each machine in the vending machine location record shall include  
831 the machine serial number and model number, the department's license number, and a  
832 designation of the machine by primary vending purpose. Primary vending purposes are:

- 833 (a) Heated.



- 834 (b) Refrigerated.
- 835 (c) Beverages.
- 836 (d) Food other than beverages.
- 837 (e) A combination of any 2 of pars. (a) to (d).

838 **ATCP 75.36 Maintenance and service connections. (1) REPLACEMENT PARTS.** All  
839 replacement parts and tubing shall be equal to or exceed original equipment specifications.  
840 Where clear tubing is used, it shall only be replaced with clear tubing. No part built in as a  
841 function of the vending machine may be removed or bypassed.

842 **(2) SERVICE CONNECTIONS. (a) Utility openings.** All service connections through an exterior  
843 wall of the machine, including water, gas, electrical and refrigeration connections, shall be  
844 grommited or closed to prevent the entry of insects and rodents.

845 **(b) Miscellaneous openings.** Miscellaneous openings into the cabinet and through the cabinet  
846 wall other than coin entrance, money or credit card slots, coin returns, and crown pullers, but  
847 including openings for optional service connections or alternate installations, shall be provided  
848 with effective closures by the manufacturer. The closures shall be provided for these not-in-use  
849 openings, and shall be easily identifiable, properly marked or adequately described in the  
850 instruction manual for their intended use.

851 **(c) Disconnection safeguards.** All service connections to utilities shall be of a type that will  
852 discourage their unauthorized or unintentional disconnection.

853 **ATCP 75.38 Sanitization. (1) CLEANING AND SANITIZING FACILITIES.** Approved facilities  
854 for cleaning and sanitizing equipment shall be available for each vending machine location or at  
855 a central location. If at a central location, product contact surfaces shall be protected from  
856 contamination during storage, transportation, and installation. Facilities for cleaning and

857 sanitizing shall include either a permanently fixed three-compartment sink large enough to  
858 accommodate the immersion of the largest equipment and utensil or portable washing facilities  
859 such as a service wagon, metal or plastic pails, or another mobile device which can be moved  
860 from one location to another.

861 (2) **CLEANED IN PLACE.** In machines designed so that food-contact surfaces are not readily  
862 removable, all surfaces intended for in-place cleaning shall be designed and fabricated so that all  
863 of the following conditions are met:

864 (a) Cleaning and sanitizing solutions can be circulated throughout a fixed system using an  
865 effective cleaning and sanitizing regimen.

866 (b) Cleaning and sanitizing solutions will contact all food-contact surfaces.

867 (c) The system is self-draining or capable of being completely evacuated.

868 (d) The procedures used result in thorough cleaning and sanitizing of the equipment.

869 **ATCP 75.40 Waste disposal. (1) REMOVAL.** All trash and other food product waste material  
870 shall be removed from the vending machine location as frequently as may be necessary to  
871 prevent attracting vermin, or creating a nuisance and unsightliness, and shall be disposed of in a  
872 manner that will not attract insects or rodents.

873 (2) **CONTAINERS.** Self-closing, leak-proof and easily cleanable refuse containers shall be  
874 provided in the vicinity of each machine or machines to receive cartons, wrappers, and other  
875 items of refuse.

876 (3) **WASTE COLLECTION.** (a) Containers shall be provided within all machines dispensing  
877 liquid products in bulk for the collection of drip, spillage, overflow, and other internal wastes.

878 (b) An automatic shutoff device shall be provided which will place the vending machine out  
879 of operation before a container overflows. The cutoff mechanism shall be set at a point to permit  
880 removal of the waste container from the machine without spillage.

881 (c) Containers and surfaces on which wastes may accumulate shall be readily removable for  
882 cleaning, easily cleanable, and corrosion resistant.

883 **ATCP 75.42 Delivery of foods.** Foods, including beverages and ingredients, in transit to  
884 vending machine locations shall be protected from contamination with dirt, dust, insects, rodents,  
885 and other foreign material. Similar protection shall be provided for single-service containers, as  
886 defined in 1-201.10; ch. ATCP 75 appendix, and for the product contact surfaces of equipment,  
887 containers, and devices in transit to machine locations.

#### 888 **Subchapter VI — Micro Markets**

889 **ATCP 75.44 Applicability of rules.** This chapter and chapters 1 to 7 in ch. ATCP 75  
890 Appendix, except for Part 2-1, apply to a micro market, as defined in s. ATCP 75.04 (22).

891 **ATCP 75.46 Location.** A micro market shall be located in the interior of a building that is  
892 not accessible to the general public. Access to the micro market shall be limited to a defined  
893 population of employees, guests, or occupants of the building where the establishment is located.

894 **ATCP 75.48 License holder responsibilities. (1) REQUIREMENTS.** The license holder shall  
895 assure that all of the following conditions are met:

896 (a) Food is from sources that comply with law.

897 (b) Packaged food is provided in tamper-evident packaging.

898 (c) Food is protected from potential sources of cross contamination.

899 (d) Food is maintained at safe temperatures during storage, transport and display.

901 (2) MICRO MARKET OVERSIGHT. Each micro market shall have a sign readily visible at the  
902 automated payment station stating all of the following:

903 (a) The name and mailing address of the business entity responsible for the establishment  
904 and to whom complaints and comments should be addressed.

905 (b) The telephone, email, or web information for the responsible business entity, when  
906 applicable.

907 (3) DESIGNATION OF RESPONSIBILITIES. The license holder bears all responsibilities for the  
908 operation of the micro market. Where the license holder is not the owner or operator of the  
909 building in which the retail food establishment is located, a written agreement that outlines the  
910 responsibilities for cleaning and maintenance of all surfaces and equipment, provision of  
911 supportive facilities and services such as janitorial and restroom facilities, pest control and  
912 removal of solid waste may be approved by the department or its agent. This agreement should  
913 also outline what actions must be taken by both parties to maintain the establishment in  
914 compliance with all requirements.

915 **ATCP 75.50 Nature and source of food and beverages offered for sale.** All of the  
916 following requirements apply to a micro market:

917 (1) Only commercially packaged foods properly labeled for individual retail sale shall be  
918 offered.

919 (2) Food preparation by consumers is limited to heating or reheating food in a microwave  
920 oven.

921 (3) Dispensing of bulk food is prohibited.

922 **ATCP 75.52 Equipment. (1) REFRIGERATED DISPLAY EQUIPMENT FEATURES.** A micro market  
923 that offers refrigerated or frozen foods shall be equipped with refrigeration or freezer units that  
924 have all of the following features:

925 (a) Self-closing doors that allow food to be viewed without opening the door to the  
926 refrigerated cooler or freezer.

927 (b) An automatic self-locking mechanism that prevents the consumer from accessing the  
928 unit upon failure of the refrigeration unit to maintain the appropriate temperature.

929 **(2) REFRIGERATED DISPLAY EQUIPMENT MAINTENANCE.** Automatic self-locking mechanisms  
930 that have been activated shall require an onsite visit by the operator or the operator's designee to  
931 evaluate and restore access to the refrigeration equipment.

932 **(3) FOOD SERVICE EQUIPMENT LIMITATIONS.** Beverages shall be dispensed in amounts  
933 intended for a single serving size. Beverage dispensers connected to the building water supply  
934 shall be equipped with backflow prevention.

935 **ATCP 75.54 Security.** A micro market shall provide and maintain continuous video  
936 surveillance of areas where consumers view, select, handle, and purchase products. The  
937 surveillance shall provide sufficient resolution to identify situations that may compromise food  
938 safety or food defense. Video surveillance recordings shall meet all of the following  
939 requirements:

940 (1) Video surveillance recordings shall be retained by the establishment for at least 14 days  
941 after the date of the surveillance.

942 (2) Video surveillance recordings shall be retained and made available for inspection  
943 upon request by the department or its agent within 24 hours of a request.

944 **ATCP 75.56 Routine maintenance at a micro market.** The license holder shall maintain the  
945 micro market, food, equipment and utensils in a clean, sanitary and unadulterated condition. This  
946 includes the following activities:

947 (1) Checking food supplies and equipment for signs of product damage or tampering,  
948 and discarding damaged food or food that has been tampered with.

949 (2) Verifying refrigeration equipment is operating properly including the  
950 temperature display and self-locking mechanism.

951 (3) Cleaning food service equipment and food display areas.

952 (4) Stocking food and disposable single-use and single-service supplies.

953 (5) Checking inventory for recalled foods.

954 (6) Any other reasonable actions to maintain a clean, sanitary and unadulterated condition.

**Applicability  
and Terms  
Defined**

**1-201.10 Statement of Application and Listing of Terms.**

(A) The following definitions shall apply in the interpretation and application of this Code.

(B) Terms Defined. As used in this Code, each of the terms listed in ¶ 1-201.10 (B) shall have the meaning stated below.

**Accredited Program.**

(1) **“Accredited program”** means a FOOD protection manager certification program that has been evaluated and listed by an accrediting agency as conforming to national standards for organizations that certify individuals.

(2) **“Accredited program”** refers to the certification process and is a designation based upon an independent evaluation of factors such as the sponsor’s mission; organizational structure; staff resources; revenue sources; policies; public information regarding program scope, eligibility requirements, re-certification, discipline and grievance procedures; and test development and administration.

(3) **“Accredited program”** does not refer to training functions or educational programs.

**Additive.**

(1) **“Food additive”** has the meaning stated in the Federal Food, Drug, and Cosmetic Act, § 201 (s) and 21 CFR 170.3 (e) (1).

(2) **“Color additive”** has the meaning stated in the Federal Food, Drug, and Cosmetic Act, § 201 (t) and 21 CFR 70.3 (f).

**“Adulterated”** has the meaning stated in s. 97.02, Stats.

**“Approved”** means acceptable to the REGULATORY AUTHORITY based on a determination of conformity with principles, practices, and generally recognized standards that protect public health.

**Asymptomatic.**

(1) **“Asymptomatic”** means without obvious symptoms; not showing or producing indications of a disease or other medical condition, such as an individual infected with a pathogen but not exhibiting or producing any signs or symptoms of vomiting, diarrhea, or jaundice.

(2) **“Asymptomatic”** includes not showing symptoms because symptoms have resolved or subsided, or because symptoms never manifested.

**“a<sub>w</sub>”** means water activity which is a measure of the free moisture in a FOOD, is the quotient of the water vapor pressure of the substance divided by the vapor pressure of pure water at the same temperature, and is indicated by the symbol a<sub>w</sub>.

**“Balut”** means an embryo inside a fertile EGG that has been incubated for a period sufficient for the embryo to reach a specific stage of development after which it is removed from incubation before hatching.

**“Beverage”** means a liquid for drinking, including water.

**“Bottled drinking water”** means water that is SEALED in bottles, packages, or other containers and offered for sale for human consumption, including bottled mineral water.

**“Casing”** means a tubular container for sausage products made of either natural or artificial (synthetic) material.

**“Certification number”** means a unique combination of letters and numbers assigned by a SHELLFISH CONTROL AUTHORITY to a MOLLUSCAN SHELLFISH DEALER according to the provisions of the National Shellfish Sanitation Program.

**“CFR”** means Code of Federal Regulations. Citations in this Code to the CFR refer sequentially to the Title, Part, and Section numbers, such as 40 CFR 180.194 refers to Title 40, Part 180, Section 194.

**CIP.**

(1) **“CIP”** means cleaned in place by the circulation or flowing by mechanical means through a piping system of a detergent solution, water rinse, and SANITIZING solution onto or over EQUIPMENT surfaces that require cleaning, such as the method used, in part, to clean and SANITIZE a frozen dessert machine.

(2) **“CIP”** does not include the cleaning of EQUIPMENT such as band saws, slicers, or mixers that are subjected to in-place manual cleaning without the use of a CIP system.

**“Commingle”** means:

(1) To combine SHELLSTOCK harvested on different days or from different growing areas as identified on the tag or label; or

(2) To combine SHUCKED SHELLFISH from containers with different container codes or different shucking dates.

**Comminuted.**

(1) **“Comminuted”** means reduced in size by methods including chopping, flaking, grinding, or mincing.

(2) **“Comminuted”** includes FISH or MEAT products that are reduced in size and restructured or reformulated such as gefilte FISH, gyros, ground beef, and sausage; and a mixture of 2 or more types of MEAT that have been reduced in size and combined, such as sausages made from 2 or more MEATS.

**“Conditional employee”** means a potential FOOD EMPLOYEE to whom a job offer is made, conditional on responses to subsequent medical questions or examinations designed to identify potential FOOD EMPLOYEES who may be suffering from a disease that can be transmitted through FOOD and done in compliance with Title 1 of the Americans with Disabilities Act of 1990.

**“Confirmed disease outbreak”** means a FOODBORNE DISEASE OUTBREAK in which laboratory analysis of appropriate specimens identifies a causative agent and epidemiological analysis implicates the FOOD as the source of the illness.

**“Consumer”** means a person who is a member of the public, takes possession of FOOD, is not functioning in the capacity of an OPERATOR of a FOOD ESTABLISHMENT or FOOD PROCESSING PLANT, and does not offer the FOOD for resale.

**Core Item.**

(1) **“Core item”** means a provision in this Code that is not designated as a PRIORITY ITEM or a PRIORITY FOUNDATION ITEM.

(2) **“Core item”** includes an item that usually relates to general sanitation, operational controls, sanitation standard operating procedures (SSOPs), facilities or structures, equipment design, or general maintenance.

**“Corrosion-resistant material”** means a material that maintains acceptable surface cleanability characteristics under prolonged influence of the FOOD to be contacted, the normal use of cleaning compounds and SANITIZING solutions, and other conditions of the use environment.

**“Counter-mounted equipment”** means EQUIPMENT that is not portable and is designed to be mounted off the floor on a table, counter, or shelf.

**“Critical control point”** means a point or procedure in a specific FOOD system where loss of control may result in an unacceptable health RISK.

**“Critical limit”** means the maximum or minimum value to which a physical, biological, or chemical parameter must be controlled at a CRITICAL CONTROL POINT to minimize the RISK that the identified FOOD safety HAZARD may occur.

**“Cut leafy greens”** means fresh leafy greens whose leaves have been cut, shredded, sliced, chopped, or torn. The term “leafy greens” includes iceberg lettuce, romaine lettuce, leaf lettuce, butter lettuce, baby leaf lettuce (i.e., immature lettuce or leafy greens), escarole, endive, spring mix, spinach,

cabbage, kale, arugula, and chard. The term “leafy greens” does not include herbs such as cilantro or parsley.

“**Dealer**” means a PERSON who is authorized by a SHELLFISH CONTROL AUTHORITY for the activities of SHELLSTOCK shipper, shucker–packer, repacker, reshipper, or depuration processor of MOLLUSCAN SHELLFISH according to the provisions of the National Shellfish Sanitation Program.

“**Department**” means the department of agriculture, trade and consumer protection as applicable.

“**Disclosure**” means a written statement that clearly identifies the animal–derived FOODS which are, or can be ordered, raw, undercooked, or without otherwise being PROCESSED to eliminate pathogens, or items that contain an ingredient that is raw, undercooked, or without otherwise being PROCESSED to eliminate pathogens.

**Drinking Water.**

(1) “**Drinking water**” means water that meets the requirements of ch. NR 809, Safe Drinking Water.

(2) “**Drinking water**” is traditionally known as “potable water.”

(3) “**Drinking water**” includes the term “water” *except where the term used connotes that the water is not potable, such as “boiler water,” “mop water,” “rainwater,” “wastewater,” and “nondrinking” water.*

“**Dry storage area**” means a room or area designated for the storage of PACKAGED or containerized bulk FOOD that is not TIME/TEMPERATURE CONTROLLED FOR SAFETY FOOD and dry goods such as SINGLE–SERVICE items

**Easily Cleanable.**

(1) “**Easily cleanable**” means a characteristic of a surface that:

(a) Allows effective removal of soil by normal cleaning methods;

(b) Is dependent on the material, design, construction, and installation of the surface; and

(c) Varies with the likelihood of the surface’s role in introducing pathogenic or toxigenic agents, allergens, or other contaminants into FOOD based on the surface’s APPROVED placement, purpose, and use.

(2) “**Easily cleanable**” includes a tiered application of the criteria that qualify the surface as EASILY CLEANABLE as specified in Subparagraph (1) of this

definition to different situations in which varying degrees of cleanability are required such as:

- (a) The appropriateness of stainless steel for a FOOD preparation surface as opposed to the lack of need for stainless steel to be used for floors or for tables used for CONSUMER dining; or
- (b) The need for a different degree of cleanability for a utilitarian attachment or accessory in the kitchen as opposed to a decorative attachment or accessory in the CONSUMER dining area.

**“Easily movable”** means:

- (1) Portable; mounted on casters, gliders, or rollers; or provided with a mechanical means to safely tilt a unit of EQUIPMENT for cleaning; and
- (2) Having no utility connection, a utility connection that disconnects quickly, or a flexible utility connection line of sufficient length to allow the EQUIPMENT to be moved for cleaning of the EQUIPMENT and adjacent area.

**Egg.**

- (1) **“Egg”** means the shell EGG of avian species such as chicken, duck, goose, guinea, quail, RATITE, or turkey.
- (2) **“Egg”** does not include:
  - (a) A BALUT;
  - (b) The EGG of reptile species such as alligator; or
  - (c) An EGG PRODUCT.

**Egg Product.**

- (1) **“Egg Product”** means all, or a portion of, the contents found inside EGGS separated from the shell and pasteurized in a FOOD PROCESSING PLANT, with or without added ingredients, intended for human consumption, such as dried, frozen or liquid EGGS.
- (2) **“Egg Product”** *does not include FOOD which contains EGGS only in a relatively small proportion such as cake mixes.*

**“Employee”** means the LICENSE HOLDER, PERSON IN CHARGE, FOOD EMPLOYEE, PERSON having supervisory or management duties, PERSON on the payroll, family member, volunteer, PERSON performing work under contractual agreement, or other PERSON working in the FOOD ESTABLISHMENT.

**“EPA”** means the U.S. Environmental Protection Agency.

**Equipment.**

(1) **“Equipment”** means an article that is used in the operation of a FOOD ESTABLISHMENT such as a freezer, grinder, hood, ice maker, MEAT block, mixer, oven, reach-in refrigerator, scale, sink, slicer, stove, table, TEMPERATURE MEASURING DEVICE for ambient air, VENDING MACHINE, or WAREWASHING machine.

(2) **“Equipment”** *does not include apparatuses used for handling or storing large quantities of PACKAGED FOODS that are received from a supplier in a cased or overwrapped lot, such as hand trucks, forklifts, dollies, pallets, racks, and skids.*

**“Exclude”** means to prevent a PERSON from working as an EMPLOYEE in a FOOD ESTABLISHMENT or entering a FOOD ESTABLISHMENT as an EMPLOYEE.

**“Existing”** in reference to a FOOD ESTABLISHMENT, means a FOOD ESTABLISHMENT operating under a LICENSE issued by the REGULATORY AUTHORITY before [the effective date of this code]

**“FDA”** means the U.S. Food and Drug Administration.

**Fish.**

(1) **“Fish”** means fresh or saltwater finfish, crustaceans and other forms of aquatic life (including alligator, frog, aquatic turtle, jellyfish, sea cucumber, and sea urchin and the roe of such animals) other than birds or mammals, and all mollusks, if such animal life is intended for human consumption.

(2) **“Fish”** includes an edible human FOOD product derived in whole or in part from FISH, including FISH that have been PROCESSED in any manner.

**“Food”** means a raw, cooked, or PROCESSED edible substance, ice, BEVERAGE, or ingredient used or intended for use or for sale in whole or in part for human consumption, or chewing gum.

**“Foodborne disease outbreak”** means the occurrence of two or more cases of a similar illness resulting from the ingestion of a common FOOD.

**“Food-contact surface”** means:

(1) A surface of EQUIPMENT or a UTENSIL with which FOOD normally comes into contact; or

(2) A surface of EQUIPMENT or a UTENSIL from which FOOD may drain, drip, or splash:



(a) Into a FOOD, or

(b) Onto a surface normally in contact with FOOD.

**“Food employee”** means an individual working with UNPACKAGED FOOD, FOOD EQUIPMENT OR UTENSILS, OR FOOD–CONTACT SURFACES.

**“Food Establishment”**

(1) **“Food establishment”** means an operation that:

(a) Stores, prepares, PACKAGES, serves, vends food directly to the CONSUMER, or otherwise provides FOOD for human consumption such as a restaurant as defined in s. 97.01 (14g), Stats.; satellite or catered feeding location; catering operation if the operation provides FOOD directly to a CONSUMER or to a conveyance used to transport people; market; vending location; institution; or FOOD bank; and

(b) Relinquishes possession of FOOD to a CONSUMER directly, or indirectly through a delivery service such as home delivery of grocery orders or restaurant takeout orders, or delivery service that is provided by common carriers.

(2) **“Food establishment”** includes:

An operation that is conducted in a mobile, stationary, temporary, or permanent facility or location; where consumption is on or off the PREMISES; and regardless of whether there is a charge for the FOOD.

(3) **“Food establishment”** *does not include:*

*(a) An establishment that offers only prePACKAGED FOODS that are not TIME/TEMPERATURE CONTROL FOR SAFETY FOODS;*

*(b) A produce stand that only offers whole, uncut fresh fruits and vegetables;*

*(c) A FOOD PROCESSING PLANT; including those that are located on the PREMISES of a FOOD ESTABLISHMENT;*

*(d) A kitchen in a private home if only FOOD that is not TIME/TEMPERATURE CONTROL FOR SAFETY FOOD, is prepared for sale or service at a function such as a religious or charitable organization’s bake sale if allowed by LAW and if the CONSUMER is informed by a clearly visible placard at the sales or service location that the FOOD is prepared in a kitchen that is not subject to regulation and inspection by the REGULATORY AUTHORITY;*

(e) An area where FOOD that is prepared as specified in Subparagraph (3)(d) of this definition is sold or offered for human consumption;

(f) A kitchen in a private home, such as a small family day-care provider; or a bed-and-breakfast operation that prepares and offers FOOD to guests if the home is owner occupied, the number of available guest bedrooms does not exceed 8, breakfast is the only meal offered, the number of guests served does not exceed 20; or

(g) A private home that receives catered or home-delivered FOOD.

**Food Processing Plant.**

(1) **“Food processing plant”** means a commercial operation that manufactures, PACKAGES, labels, or stores FOOD for human consumption, and provides FOOD for sale or distribution to other business entities such as FOOD PROCESSING PLANTS or FOOD ESTABLISHMENTS.

(2) **“Food processing plant”** does not include a FOOD ESTABLISHMENT.

**Game Animal.**

(1) **“Game animal”** means an animal, the products of which are FOOD, that is not classified as cattle, sheep, swine, goat, horse, mule, or other equine in 9 CFR 301.2 - Definitions, or as POULTRY, or as FISH.

(2) **“Game animal”** includes mammals such as reindeer, elk, deer, antelope, water buffalo, bison, rabbit, squirrel, opossum, raccoon, nutria, or muskrat; and nonaquatic reptiles such as land snakes.

(3) **“Game animal”** does not include RATITES.

**“General use pesticide”** means a pesticide that is not classified by EPA for restricted use as specified in 40 CFR 152.175 — Pesticides classified for restricted use.

**“Grade A standards”** means the requirements of the United States Public Health Service/FDA “Grade A Pasteurized Milk Ordinance” with which certain fluid and dry milk and milk products comply.

**Note:** A copy of the “Grade A Pasteurized Milk Ordinance” may be secured from the Department of Health and Human Services, Public Health Service, Food and Drug Administration, Division of Plant and Dairy Food Safety (HFS316), 5100 Paint Branch Parkway, College Park, MD 20740-3835 or you can contact the Wisconsin department of agriculture, trade and consumer protection.

**“HACCP plan”** means a written document that delineates the formal procedures for following the HAZARD Analysis and CRITICAL CONTROL POINT principles developed by The National Advisory Committee on Microbiological Criteria for Foods.

**Handwashing Sink.**

- (1) **“Handwashing sink”** means a lavatory, a basin or vessel for washing, a wash basin, or a PLUMBING FIXTURE especially placed for use in personal hygiene and designed for the washing of the hands.
- (2) **“Handwashing sink”** includes an automatic handwashing facility.

**“Hazard”** means a biological, chemical, or physical property that may cause an unacceptable CONSUMER health RISK.

**“Health practitioner”** means a physician licensed to practice medicine, or if allowed by LAW, a nurse practitioner, physician assistant, or similar medical professional.

**“Hermetically sealed container”** means a container that is designed and intended to be secure against the entry of microorganisms and, in the case of low acid canned FOODS, to maintain the commercial sterility of its contents after PROCESSING.

**“Highly susceptible population”** means PERSONS who are more likely than other people in the general population to experience foodborne disease because they are:

- (1) Immunocompromised; preschool age children, or older adults; and
- (2) Obtaining FOOD at a facility that provides services such as custodial care, health care, or assisted living, such as a child or adult day care center, kidney dialysis center, hospital or nursing home, or nutritional or socialization services such as a senior center.

**“Imminent health hazard”** means a significant threat or danger to health that is considered to exist when there is evidence sufficient to show that a product, practice, circumstance, or event creates a situation that requires immediate correction or cessation of operation to prevent injury based on:

- (1) The number of potential injuries; and
- (2) The nature, severity, and duration of the anticipated injury.

**“Injected”** means manipulating MEAT to which a solution has been introduced into its interior by processes that are referred to as “injecting,” “pump marinating,” or “stitch pumping.”

**Juice.**

(1) **“Juice”** means the aqueous liquid expressed or extracted from one or more fruits or vegetables, purées of the edible portions of one or more fruits or vegetables, or any concentrates of such liquid or purée.

(2) **“Juice”** *does not include, for purposes of HACCP, liquids, purées, or concentrates that are not used as BEVERAGES or ingredients of BEVERAGES.*

**“Kitchenware”** means FOOD preparation and storage UTENSILS.

**“Law”** means applicable local, state, and federal statutes, regulations, and ordinances.

**“License”** means the document issued by the REGULATORY AUTHORITY that authorizes a PERSON to operate a FOOD ESTABLISHMENT.

**“License holder”** means the entity that:

(1) Is legally responsible for the operation of the FOOD ESTABLISHMENT such as the owner, the owner’s agent, or other PERSON; and

(2) Possesses a valid LICENSE, as applicable, to operate a FOOD ESTABLISHMENT.

**“Linens”** means fabric items such as cloth hampers, cloth napkins, table cloths, wiping cloths, and work garments including cloth gloves.

**Major Food Allergen.**

(1) **“Major food allergen”** means:

(a) Milk, EGG, FISH (such as bass, flounder, cod, and including crustacean shellfish such as crab, lobster, or shrimp), tree nuts (such as almonds, pecans, or walnuts), wheat, peanuts, and soybeans; or

(b) A FOOD ingredient that contains protein derived from a FOOD, as specified in Subparagraph (1) (a) of this definition.

(2) **“Major food allergen”** *does not include:*

(a) *Any highly refined oil derived from a FOOD specified in Subparagraph (1) (a) of this definition and any ingredient derived from such highly refined oil; or*

(b) *Any ingredient that is exempt under the petition or notification process specified in the Food Allergen Labeling and Consumer Protection Act of 2004 (Public Law 108–282).*

**“Meat”** means the flesh of animals used as FOOD including the dressed flesh of cattle, swine, sheep, or goats and other edible animals, *except FISH, POULTRY, and wild GAME ANIMALS as specified under Subparagraphs 3–201.17 (A) (3) and (4).*

**Mechanically Tenderized.**

(1) **“Mechanically tenderized”** means manipulating MEAT with deep penetration by processes which may be referred to as “blade tenderizing,” “jaccarding,” “pinning,” “needling,” or using blades, pins, needles, or any mechanical device.

(2) **“Mechanically tenderized”** does not include processes by which solutions are INJECTED into MEAT.

**“mg/L”** means milligrams per liter, which is the metric equivalent of parts per million (ppm).

**“Milk and milk products”** means grade A milk and grade A milk products.

**Mobile Food Establishment.**

(1) **“Mobile food establishment”** means a restaurant or retail FOOD ESTABLISHMENT where FOOD is served or sold from a movable vehicle, intrastate railway car, push cart, trailer, or boat which periodically or continuously changes location and requires a SERVICE BASE to accommodate the unit for servicing, cleaning, inspection and maintenance or except as specified in ¶ 9–103.11 (D).

(2) **“Mobile food establishment”** *does not include a vehicle which is used solely to transport or deliver FOOD or a common carrier regulated by the state or federal government, or a movable concession stand designed to operate as a TEMPORARY FOOD ESTABLISHMENT or a traveling retail FOOD ESTABLISHMENT.*

**“Molluscan shellfish”** means any edible species of fresh or frozen oysters, clams, mussels, and scallops or edible portions thereof, *except when the scallop product consists only of the shucked adductor muscle.*

**“New”** in reference to a FOOD ESTABLISHMENT, means operating with a LICENSE from the DEPARTMENT or its agent for the first time on or after [the effective date of this code].

**Non-Continuous Cooking.**

(1) **“Non-continuous cooking”** means the cooking of FOOD in a FOOD ESTABLISHMENT using a process in which the initial heating of the FOOD is intentionally halted so that it may be cooled and held for complete cooking at a later time prior to sale or service.

(2) **“Non-continuous cooking”** does not include cooking procedures that only involve temporarily interrupting or slowing an otherwise continuous cooking process.

**“Operator”** means the LICENSE HOLDER or PERSON responsible to the LICENSE HOLDER for the operation of the FOOD ESTABLISHMENT.

**Packaged.**

(1) **“Packaged”** means bottled, canned, cartoned, securely bagged, or securely wrapped, whether PACKAGED in a FOOD ESTABLISHMENT or a FOOD PROCESSING PLANT as defined in s. 97.01 (12), Stats.

(2) **“Packaged”** does not include wrapped or placed in a carry-out container to protect the FOOD during service or delivery to the CONSUMER, by a FOOD EMPLOYEE, upon CONSUMER request.

**“Person”** means an association, corporation, individual, partnership, other legal entity, government, or governmental subdivision or agency.

**“Person in charge”** means the individual present at a FOOD ESTABLISHMENT who is responsible for the operation at the time of inspection.

**Personal Care Items.**

(1) **“Personal care items”** means items or substances that may be poisonous, toxic, or a source of contamination and are used to maintain or enhance a PERSON’S health, hygiene, or appearance.

(2) **“Personal care items”** include items such as medicines; first aid supplies; and other items such as cosmetics, and toiletries such as toothpaste and mouthwash.

**“pH”** means the symbol for the negative logarithm of the hydrogen ion concentration, which is a measure of the degree of acidity or alkalinity of a solution.

Values between 0 and 7 indicate acidity and values between 7 and 14 indicate alkalinity. The value for pure distilled water is 7, which is considered neutral.

**“Physical facilities”** means the structure and interior surfaces of a FOOD ESTABLISHMENT including accessories such as soap and towel dispensers and attachments such as light fixtures and heating or air conditioning system vents.

**“Plumbing fixture”** means a receptacle or device that:

(1) Is permanently or temporarily connected to the water distribution system of the PREMISES and demands a supply of water from the system;

(2) Discharges used water, waste materials, or SEWAGE directly or indirectly to the drainage system of the PREMISES.

**“Plumbing system”** means the water supply and distribution pipes; PLUMBING FIXTURES and traps; soil, waste, and vent pipes; sanitary and storm sewers and building drains, including their respective connections, devices, and appurtenances within the PREMISES; and water-treating EQUIPMENT.

**“Poisonous or toxic materials”** means substances that are not intended for ingestion and are included in 4 categories:

(1) Cleaners and SANITIZERS, which include cleaning and SANITIZING agents and agents such as caustics, acids, drying agents, polishes, and other chemicals;

(2) Pesticides, *except cleaners and SANITIZERS*, which include substances such as insecticides and rodenticides;

(3) Substances necessary for the operation and maintenance of the establishment such as nonfood grade lubricants and PERSONAL CARE ITEMS that may be deleterious to health; and

(4) Substances that are not necessary for the operation and maintenance of the establishment and are on the PREMISES for retail sale, such as petroleum products and paints.

**“Poultry”** means:

(1) Any domesticated bird (chickens, turkeys, ducks, geese, guineas, RATITES, or squabs), whether live or dead, as defined in 9 CFR 381.1 — Poultry Products Inspection Regulations Definitions, Poultry; and

(2) Any migratory waterfowl or game bird, pheasant, partridge, quail, grouse, or pigeon, whether live or dead, as defined in 9 CFR 362.1 — Voluntary Poultry Inspection Regulations, Definitions.

**“Premises”** means:

(1) The PHYSICAL FACILITY, its contents, and the contiguous land or property under the control of the LICENSE HOLDER; or

(2) The PHYSICAL FACILITY, its contents, and the land or property not described under Subparagraph (1) of this definition, if its facilities and contents are under the control of the LICENSE HOLDER and may impact FOOD ESTABLISHMENT personnel, facilities, or operations, and a FOOD ESTABLISHMENT is

only one component of a larger operation such as a health care facility, hotel, motel, school, recreational camp, or prison.

**“Primal cut”** means a basic major cut into which carcasses and sides of MEAT are separated, such as a beef round, pork loin, lamb flank, or veal breast.

**Priority Item.**

- (1) **“Priority item”** means a provision in this Code whose application contributes directly to the elimination, prevention, or reduction to an acceptable level, HAZARDS associated with foodborne illness or injury and there is no other provision that more directly controls the HAZARD.
- (2) **“Priority item”** includes items with a quantifiable measure to show control of HAZARDS such as cooking, reheating, cooling, handwashing; and
- (3) **“Priority item”** is an item that is denoted in this Code with a superscript P<sup>-P</sup>.

**Priority foundation Item.**

- (1) **“Priority foundation item”** means a provision in this Code whose application supports, facilitates, or enables one or more PRIORITY ITEMS.
- (2) **“Priority foundation item”** includes an item that requires the purposeful incorporation of specific actions, EQUIPMENT or procedures by industry management to attain control of RISK FACTORS that contribute to foodborne illness or injury such as personnel training, infrastructure or necessary EQUIPMENT, HACCP PLAN, documentation or record keeping, and labeling; and
- (3) **“Priority foundation item”** is an item that is denoted in this Code with a superscript Pf<sup>-Pf</sup>.

**“Processed” means:**

- (1) The preparation of FOOD for sale or service through the process of, extracting, fermentation, distilling, pickling, freezing, baking, assembling, drying, smoking, grinding, cutting, mixing, coating, stuffing, packing, bottling or packaging, or through any other treatment or preservation process.
- (2) PROCESSED does not mean the canning of FOOD or the smoking of FISH in a FOOD ESTABLISHMENTS.

**“Public water system”** means a system for the provision to the public of piped water for human consumption, if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year, as defined in s. 281.61 (1) (c), Stats. A PUBLIC



WATER SYSTEM is either a “community water system” as defined in s. 281.62 (1) (a), Stats., or a “non-community water system” as defined in s. 281.62 (1) (b), Stats. Such system includes:

- (1) Any collection, treatment, storage, and distribution facilities under control of the OPERATOR of such system and used primarily in connection with such system; and
- (2) Any collection or pretreatment storage facilities not under such control which are used primarily in connection with such system.

**“Pushcart”** means a MOBILE FOOD ESTABLISHMENT solely moved by the efforts of the operator and not designed to be towed.

**“Ratite”** means a flightless bird such as an emu, ostrich, or rhea.

**Ready-to-Eat Food.**

- (1) **“Ready-to-eat”** means FOOD that:
  - (a) Is in a form that is edible without additional preparation to achieve FOOD safety, as specified under one of the following: ¶ 3-401.11 (A) or (B), § 3-401.12, or § 3-402.11, or as specified in ¶ 3-401.11 (C); or
  - (b) Is a raw or partially cooked animal FOOD and the CONSUMER is advised as specified in Subparagraphs 3-401.11 (D) (1) and (3); or
  - (c) Is prepared in accordance with a VARIANCE that is granted as specified under Subparagraph 3-401.11 (D) (4); and
  - (d) May receive additional preparation for palatability or aesthetic, epicurean, gastronomic, or culinary purposes.
- (2) **“Ready-to-eat food”** includes:
  - (a) Raw animal FOOD that is cooked as specified under § 3-401.11 or 3-401.12, or frozen as specified under § 3-402.11;
  - (b) Raw fruits and vegetables that are washed as specified under § 3-302.15;
  - (c) Fruits and vegetables that are cooked for hot holding, as specified under § 3-401.13;
  - (d) All TIME/TEMPERATURE CONTROL FOR SAFETY FOOD that is cooked to the temperature and time required for the specified FOOD under Subpart 3-401 and cooled as specified in § 3-501.14;

(e) Plant FOOD for which further washing, cooking, or other processing is not required for FOOD safety, and from which rinds, peels, husks, or shells, if naturally present are removed;

(f) Substances derived from plants such as spices, seasonings, and sugar;

(g) A bakery item such as bread, cakes, pies, fillings, or icing for which further cooking is not required for FOOD safety;

(h) The following products that are produced in accordance with USDA guidelines and that have received a lethality treatment for pathogens: dry, fermented sausages, such as dry salami or pepperoni; salt-cured MEAT and POULTRY products, such as prosciutto ham, country cured ham, and Parma ham; and dried MEAT and POULTRY products, such as jerky or beef sticks; and

(i) FOODS manufactured as specified in 21 CFR Part 113 — Thermally Processed Low-Acid Foods Packaged in Hermetically Sealed Containers.

**Reduced Oxygen Packaging.**

(1) **“Reduced oxygen packaging”** means:

(a) The reduction of the amount of oxygen in a PACKAGE by removing oxygen; displacing oxygen and replacing it with another gas or combination of gases; or otherwise controlling the oxygen content to a level below that normally found in the atmosphere (approximately 21% at sea level); and

(b) A process as specified in Subparagraph (1) (a) of this definition that involves a FOOD for which the HAZARDS **Clostridium botulinum** or **Listeria monocytogenes** require control in the final PACKAGED form.

(2) **“Reduced oxygen packaging”** includes:

(a) Vacuum PACKAGING, in which air is removed from a PACKAGE of FOOD and the PACKAGE is HERMETICALLY SEALED so that a vacuum remains inside the PACKAGE;

(b) Modified atmosphere PACKAGING, in which the atmosphere of a PACKAGE of FOOD is modified so that its composition is different from air but the atmosphere may change over time due to the permeability of the PACKAGING material or the respiration of the FOOD. Modified atmosphere PACKAGING includes: reduction in the proportion of oxygen, total replacement of oxygen, or an increase in the proportion of other gases such as carbon dioxide or nitrogen; and

(c) Controlled atmosphere PACKAGING, in which the atmosphere of a PACKAGE of FOOD is modified so that until the PACKAGE is opened, its composition is different from air, and continuous control of that atmosphere is maintained, such as by using oxygen scavengers or a combination of total replacement of oxygen, nonrespiring FOOD, and impermeable PACKAGING material.

(d) Cook chill PACKAGING, in which cooked FOOD is hot filled into impermeable bags which have the air expelled and are then sealed or crimped closed. The bagged FOOD is rapidly chilled and refrigerated at temperatures that inhibit the growth of psychotropic pathogens; or

(e) Sous vide PACKAGING, in which raw or partially cooked FOOD is vacuum packaged in an impermeable bag, cooked in the bag, rapidly chilled, and refrigerated at temperatures that inhibit the growth of psychotropic pathogens.

**“Refuse”** means solid waste not carried by water through the SEWAGE system.

**“Regulatory authority”** means the local, state, or federal enforcement body or authorized representative having jurisdiction over the FOOD ESTABLISHMENT.

**“Reminder”** means a written statement concerning the health RISK of consuming animal FOODS raw, undercooked, or without otherwise being processed to eliminate pathogens.

**“Re-service”** means the transfer of FOOD that is unused and returned by a CONSUMER after being served or sold and in the possession of the CONSUMER, to another PERSON.

**“Restrict”** means to limit the activities of a FOOD EMPLOYEE so that there is no RISK of transmitting a disease that is transmissible through FOOD and the FOOD EMPLOYEE does not work with exposed FOOD, clean EQUIPMENT, UTENSILS, LINENS; OR unwrapped SINGLE-SERVICE or SINGLE-USE ARTICLES.

**“Restricted egg”** means any check, dirty EGG, incubator reject, inedible, leaker, or loss as defined in 9 CFR 590.

**“Restricted use pesticide”** means a pesticide product that contains the active ingredients specified in 40 CFR 152.175 Pesticides classified for restricted use, or ATCP 29, and that is limited to use by or under the direct supervision of a certified applicator.

**“Risk”** means the likelihood that an adverse health effect will occur within a population as a result of a HAZARD in a FOOD.

**“Risk control plan (RCP)”** means a written plan developed by the FOOD ESTABLISHMENT OPERATOR in conjunction with the REGULATORY AUTHORITY that

describes a system for controlling specific out-of-control foodborne illness RISK FACTORS.

**“Risk Factor”** means the improper practices or procedures that have been identified by the Centers for Disease Control and Prevention (CDC) through epidemiological data, as the most prevalent contributing factors of foodborne illness or injury. RISK FACTORS include:

- (1) Poor personal hygiene;
- (2) FOOD from unsafe source;
- (3) Inadequate cooking;
- (4) Improper holding temperatures; and
- (5) Contaminated EQUIPMENT.

**“Safe material”** means:

- (1) An article manufactured from or composed of materials that may not reasonably be expected to result, directly or indirectly, in their becoming a component or otherwise affecting the characteristics of any FOOD;
- (2) An ADDITIVE that is used as specified in § 409 of the Federal Food, Drug, and Cosmetic Act; or
- (3) Other materials that are not ADDITIVES and that are used in conformity with applicable regulations of the Food and Drug Administration.

**“Sanitization”** means the application of cumulative heat or chemicals on cleaned FOOD-CONTACT SURFACES that, when evaluated for efficacy, is sufficient to yield a reduction of 5 logs, which is equal to a 99.999% reduction, of representative disease microorganisms of public health importance.

**“Sealed”** means free of cracks or other openings that allow the entry or passage of moisture.

**“Service animal”** means an animal such as a guide dog, signal dog, or other animal individually trained to provide assistance to an individual with a disability.

**“Service Base”** means an operating base location to which a MOBILE FOOD ESTABLISHMENT or transportation vehicle returns regularly for such things as vehicle and EQUIPMENT cleaning, discharging liquid or solid wastes, refilling water tanks and ice bins, and boarding FOOD.

**“Sewage”** means liquid waste containing animal or vegetable matter in suspension or solution and may include liquids containing chemicals in solution.

**“Shellfish control authority”** means a state, federal, foreign, tribal, or other government entity legally responsible for administering a program that includes certification of MOLLUSCAN SHELLFISH harvesters and DEALERS for interstate commerce.

**“Shellstock”** means raw, in-shell MOLLUSCAN SHELLFISH.

**“Shiga toxin-producing Escherichia coli” (STEC)** means any E. coli capable of producing Shiga toxins (also called verocytotoxins). STEC infections can be asymptomatic or may result in a spectrum of illness ranging from mild, non-bloody diarrhea, to hemorrhagic colitis (i.e., bloody diarrhea), to hemolytic uremic syndrome (HUS – a type of kidney failure). Examples of serotypes of STEC include: E. coli O157:H7; E. coli O157:NM; E. coli O26:H11; E. coli O145:NM; E. coli O103:H2; and E. coli O111:NM. STEC are sometimes referred to as VTEC (verocytotoxigenic E. coli) or as EHEC (Enterohemorrhagic E. coli). EHEC are a subset of STEC which can cause hemorrhagic colitis or HUS.

**“Shucked shellfish”** means MOLLUSCAN SHELLFISH that have one or both shells removed.

**“Single-service articles”** means TABLEWARE, carry-out UTENSILS, and other items such as bags, containers, placemats, stirrers, straws, toothpicks, and wrappers that are designed and constructed for one time, one PERSON use after which they are intended for discard.

#### **Single-Use Articles.**

(1) **“Single-use articles”** means UTENSILS and bulk FOOD containers designed and constructed to be used once and discarded.

(2) **“Single-use articles”** includes items such as wax paper, butcher paper, plastic wrap, formed aluminum FOOD containers, jars, plastic tubs or buckets, bread wrappers, pickle barrels, ketchup bottles, and number 10 cans which do not meet the materials, durability, strength, and cleanability specifications under §§ 4-101.11, 4-201.11, and 4-202.11 for multiuse UTENSILS.

**“Slacking”** means the process of moderating the temperature of a FOOD such as allowing a FOOD to gradually increase from a temperature of -23°C (-10°F) to -4°C (25°F) in preparation for deep-fat frying or to facilitate even heat penetration during the cooking of previously block-frozen FOOD such as shrimp.

**“Smooth”** means:

(1) A FOOD-CONTACT SURFACE having a surface free of pits and inclusions with a cleanability equal to or exceeding that of (100 grit) number 3 stainless steel;

(2) A nonFOOD-CONTACT SURFACE of EQUIPMENT having a surface equal to that of commercial grade hot-rolled steel free of visible scale; and

(3) A floor, wall, or ceiling having an even or level surface with no roughness or projections that render it difficult to clean.

**"Tableware"** means eating, drinking, and serving UTENSILS for table use such as flatware including forks, knives, and spoons; hollowware including bowls, cups, serving dishes, and tumblers; and plates.

**"Temperature measuring device"** means a thermometer, thermocouple, thermistor, or other device that indicates the temperature of FOOD, air, or water.

**"Temporary food establishment"** means a FOOD ESTABLISHMENT that operates at a fixed location for a period of no more than 14 consecutive days in conjunction with a single event or celebration such as a fair, carnival, circus, public exhibition, anniversary sale, or occasional sales promotion.

**Time/Temperature Control for Safety Food** (formerly "potentially hazardous food" (PHF).

(1) **"Time/temperature control for safety food"** means a FOOD that requires time/temperature control for safety (TCS) to limit pathogenic microorganism growth or toxin formation.

(2) **"Time/temperature control for safety food"** includes:

(a) An animal FOOD that is raw or heat-treated; a plant FOOD that is heat-treated or consists of raw seed sprouts, cut melons, CUT LEAFY GREENS, cut tomatoes or mixtures of cut tomatoes that are not modified in a way so that they are unable to support pathogenic microorganism growth or toxin formation, or garlic-in-oil mixtures that are not modified in a way so that they are unable to support pathogenic microorganism growth or toxin formation; and

(b) Except as specified in Subparagraph (3) (d) of this definition, a FOOD that because of the interaction of its  $A_w$  and pH values is designated as Product Assessment Required (PA) in Table A or B of this definition:

(3) **"Time/temperature control for safety food" does not include:**

(a) *An air-cooled hard-boiled EGG with shell intact, or an EGG with shell intact that is not hard-boiled, but has been pasteurized to destroy all viable Salmonellae;*

(b) *A FOOD in an unopened HERMETICALLY SEALED CONTAINER that is commercially processed to achieve and maintain commercial sterility under conditions of non-refrigerated storage and distribution;*

(c) *A FOOD that because of its pH or A<sub>w</sub> value, or interaction of A<sub>w</sub> and pH values, is designated as a non-TCS FOOD in Table A or B of this definition;*

(d) *A FOOD that is designated as Product Assessment Required (PA) in Table A or B of this definition and has undergone a Product Assessment showing that the growth or toxin formation of pathogenic microorganisms that are reasonably likely to occur in that FOOD is precluded due to:*

(i) *Intrinsic factors including added or natural characteristics of the FOOD such as preservatives, antimicrobials, humectants, acidulants, or nutrients,*

(ii) *Extrinsic factors including environmental or operational factors that affect the FOOD such as PACKAGING, modified*

atmosphere such as REDUCED OXYGEN PACKAGING, shelf life and use, or temperature range of storage and use, or

(iii) A combination of intrinsic and extrinsic factors; or

(e) A FOOD that does not support the growth or toxin formation of pathogenic microorganisms in accordance with one of the Subparagraphs (3)(a) -(3)(d) of this definition even though the FOOD may contain a pathogenic microorganism or chemical or physical contaminant at a level sufficient to cause illness or injury.

**"USDA"** means the U.S. Department of Agriculture.

**"Utensil"** means a FOOD-contact implement or container used in the storage, preparation, transportation, dispensing, sale, or service of FOOD, such as KITCHENWARE or TABLEWARE that is multiuse, SINGLE-SERVICE, or SINGLE-USE; gloves used in contact with FOOD; temperature sensing probes of FOOD TEMPERATURE MEASURING DEVICES; and probe-type price or identification tags used in contact with FOOD.

**"Variance"** means a written document issued by the DEPARTMENT that authorizes a modification or waiver of one or more requirements of this Code if, in the opinion of the DEPARTMENT, a health HAZARD or nuisance will not result from the modification or waiver.

**"Vending machine"** has the meaning given in s. 97.01 (15p), Stats.

Note: Section 97.01 (15p), Stats., defines VENDING MACHINES as any self-service device offered for public use which, upon insertion of a coin or token, or by other means, dispenses unit servings of FOOD or BEVERAGE either in bulk or in PACKAGE, without the necessity of replenishing the device between each vending operation. "VENDING MACHINE" does not include a device which dispenses only bottled, prePACKAGED or canned soft drinks, a one cent vending device, a VENDING MACHINE dispensing only candy, gum, nuts, nut meats, cookies or crackers, or a VENDING MACHINE dispensing only prePACKAGED grade A pasteurized milk or milk products.

**"Vending machine commissary"** means any building, room or place in the state at which FOODS, containers, transport equipment, or supplies for VENDING MACHINES are kept, handled, prepared, or stored by a VENDING MACHINE OPERATOR, except a place at which the OPERATOR is licensed to manufacture, distribute, or sell FOOD products under ch. 97, Stats.

**"Vending machine location"** means the room, enclosure, space, or area where one or more VENDING MACHINES are installed and operated and includes the storage areas and areas on the PREMISES that are used to service and maintain the VENDING MACHINES.

**"Vending machine operator"** has the meaning prescribed in s. 97.01 (15y), Stats., namely, the person maintaining a place of business in the state and responsible for the operation of one or more vending machines.



**“Warewashing”** means the cleaning and SANITIZING of UTENSILS and FOOD–CONTACT SURFACES of EQUIPMENT.

**“Whole–muscle, intact beef”** means whole muscle beef that is not INJECTED, MECHANICALLY TENDERIZED, reconstructed, or scored and marinated, from which beef steaks may be cut.

(b) 21 CFR 178 -Indirect FOOD ADDITIVES: Adjuvants, Production Aids, and Sanitizers as regulated for use as a FOOD ADDITIVE with conditions of safe use, <sup>Pf</sup> or

(c) A determination of generally recognized as safe (GRAS). Partial listings of substances with FOOD uses that are GRAS may be found in 21 CFR 182 -Substances Generally Recognized as Safe, 21 CFR 184 -Direct FOOD Substances Affirmed as Generally Recognized as Safe, or 21 CFR 186 – Indirect FOOD Substances Affirmed as Generally Recognized as Safe for use in contact with FOOD, and in FDA's Inventory of GRAS Notices, <sup>Pf</sup> or

The procedures shall address the specific actions EMPLOYEES must take to minimize the spread of contamination and the exposure of EMPLOYEES, CONSUMERS, FOOD, and surfaces to vomitus or fecal matter. <sup>Pf</sup>

(G) EGGS that have not been specifically treated to destroy all viable *Salmonellae* shall be labeled to include safe handling instructions as specified in LAW, including 21 CFR 101.17 (h).

(H) EGGS shall be:

(1) From an EGG handler complying with the requirements of ATCP 88 and holding a FOOD PROCESSING PLANT license under s. 97.29, Stats.,

(2) From an EGG handler complying with the LAW of another state, or

(3) Sold directly to the consumer by an EGG producer exempted under s.97.28, Stats., and s. ATCP 88.02 and selling nest-run or washed, candled, graded, sized, or packaged EGGS from a flock of not more than 150 laying birds owned by the producer.

**3-201.12 Food in a Hermetically Sealed Container.**

FOOD in a HERMETICALLY SEALED CONTAINER, shall be obtained from a FOOD PROCESSING PLANT that is regulated by the FOOD regulatory agency that has jurisdiction over the plant. <sup>P</sup>

**3-201.13 Fluid Milk and Milk Products.**

Fluid milk and milk products shall be obtained from sources that comply with GRADE A STANDARDS as specified in LAW. <sup>P</sup>

**3-201.14 Fish.**

(A) FISH that are received for sale or service shall be:

- (1) Commercially and legally caught or harvested; <sup>P</sup> or
- (2) APPROVED for sale or service. <sup>P</sup>

(B) MOLLUSCAN SHELLFISH that are recreationally caught may not be received for sale or service. <sup>P</sup>

**3-201.15 Molluscan Shellfish.**

(A) MOLLUSCAN SHELLFISH shall be obtained from sources according to LAW and the requirements specified in the U.S. Department of Health and Human Services, Public Health Service, Food and Drug Administration, National Shellfish Sanitation Program Guide for the Control of Molluscan Shellfish. <sup>P</sup>

(A) Except as specified in ¶ (B) of this section, mushroom species picked in the wild shall not be offered for sale or service by a FOOD ESTABLISHMENT unless the FOOD ESTABLISHMENT has been APPROVED to do so. <sup>P</sup>

- (1) *Cultivated wild mushroom species that are grown, harvested, and PROCESSED in an operation that is regulated by the FOOD regulatory agency that has jurisdiction over the operation; or*

**3-201.17 Game Animals.**

If GAME ANIMALS are received for sale or service they shall be:

  - (a) Raised, slaughtered, and PROCESSED under a voluntary inspection program that is conducted by the agency that has animal health jurisdiction,<sup>P</sup> or
  - (b) Under a routine inspection program conducted by a regulatory agency other than the agency that has animal health jurisdiction,<sup>P</sup> and
  - (c) Raised, slaughtered, and PROCESSED according to:
    - (i) LAWS governing MEAT and POULTRY as determined by the agency that has animal health jurisdiction and the agency that conducts the inspection program,<sup>P</sup> and
    - (ii) Requirements which are developed by the agency that has animal health jurisdiction and the agency that conducts the inspection program with consideration of factors such as the need for antemortem and postmortem examination by an APPROVED veterinarian or veterinarian's designee;<sup>P</sup>
- (2) Under a voluntary inspection program administered by the USDA for game animals such as exotic animals (reindeer, elk, deer, antelope, water buffalo, or bison) that are "inspected and APPROVED" in accordance with 9 CFR 352 Exotic animals; voluntary inspection or rabbits that are "inspected and certified" in accordance with 9 CFR 354 voluntary inspection of rabbits and edible products thereof;<sup>P</sup>
- (3) As allowed by LAW, for wild GAME ANIMALS that are live-caught:
  - (a) Under a routine inspection program conducted by a regulatory agency such as the agency that has animal health jurisdiction,<sup>P</sup> and
  - (b) Slaughtered and PROCESSED according to:
    - (i) LAWS governing MEAT and POULTRY as determined by the agency that has animal health jurisdiction and the agency that conducts the inspection program,<sup>P</sup> and

FOOD may not contain UNAPPROVED FOOD ADDITIVES or ADDITIVES that exceed amounts specified in 21 CFR 170 to 180 relating to FOOD ADDITIVES, generally recognized as safe or prior sanctioned substances that exceed amounts specified in 21 CFR 181 to 186, substances that exceed amounts specified in 9 CFR Subpart C Section 424.21 (b) Use of Food Ingredients and Sources of Radiation, or pesticide residues that exceed provisions specified in 40 CFR 180 Tolerances and Exemptions for Pesticide Chemical Residues in Food. <sup>P</sup>

**3-202.13 Eggs.**

EGGS shall be received clean and sound and may not exceed the RESTRICTED EGG tolerances as specified in s. ATPC 88.26. <sup>P</sup>

**3-202.14 Eggs and Milk Products, Pasteurized.**

(A) EGG PRODUCTS shall be obtained pasteurized. <sup>P</sup>

(B) Fluid and dry milk and milk products shall:

(1) Be obtained pasteurized; <sup>P</sup> and

(2) Comply with GRADE A STANDARDS as specified in LAW. <sup>P</sup>

(C) The identity of the source of SHELLSTOCK that are sold or served shall be maintained by retaining SHELLSTOCK tags or labels for 90 calendar days from the date that is recorded on the tag or label, as specified under ¶ (B) of this section, by: <sup>Pf</sup>

(1) Using an APPROVED record keeping system that keeps the tags or labels in chronological order correlated to the date that is recorded on the tag or label, as specified under ¶ (B) of this section; <sup>Pf</sup> and

(2) If SHELLSTOCK are removed from their tagged or labeled container:

(a) Preserving source identification by using a record keeping system as specified under Subparagraph (C) (1) of this section, <sup>Pf</sup> and

**3-203.13 Grinding Log, Ground Beef**

(A) Grinding records shall be kept for any raw ground beef manufactured in a retail FOOD ESTABLISHMENT as specified under 9 CFR 320.1(b)(4), 320.2 and 320.3. This does not apply to non-intact products such as mechanically tenderized or needle injected raw beef.

(B) Retail FOOD ESTABLISHMENTS, including restaurants, that grind beef for sale as raw ground beef or another not READY-TO-EAT FOOD, shall maintain the following records:

1) The establishment number or license number of the facility that supplies the beef used to grind each lot of raw ground beef product;

2) All beef supplier lot numbers and production dates;

3) The names of the supplied beef, including beef components and any materials (rework or regrind) carried over from one production lot to the next;

(6) Protecting FOOD containers that are received PACKAGED together in a case or overwrap from cuts when the case or overwrap is opened;

(7) Storing damaged, spoiled, or recalled FOOD being held in the FOOD ESTABLISHMENT as specified under § 6-404.11; and

(8) Separating fruits and vegetables, before they are washed as specified under §3-302.15 from READY-TO-EAT FOOD.

(C) On a clean portion of the FOOD preparation table or cooking EQUIPMENT only if the in-use UTENSIL and the FOOD-CONTACT SURFACE of the FOOD preparation table or cooking EQUIPMENT are cleaned and SANITIZED at a frequency specified under §§ 4-602.11 and 4-702.11;

(D) In running water of sufficient velocity to flush particulates to the drain, if used with moist FOOD such as ice cream or mashed potatoes;

(E) In a clean, protected location if the UTENSILS, such as ice scoops, are used only with a FOOD that is not TIME/TEMPERATURE CONTROL FOR SAFETY FOOD; or

(F) In a container of water if the water is maintained at a temperature of at least 57°C (135°F) and the container is cleaned at a frequency specified under Subparagraph 4-602.11 (D)(7).

**3-304.13 Linens and Napkins, Use Limitation.**

LINENS, such as cloth napkins, may not be used in contact with FOOD *unless they are used to line a container for the service of FOODS and the LINENS and napkins are replaced each time the container is refilled for a new CONSUMER.*

**3-304.14 Wiping Cloths, Use Limitation.**

(A) Cloths in-use for wiping FOOD spills from TABLEWARE and carry-out containers that occur as FOOD is being served shall be:

- (1) Maintained dry; and
- (2) Used for no other purpose.

(B) Cloths in-use for wiping counters and other EQUIPMENT surfaces shall be:



(1) Held between uses in a chemical sanitizer solution at a concentration specified under § 4-501.114; and

(2) Laundered daily as specified under ¶ 4-802.11 (D).

(C) Cloths in-use for wiping surfaces in contact with raw animal FOODS shall be kept separate from cloths used for other purposes.

(D) Dry wiping cloths and the chemical sanitizing solutions specified in Subparagraph (B)(1) of this section in which wet wiping cloths are held between uses shall be free of FOOD debris and visible soil.

(E) Containers of chemical sanitizing solutions specified in Subparagraph (B)(1) of this section in which wet wiping cloths are held between uses shall be stored off the floor and used in a manner that prevents contamination of FOOD, EQUIPMENT, UTENSILS, LINENS, SINGLE-SERVICE, or SINGLE-USE ARTICLES.

(F) SINGLE-USE disposable sanitizer wipes shall be used in accordance with EPA-approved manufacturer's label use instructions.

**3-304.15 Gloves, Use Limitation.**

(A) If used, SINGLE-USE gloves shall be used for only one task such as working with READY-TO-EAT FOOD or with raw animal FOOD, used for no other purpose, and discarded when damaged or soiled, or when interruptions occur in the operation.

(B) Except as specified in ¶ (C) of this section, slash-resistant gloves that are used to protect the hands during operations requiring cutting shall be used in direct contact only with FOOD that is subsequently cooked as specified under Part 3-4 such as frozen FOOD or a PRIMAL CUT OF MEAT.

(C) *Slash-resistant gloves may be used with READY-TO-EAT FOOD that will not be subsequently cooked if the slash-resistant gloves have a SMOOTH, durable, and nonabsorbent outer surface; or if the slash-resistant gloves are covered with a SMOOTH, durable, nonabsorbent glove, or a single-use glove.*

(D) Cloth gloves may not be used in direct contact with FOOD *unless the FOOD is subsequently cooked as required under Part 3-4 such as frozen FOOD or a PRIMAL CUT of MEAT.*

**3-304.16 Using Clean Tableware for Second Portions and Refills.**

(A) Except for refilling a CONSUMER's drinking cup or container without contact between the pouring UTENSIL and the lip-contact area of the drinking cup or container, FOOD EMPLOYEES may not use TABLEWARE, including SINGLE-SERVICE ARTICLES, soiled by the CONSUMER, to provide second portions or refills.

(B) Except as specified in ¶ (C) of this section, self-service CONSUMERS may not be allowed to use soiled TABLEWARE, including SINGLE-SERVICE ARTICLES, to obtain additional FOOD from the display and serving EQUIPMENT.

(C) *Drinking cups and containers may be reused by self-service CONSUMERS if refilling is a contamination-free process as specified under §§ 4-204.13 (A), (B), and (D).*

**3-304.17 Refilling Returnables.**

(A) Except as specified in §§ (B) - (E) of this section, empty containers returned to a FOOD ESTABLISHMENT for cleaning and refilling with FOOD shall be cleaned and refilled in a regulated FOOD PROCESSING PLANT. <sup>P</sup>

(B) *A take-home FOOD container returned to a FOOD ESTABLISHMENT may be refilled at a FOOD ESTABLISHMENT with FOOD if the FOOD container is:*

(1) *Designed and constructed for reuse and in accordance with the requirements specified under Part 4-1 and 4-2;* <sup>P</sup>

(2) *One that was initially provided by the FOOD ESTABLISHMENT to the CONSUMER, either empty or filled with FOOD by the FOOD ESTABLISHMENT, for the purpose of being returned for reuse;*

(3) *Returned to the FOOD ESTABLISHMENT by the CONSUMER after use;*

(4) *Subject to the following steps before being refilled with FOOD:*

(a) *Cleaned as specified under Part 4-6 of this Code,*

(b) *Sanitized as specified under Part 4-7 of this Code;* <sup>P</sup>

(c) *Visually inspected by a FOOD EMPLOYEE to verify that the container, as returned, meets the requirements specified under Part 4-1 and 4-2;* <sup>P</sup>

(1) For the purposes of this paragraph only, children who are age 9 or less and receive FOOD in a school, day care setting, or similar facility that provides custodial care are included as HIGHLY SUSCEPTIBLE POPULATIONS;

(2) PrePACKAGED JUICE or a prePACKAGED BEVERAGE containing JUICE, that bears a warning label as specified in 21 CFR 101.17 (g) Food labeling, warning, notice, and safe handling statements, JUICES that have not been specifically PROCESSED to prevent, reduce, or eliminate the presence of pathogens, or a PACKAGED JUICE or BEVERAGE containing JUICE, that bears a warning label as specified under ¶ 3-404.11 (B) may not be served or offered for sale; <sup>P</sup> and

(3) UNPACKAGED JUICE that is prepared on the PREMISES for service or sale in a READY-TO-EAT form shall be processed under a HACCP PLAN required by the DEPARTMENT under § 1-106.12, and as specified in 21 CFR 120 - Hazard Analysis and Critical Control Point (HACCP) Systems, Subpart B Pathogen Reduction, 120.24 Process controls. <sup>P</sup>

(B) Pasteurized EGGS or EGG PRODUCTS shall be substituted for raw EGGS in the preparation of: <sup>P</sup>

(1) FOODS such as Caesar salad, hollandaise or Béarnaise sauce, mayonnaise, meringue, EGGnog, ice cream, and EGG-fortified BEVERAGES, <sup>P</sup> and

(2) Except as specified in ¶ (F) of this section, recipes in which more than one EGG is broken and the EGGS are combined. <sup>P</sup>

**4-1 MATERIALS FOR CONSTRUCTION AND REPAIR**

**Multiuse****4-101.11 Characteristics.**

Materials that are used in the construction of UTENSILS and FOOD-CONTACT SURFACES of EQUIPMENT may not allow the migration of deleterious substances or impart colors, odors, or tastes to FOOD and under normal use conditions shall be: <sup>P</sup>

- (A) Safe; <sup>P</sup>
- (B) Durable, CORROSION-RESISTANT, and nonabsorbent;
- (C) Sufficient in weight and thickness to withstand repeated WAREWASHING;
- (D) Finished to have a SMOOTH, EASILY CLEANABLE surface; and
- (E) Resistant to pitting, chipping, crazing, scratching, scoring, distortion, and decomposition.

**4-101.12 Cast Iron, Use Limitation.**

- (A) Except as specified in ¶¶ (B) and (C) of this section, cast iron may not be used for UTENSILS or FOOD-CONTACT SURFACES of EQUIPMENT.
- (B) *Cast iron may be used as a surface for cooking.*
- (C) *Cast iron may be used in UTENSILS for serving FOOD if the UTENSILS are used only as part of an uninterrupted process from cooking through service.*

**4-101.13 Lead, Use Limitation.**

- (A) Ceramic, china, and crystal UTENSILS, and decorative UTENSILS such as hand painted ceramic or china that are used in contact with FOOD shall be lead-free or contain levels of lead not exceeding the limits of the following UTENSIL categories: <sup>P</sup>

Beverage Mugs, Cups, Pitchers	Coffee Mugs	0.5

(B) Pewter alloys containing lead in excess of 0.05% may not be used as a FOOD-CONTACT SURFACE. <sup>P</sup>

(C) Solder and flux containing lead in excess of 0.2% may not be used as a FOOD-CONTACT SURFACE.

**4-101.14 Copper, Use Limitation.**

(A) Except as specified in ¶ (B) of this section, copper and copper alloys such as brass may not be used in contact with a FOOD that has a pH below 6 such as vinegar, fruit JUICE, or wine or for a fitting or tubing installed between a backflow prevention device and a carbonator. <sup>P</sup>

(B) *Copper and copper alloys may be used in contact with beer brewing ingredients that have a pH below 6 in the prefermentation and fermentation steps of a beer brewing operation such as a brewpub or microbrewery.*

**4-101.15 Galvanized Metal, Use Limitation.**

Galvanized metal may not be used for UTENSILS or FOOD-CONTACT SURFACES of EQUIPMENT that are used in contact with acidic FOOD. <sup>P</sup>

**4-101.16 Sponges, Use Limitation.**

Sponges may not be used in contact with cleaned and SANITIZED or in-use FOOD-CONTACT SURFACES.

**4-101.17 Wood, Use Limitation.**

(A) Except as specified in ¶¶ (B), (C), and (D) of this section, wood and wood wicker may not be used as a FOOD-CONTACT SURFACE.

(B) *Hard maple or an equivalently hard, close-grained wood may be used for:*

*(1) Cutting boards; cutting blocks; bakers' tables; and UTENSILS such as rolling pins, doughnut dowels, salad bowls, and chopsticks; and*

*(2) Wooden paddles used in confectionery operations for pressure scraping kettles when manually preparing confections at a temperature of 110°C (230°F) or above.*

(C) *Whole, uncut, raw fruits and vegetables, and nuts in the shell may be kept in the wood shipping containers in which they were received, until the fruits, vegetables, or nuts are used.*

(D) *If the nature of the FOOD requires removal of rinds, peels, husks, or shells before consumption, the whole, uncut, raw FOOD may be kept in:*

(1) Be specifically designed and equipped to maintain the commercial sterility of aseptically PACKAGED FOOD in a homogenous liquid form for a specified duration from the time of opening of the PACKAGING within the EQUIPMENT; <sup>P</sup> and

(2) Conform to the requirements for this EQUIPMENT as specified in *NSF/ANSI 18-2006-Manual Food and Beverage Dispensing Equipment*. <sup>P</sup>

**4-204.14 Vending Machine, Vending Stage Closure.**

The dispensing compartment of a VENDING MACHINE including a machine that is designed to vend prePACKAGED snack FOOD that is not TIME/TEMPERATURE CONTROL FOR SAFETY FOOD such as chips, party mixes, and pretzels shall be equipped with a self-closing door or cover if the machine is:

(A) Located in an outside area that does not otherwise afford the protection of an enclosure against the rain, windblown debris, insects, rodents, and other contaminants that are present in the environment; or

(B) Available for self-service during hours when it is not under the full-time supervision of a FOOD EMPLOYEE.

**4-204.15 Bearings and Gear Boxes, Leakproof.**

EQUIPMENT containing bearings and gears that require lubricants shall be designed and constructed so that the lubricant cannot leak, drip, or be forced into FOOD or onto FOOD-CONTACT SURFACES.

**4-204.16 Beverage Tubing, Separation.**

*Except for cold plates that are constructed integrally with an ice storage bin,* BEVERAGE tubing and cold-plate BEVERAGE cooling devices may not be installed in contact with stored ice.

**4-204.17 Ice Units, Separation of Drains.**

Liquid waste drain lines may not pass through an ice machine or ice storage bin.

**4-204.18 Condenser Unit, Separation.**

If a condenser unit is an integral component of EQUIPMENT, the condenser unit shall be separated from the FOOD and FOOD storage space by a dustproof barrier.

**4-204.19 Can Openers on Vending Machines.**

Cutting or piercing parts of can openers on VENDING MACHINES shall be protected from manual contact, dust, insects, rodents, and other contamination.

**4-204.110 Molluscan Shellfish Tanks.**

(A) Except as specified under ¶ (B) of this section, MOLLUSCAN SHELLFISH life support system display tanks may not be used to display shellfish that are offered for human consumption and shall be conspicuously marked so that it is obvious to the CONSUMER that the shellfish are for display only. <sup>P</sup>

(B) MOLLUSCAN SHELLFISH life-support system display tanks that are used to store and display shellfish that are offered for human consumption shall be operated and maintained in accordance with a VARIANCE granted by the DEPARTMENT as specified in § 1-105.11 and under § 1-105.12 and a HACCP PLAN that: <sup>Pf</sup>

(1) Is submitted by the LICENSE HOLDER and APPROVED as specified by the DEPARTMENT under 1-106.11 and 1-106.12; <sup>Pf</sup> and

(2) Ensures that:

- (a) Water used with FISH other than MOLLUSCAN SHELLFISH does not flow into the molluscan tank, <sup>Pf</sup>
- (b) The safety and quality of the shellfish as they were received are not compromised by the use of the tank, <sup>Pf</sup> and
- (c) The identity of the source of the SHELLSTOCK is retained as specified under § 3-203.12. <sup>Pf</sup>

**4-204.111 Vending Machines, Automatic Shutoff.**

(A) A machine vending TIME/TEMPERATURE CONTROL FOR SAFETY FOOD shall have an automatic control that prevents the machine from vending FOOD:

- (1) If there is a power failure, mechanical failure, or other condition that results in an internal machine temperature that cannot maintain FOOD temperatures as specified under Chapter 3; <sup>P</sup> and
- (2) If a condition specified under Subparagraph (A)(1) of this section occurs, until the machine is serviced and restocked with FOOD that has been maintained at temperatures specified under Chapter 3. <sup>P</sup>

(B) When the automatic shutoff within a machine vending TIME/TEMPERATURE CONTROL FOR SAFETY FOOD is activated:

- (1) In a refrigerated VENDING MACHINE, the ambient temperature may not exceed 5°C (41°F) for more than 30 minutes immediately after the machine is filled, serviced, or restocked; <sup>P</sup> or
- (2) In a hot holding VENDING MACHINE, the ambient temperature may not be less than 57°C (135°F) for more than 120 minutes immediately after the machine is filled, serviced, or restocked. <sup>P</sup>

**4-204.112 Temperature Measuring Devices.**

(A) In a mechanically refrigerated or hot FOOD storage unit, the sensor of a TEMPERATURE MEASURING DEVICE shall be located to measure the air temperature or a simulated product temperature in the warmest part of a mechanically refrigerated unit and in the coolest part of a hot FOOD storage unit.

(B) Except as specified in ¶ (C) of this section, cold or hot holding EQUIPMENT used for TIME/TEMPERATURE CONTROL FOR SAFETY FOOD shall be designed to include and shall be equipped with at least one integral or permanently affixed TEMPERATURE MEASURING DEVICE that is located to allow easy viewing of the device's temperature display.

(C) *Paragraph (B) of this section does not apply to EQUIPMENT for which the placement of a TEMPERATURE MEASURING DEVICE is not a practical means for measuring the ambient air surrounding the FOOD because of the design, type, and use of the EQUIPMENT, such as calrod units, heat lamps, cold plates, bainmaries, steam tables, insulated FOOD transport containers, and salad bars.*

(D) TEMPERATURE MEASURING DEVICES shall be designed to be easily readable.

(E) FOOD TEMPERATURE MEASURING DEVICES and water TEMPERATURE MEASURING DEVICES on WAREWASHING machines shall have a numerical scale, printed record, or digital readout in increments no greater than 1°C or 2°F in the intended range of use. <sup>Pf</sup>

**4-204.113 Warewashing Machine, Data Plate Operating Specifications.**

A WAREWASHING machine shall be provided with an easily accessible and readable data plate affixed to the machine by the manufacturer that indicates the machine's design and operating specifications including the:

(A) Temperatures required for washing, rinsing, and SANITIZING;

(B) Pressure required for the fresh water SANITIZING rinse *unless the machine is designed to use only a pumped SANITIZING rinse*; and

(C) Conveyor speed for conveyor machines or cycle time for stationary rack machines.

**4-204.114 Warewashing Machines, Internal Baffles.**

WAREWASHING machine wash and rinse tanks shall be equipped with baffles, curtains, or other means to minimize internal cross contamination of the solutions in wash and rinse tanks.

**4-204.115 Warewashing Machines, Temperature Measuring Devices.**

A WAREWASHING machine shall be equipped with a TEMPERATURE MEASURING DEVICE that indicates the temperature of the water:

(A) In each wash and rinse tank; <sup>Pf</sup> and

(B) As the water enters the hot water SANITIZING final rinse manifold or in the chemical SANITIZING solution tank. <sup>Pf</sup>

**4-204.116 Manual Warewashing Equipment, Heaters and Baskets.**

If hot water is used for SANITIZATION in manual WAREWASHING operations, the SANITIZING compartment of the sink shall be:

(A) Designed with an integral heating device that is capable of maintaining water at a temperature not less than 77°C (171°F); <sup>Pf</sup> and

(B) Provided with a rack or basket to allow complete immersion of EQUIPMENT and UTENSILS into the hot water. <sup>Pf</sup>

**4-204.117 Warewashing Machines, Automatic Dispensing of Detergents and Sanitizers.**

A WAREWASHING machine that is installed after adoption of this Code by the department, shall be equipped to:

(A) Automatically dispense detergents and SANITIZERS; <sup>Pf</sup> and

(B) Incorporate a visual means to verify that detergents and SANITIZERS are delivered or a visual or audible alarm to signal if the detergents and SANITIZERS are not delivered to the respective washing and SANITIZING cycles. <sup>Pf</sup>

**4-204.118 Warewashing Machines, Flow Pressure Device.**

(A) WAREWASHING machines that provide a fresh hot water SANITIZING rinse shall be equipped with a pressure gauge or similar device such as a transducer that measures and displays the water pressure in the supply line immediately before entering the WAREWASHING machine; and

(B) If the flow pressure measuring device is upstream of the fresh hot water SANITIZING rinse control valve, the device shall be mounted in a 6.4 millimeter or one-fourth inch Iron Pipe Size (IPS) valve.

(C) *Paragraphs (A) and (B) of this section do not apply to a machine that uses only a pumped or recirculated SANITIZING rinse.*

**4-204.119 Warewashing Sinks and Drainboards, Self-Draining.**

Sinks and drainboards of WAREWASHING sinks and machines shall be self-draining.

**4-204.120 Equipment Compartments, Drainage.**

EQUIPMENT compartments that are subject to accumulation of moisture due to conditions such as condensation, FOOD or BEVERAGE drip, or water from melting ice shall be sloped to an outlet that allows complete draining.

**4-204.121 Vending Machines, Liquid Waste Products.**

(A) VENDING MACHINES designed to store BEVERAGES that are PACKAGED in containers made from paper products shall be equipped with diversion devices and retention pans or drains for container leakage.

**4-301.14 Ventilation Hood Systems, Adequacy.**

Ventilation hood systems and devices shall be sufficient in number and capacity to prevent grease or condensation from collecting on walls and ceilings.

**4-301.15 Clothes Washers and Dryers.**

(A) Except as specified in ¶ (B) of this section, if work clothes or LINENS are laundered on the PREMISES, a mechanical clothes washer and dryer shall be provided and used.

(B) *If on-PREMISES laundering is limited to wiping cloths intended to be used moist, or wiping cloths are air-dried as specified under § 4-901.12, a mechanical clothes washer and dryer need not be provided.*

**4-501.18 Warewashing Equipment, Clean Solutions.**

The wash, rinse, and SANITIZE solutions shall be maintained clean.

**4-501.19 Manual Warewashing Equipment, Wash Solution Temperature.**

The temperature of the wash solution in manual WAREWASHING EQUIPMENT shall be maintained at not less than 43°C (110°F) or the temperature specified on the cleaning agent manufacturer's label instructions. <sup>Pf</sup>

**4-501.110 Mechanical Warewashing Equipment, Wash Solution Temperature.**

(A) The temperature of the wash solution in spray type warewashers that use hot water to SANITIZE may not be less than:

- (1) For a stationary rack, single temperature machine, 74°C (165°F); <sup>Pf</sup>
- (2) For a stationary rack, dual temperature machine, 66°C (150°F); <sup>Pf</sup>
- (3) For a single tank, conveyor, dual temperature machine, 71°C (160°F); <sup>Pf</sup>  
or
- (4) For a multitank, conveyor, multitemperature machine, 66°C (150°F). <sup>Pf</sup>



(B) The temperature of the wash solution in spray-type warewashers that use chemicals to SANITIZE may not be less than 49°C (120°F).<sup>Pf</sup>

**4-501.111 Manual Warewashing Equipment, Hot Water Sanitization Temperatures.**

If immersion in hot water is used for SANITIZING in a manual operation, the temperature of the water shall be maintained at 77°C (171°F) or above.<sup>P</sup>

**4-501.112 Mechanical Warewashing Equipment, Hot Water Sanitization Temperatures.**

(A) Except as specified in ¶ (B) of this section, in a mechanical operation, the temperature of the fresh hot water SANITIZING rinse as it enters the manifold may not be more than 90°C (194°F), or less than:<sup>Pf</sup>

- (1) For a stationary rack, single temperature machine, 74°C (165°F);<sup>Pf</sup> or
- (2) For all other machines, 82°C (180°F).<sup>Pf</sup>

(B) *The maximum temperature specified under ¶ (A) of this section, does not apply to the high pressure and temperature systems with wand-type, hand-held, spraying devices used for the in-place cleaning and SANITIZING of EQUIPMENT such as MEAT SAWS.*

**4-501.113 Mechanical Warewashing Equipment, Sanitization Pressure.**

The flow pressure of the fresh hot water SANITIZING rinse in a WAREWASHING machine, as measured in the water line immediately downstream or upstream from the fresh hot water SANITIZING rinse control valve, shall be within the range specified on the machine manufacturer’s data plate and may not be less than 35 kilopascals (5 pounds per square inch) or more than 200 kilopascals (30 pounds per square inch).

**4-501.114 Manual and Mechanical Warewashing Equipment, Chemical Sanitization -Temperature, pH, Concentration, and Hardness.**

A chemical SANITIZER used in a SANITIZING solution for a manual or mechanical operation at contact times specified under ¶ 4-703.11 (C) shall meet the criteria specified in § 7-204.11 SANITIZERS, Criteria, shall be used in accordance with the EPA-registered label use instructions,<sup>P</sup> and shall be used as follows:

(A) A chlorine solution shall have a minimum temperature based on the concentration and pH of the solution as listed in the following chart;<sup>P</sup>

Concentration Range	Minimum Temperature	
	pH 10 or less °C (°F)	pH 8 or less °C (°F)
25-49	49 (120)	49 (120)

(B) An iodine solution shall have a:

- (3) Be used only in water with 500 mg/L hardness or less or in water having a hardness no greater than specified by the EPA-registered label use instructions;<sup>P</sup>

(D) If another solution of a chemical specified under ¶¶ (A) - (C) of this section is used, the LICENSE HOLDER shall demonstrate to the REGULATORY AUTHORITY that the solution achieves SANITIZATION and the use of the solution shall be APPROVED;<sup>P</sup> or

(E) If a chemical SANITIZER other than chlorine, iodine, or a quaternary ammonium compound is used, it shall be applied in accordance with the EPA-registered label use instructions.<sup>P</sup>

(F) If a chemical SANITIZER is generated by a device located on-site at the FOOD ESTABLISHMENT it shall be used as specified in ¶¶(A)-(D) of this section and shall be produced by a device that:

- (1) Complies with regulation as specified in §§ 2(q)(1) and 12 of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA),<sup>P</sup>
- (2) Complies with 40 CFR 152.500 Requirement for Devices and 40 CFR 156.10 Labeling Requirements,<sup>P</sup>
- (3) Displays the EPA device manufacturing facility registration number on the device,<sup>Pf</sup> and
- (4) Is operated and maintained in accordance with manufacturer's instructions.<sup>Pf</sup>

**Drying**

**4-901.11 Equipment and Utensils, Air-Drying Required.**

After cleaning and SANITIZING, EQUIPMENT and UTENSILS:

(A) Shall be air-dried or used after adequate draining as specified in the first paragraph of 40 CFR 180.940 Tolerance exemptions for active and inert ingredients for use in antimicrobial formulations (FOOD-CONTACT SURFACE SANITIZING solutions), before contact with FOOD; and

(B) May not be cloth dried *except that UTENSILS that have been air-dried may be polished with cloths that are maintained clean and dry.*

**4-901.12 Wiping Cloths, Air-Drying Locations.**

Wiping cloths laundered in a FOOD ESTABLISHMENT that does not have a mechanical clothes dryer as specified in ¶ 4-301.15 (B) shall be air-dried in a location and in a manner that prevents contamination of FOOD, EQUIPMENT, UTENSILS, LINENS, and SINGLE-SERVICE and SINGLE-USE ARTICLES and the wiping cloths. *This section does not apply if wiping cloths are stored after laundering in a SANITIZING solution as specified under § 4-501.114.*

**Lubricating and Reassembling**

**4-902.11 Food-Contact Surfaces.**

Lubricants as specified under § 7-205.11 shall be applied to FOOD-CONTACT SURFACES that require lubrication in a manner that does not contaminate FOOD-CONTACT SURFACES.

**4-902.12 Equipment.**

(D) *Items that are kept in closed PACKAGES may be stored less than 15 cm (6 inches) above the floor on dollies, pallets, racks, and skids that are designed as specified under § 4-204.122.*

#### **4-903.12 Prohibitions.**

*Except where a toilet room is located outside a FOOD ESTABLISHMENT and does not open directly into the FOOD ESTABLISHMENT such as a toilet room that is provided by the management of a shopping mall, a toilet room located on the PREMISES shall be completely enclosed and provided with a tight-fitting and self-closing door.*

**6-202.15 Outer Openings, Protected.**

(A) Except as specified in ¶¶ (B), (C), (D), and (E) of this section, outer openings of a FOOD ESTABLISHMENT shall be protected against the entry of insects and rodents by:

- (1) Filling or closing holes and other gaps along floors, walls, and ceilings;
- (2) Closed, tight-fitting windows; and
- (3) Solid, self-closing, tight-fitting doors.

*(B) Paragraph (A) of this section, does not apply if a FOOD ESTABLISHMENT opens into a larger structure, such as a mall, airport, or office building, or into an attached structure, such as a porch, and the outer openings from the larger or attached structure are protected against the entry of insects and rodents.*

(C) *Exterior doors used as exits need not be self-closing if they are:*

- (1) *Solid and tight-fitting;*

(2) *Designated for use only when an emergency exists, by the fire protection authority that has jurisdiction over the FOOD ESTABLISHMENT; and*

(3) *Limited-use so they are not used for entrance or exit from the building for purposes other than the designated emergency exit use.*

(D) Except as specified in ¶¶ (B) and (E) of this section, if the windows or doors of a FOOD ESTABLISHMENT, or of a larger structure within which a FOOD ESTABLISHMENT is located, are kept open for ventilation or other purposes or a TEMPORARY FOOD ESTABLISHMENT is not provided with windows and doors as specified under ¶ (A) of this section, the openings shall be protected against the entry of insects and rodents by:

- (1) 16 mesh to 25.4mm (16 mesh to 1 inch) screens;
- (2) Properly designed and installed air curtains to control flying insects; or
- (3) Other effective means.

(E) *Paragraph (D) does not apply if flying insects and other pests are absent due to the location of the establishment, the weather, or other limiting condition.*

**6-202.16 Exterior Walls and Roofs, Protective Barrier.**

Perimeter walls and roofs of a FOOD ESTABLISHMENT shall effectively protect the establishment from the weather and the entry of insects, rodents, and other animals.

**6-202.17 Outdoor Food Vending Areas, Overhead Protection.**

*Except for machines that vend canned BEVERAGES, if located outside, a machine used to vend FOOD shall be provided with overhead protection.*

**6-202.18 Outdoor Service Base Areas, Overhead Protection.**

*Except for areas used only for the loading of water or the discharge of SEWAGE and other liquid waste, through the use of a closed system of hoses, SERVICE BASES shall be provided with overhead protection.*

**6-202.19 Outdoor Walking and Driving Surfaces, Graded to Drain.**

Exterior walking and driving surfaces shall be graded to drain.

**6-202.110 Outdoor Refuse Areas, Curbed and Graded to Drain.**

Outdoor REFUSE areas shall be constructed in accordance with LAW and shall be curbed and graded to drain to collect and dispose of liquid waste that results from the REFUSE and from cleaning the area and waste receptacles.

**6-501.16 Drying Mops.**

After use, mops shall be placed in a position that allows them to air-dry without soiling walls, EQUIPMENT, or supplies.

**6-501.17 Absorbent Materials on Floors, Use Limitation.**

Except as specified in ¶ 6-501.13 (B), sawdust, wood shavings, granular salt, baked clay, diatomaceous earth, or similar materials may not be used on floors.

**6-501.18 Cleaning of Plumbing Fixtures.**

PLUMBING FIXTURES such as HANDWASHING SINKS, toilets, and urinals shall be cleaned as often as necessary to keep them clean.

**6-501.19 Closing Toilet Room Doors.**

*Except during cleaning and maintenance operations,* toilet room doors as specified under § 6-202.14 shall be kept closed.

**6-501.110 Using Dressing Rooms and Lockers.**

(A) Dressing rooms shall be used by EMPLOYEES if the EMPLOYEES regularly change their clothes in the establishment.

(B) Lockers or other suitable facilities shall be used for the orderly storage of EMPLOYEE clothing and other possessions.

**6-501.111 Controlling Pests.**



The PREMISES shall be maintained free of insects, rodents, and other pests. The presence of insects, rodents, and other pests shall be controlled to eliminate their presence on the PREMISES by:

- (A) Routinely inspecting incoming shipments of FOOD and supplies;
- (B) Routinely inspecting the PREMISES for evidence of pests;
- (C) Using methods, if pests are found, such as trapping devices or other means of pest control as specified under §§ 7-202.12, 7-206.12, and 7-206.13; <sup>PF</sup> and
- (D) Eliminating harborage conditions.

**6-501.112 Removing Dead or Trapped Birds, Insects, Rodents, and Other Pests.**

Dead or trapped birds, insects, rodents, and other pests shall be removed from control devices and the PREMISES at a frequency that prevents their accumulation, decomposition, or the attraction of pests.

**6-501.113 Storing Maintenance Tools.**

Maintenance tools such as brooms, mops, vacuum cleaners, and similar items shall be:

- (A) Stored so they do not contaminate FOOD, EQUIPMENT, UTENSILS, LINENS, and SINGLE-SERVICE and SINGLE-USE ARTICLES; and
- (B) Stored in an orderly manner that facilitates cleaning the area used for storing the maintenance tools.

**6-501.114 Maintaining Premises, Unnecessary Items and Litter.**

The PREMISES shall be free of:

- (A) Items that are unnecessary to the operation or maintenance of the establishment such as EQUIPMENT that is nonfunctional or no longer used; and
- (B) Litter.

**6-501.115 Prohibiting Animals.**

(A) Except as specified in ¶¶ (B), (C), and (D) of this section, live animals may not be allowed on the PREMISES of a FOOD ESTABLISHMENT. <sup>PF</sup>

(B) *Live animals may be allowed in the following situations if the contamination of FOOD; clean EQUIPMENT, UTENSILS, and LINENS; and unwrapped SINGLE-SERVICE and SINGLE-USE ARTICLES cannot result:*

(1) *Edible FISH or decorative FISH in aquariums, shellfish or crustacea on ice or under refrigeration, and shellfish and crustacea in display tank systems;*

(2) *Patrol dogs accompanying police or security officers in offices and dining, sales, and storage areas, and sentry dogs running loose in outside fenced areas;*

(3) *In areas that are not used for FOOD preparation and that are usually open for customers, such as dining and sales areas, SERVICE ANIMALS that are controlled by the disabled EMPLOYEE or person, if a health or safety HAZARD will not result from the presence or activities of the SERVICE ANIMAL;*

(4) *Pets in the common dining areas of institutional care facilities such as nursing homes, assisted living facilities, group homes, or residential care facilities at times other than during meals if:*

(a) *Effective partitioning and self-closing doors separate the common dining areas from FOOD storage or FOOD preparation areas,*

(b) *Condiments, EQUIPMENT, and UTENSILS are stored in enclosed cabinets or removed from the common dining areas when pets are present, and*

(c) *Dining areas including tables, countertops, and similar surfaces are effectively cleaned before the next meal service; and*

(5) *In areas that are not used for FOOD preparation, storage, sales, display, or dining, in which there are caged animals or animals that are similarly restricted, such as in a variety store that sells pets or a tourist park that displays animals.*

(C) *Live or dead FISH bait may be stored if contamination of FOOD; clean EQUIPMENT, UTENSILS, and LINENS; and unwrapped SINGLE-SERVICE and SINGLE-USE ARTICLES cannot result.*

(D) *Only dogs may be allowed in the outside seating areas of a FOOD ESTABLISHMENT if the following requirements are strictly followed:*

(1) *Applies to the exterior areas of outdoor dining of a FOOD ESTABLISHMENT only. Live animals are not allowed in the interior portions of the FOOD ESTABLISHMENT.*

(2) *A separate entrance is provided to reach the outdoor dining area so that dogs never enter the FOOD ESTABLISHMENT.*

- (8) HACCP concepts and practices; and
- (9) Special problems in FOOD service sanitation.

(D) The department may authorize modification of course content to address code changes and emerging FOOD safety issues.

(E) A request for APPROVAL of a recertification training course shall be submitted to the DEPARTMENT in writing along with the proposed curriculum.

(F) The DEPARTMENT may cancel its APPROVAL of a training course at any time if its investigation reveals that the criteria in this subsection are not being met.
