## Dear Wisconsin Children's Safety Advocates:

In June 2018, the U.S. Consumer Product Safety Commission issued a total of **2 recalls relating to products affecting children**. Attached is a summary of the releases identifying the product, the problem, and what should be done with the recalled product.

We have found that not all of the recalls are picked up by the news media as they occur. This monthly summary will give you the opportunity to review all of the children's product safety recalls for the past month. If you are interested in a complete text of the recall, click on the hyperlink at the end of the recall description. This will direct you to the recall notice located on the CPSC website.

# KEEP YOUR KIDS SAFE

**Release Number: (#18-747)** Ashley Furniture Industries Inc., of Arcadia, Wis., is announcing the voluntary recall of about 900 Amnon floor lamps. This recall involves Signature Design by Ashley Amnon floor lamps with a floor switch and 12 lightbulb sockets. The portable, electric floor lamps are metal with a bronze finish and measure about 64 inches tall. Model number L207971 is printed on a label on the underside of the lamp's base.

**Problem:** The incorrect label on the lamp states that consumers can use 40 watt lightbulbs in the product. However, the socket is only designed to support 25 watt lightbulbs. Use of incorrect wattage lightbulbs can melt the power switch, posing a burn hazard.

**What to do:** Consumers should immediately stop using and unplug the recalled floor lamps and contact Ashley Furniture for instructions on how to receive a full refund of the purchase price. Ashley Furniture is contacting all known purchasers directly. **Release Number: (#18-751)** Top Gear Inc., d/b/a Helmets R Us, of Tacoma, Wash.; Rollerblade USA LLC, of West Lebanon, N.H., is announcing the voluntary recall of about 9,700 Rollerblade® helmets. This recall involves Rollerblade-branded Helmets R Us helmets, used in schools' physical education programs. The recalled helmets are white and Rollerblade is printed on the side in black. They were manufactured from September 2011 through April 2017. Model 16, SK-501N and the manufactured date (in MM/YYYY format) are printed on a label on the inside of the helmet. "Distributed by: Helmets R Us" is printed on another label inside of the helmet.

**Problem:** The helmets fail to meet the federal safety standard, posing a risk of head injury.

**What to do:** Consumers should immediately stop using the recalled helmets and contact Helmets R Us to receive a free replacement helmet. Helmets R Us is contacting all known purchasers directly.
