Commercial Animal Feed Tonnage Reported for 2017-2021 Wisconsin Department of Agriculture, Trade and Consumer Protection



Manufacturers, labelers and distributors of commercial animal feed in Wisconsin, including dog and cat food / treats, are required to annually hold a commercial feed license and file a tonnage and inspection fee report.

- Commercial feed licenses are valid March 1st through the end of February (28thor 29th).
- The annual license fee is \$25. Each business location in Wisconsin is required to have a license.
- Licensees pay inspection fees for feed distributed in Wisconsin during the calendar year of either \$50 for distributions of 200 tons or less, or \$0.25 per ton for distribution over 200 tons.
- A business submits one tonnage and inspection fee report annually, even if they hold multiple commercial feed licenses.
- In 2021 there were 1,157 businesses, with 1,570 licensed locations.
- Annual license renewal notices and tonnage and inspection fee report forms are mailed in January.

The Wisconsin Legislature passed revisions to Wis. Stat. § 94.72 Commercial Feed during 2017. The statutory changes in the bulleted list, and reflected in Table 1, went into effect for tonnage reported in the 2018 calendar year (filed after January 1, 2019).

- Changed minimum inspection fees from \$0.25/ton, to \$50.00 for 0-200 tons or \$0.25/ton for 201 or more tons, whichever is greater.
- Removed exempt buyer status licenses.
- Removed all credits (prepaid purchases, exempt buyer sales/purchases, and out of state distributions).
- Removed the requirement for invoices to display whether inspection fees are or are not paid.
- Required licensees only report the tons of feed and feed ingredients that they are the first to distribute in or into Wisconsin.


