Commercial Animal Feed Tonnage Reported for 2018-2022 Wisconsin Department of Agriculture, Trade and Consumer Protection



All manufacturers, labelers, and distributors of commercial animal feed in Wisconsin, including food and treats for dogs and cats, are required to hold an annual commercial feed license and file a tonnage and inspection fee report with the Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP). DATCP's commercial feed program uses this information to assist in determining the frequency of inspections and samples taken based on products reported in the annual tonnage report.

In 2022, there was a reported 4,785,035 tons of commercial animal feed in Wisconsin. That is approximately 398,000 tons less than what was reported in 2021. As you can see in Figure 1 and Table 1, there is a steady decline in the number of tons reported over the last five years. Tables 2, 3, and 4 provide data regarding program statistics, feed tonnage, and ingredient tonnage.

- Commercial feed licenses are valid March 1 through the end of February (28 or 29).
- The annual license fee is \$25. Each business location in Wisconsin is required to have a license.
- Licensees pay inspection fees for feed distributed in Wisconsin during the calendar year of either \$50 for distributions of 200 tons or less, or \$0.25 per ton for distribution over 200 tons.
- A business submits one tonnage and inspection fee report annually, even if they hold multiple commercial feed licenses.
- In 2022, there were 1,196 businesses with 1,384 licensed locations.
- Annual license renewal notices and tonnage and inspection fee report forms are mailed in January.


