

2023 Spongy Moth Slow the Spread Program:
Chart of Treatment Sites and Completion Dates

- The 2022 Slow the Spread program has planned treatments for 37 sites in the following 10 counties: Barron, Chippewa, Crawford, Dunn, Grant, La Crosse, Lafayette, Rusk, Vernon, and Washburn.
- Aerial treatments depend on good weather and proper flying conditions. Therefore, dates are usually determined on a day-to-day basis. Any dates that are changed are due to weather, logistical or mechanical problems. The latest updates are available on the toll-free hotline 1-800-642-MOTH (6684), option 1.
- Sites will be treated with one of the following organic products: *Bacillus thuringiensis* var. *kurstaki* (Btk) or Mating Disruption (MD). Generally, Btk is applied in late spring, and MD treatments take place in early summer.
