- SUBJECT: ATCP 134: Residential Rental Practices; Request that the Board Approve a Notice of Preliminary Public Hearing and Comment Period on a Rulemaking Scope Statement (Emergency Under DHS EO #8)

#### TO BE PRESENTED BY: David Woldseth

#### **REQUESTED ACTION:**

At the March 27, 2020 Board meeting, the Department of Agriculture, Trade and Consumer Protection (DATCP) will ask the DATCP Board to approve a Notice of a Preliminary Public Hearing and Comment Period on a Statement of Scope for proposed emergency amendments to the current DATCP rule related to residential rental practices.

DATCP requests the notice be approved because emergency order DHS EO #8 requires security in housing during a public health and economic crisis.

If the notice is approved, DATCP will hold a preliminary public hearing on the scope statement before asking the board to approve the scope statement. A scope statement explains the general purpose and scope of a proposed rule. DATCP may not begin drafting a proposed rule (including a proposal to amend or repeal an existing rule) until the Governor approves a scope statement for the proposed rule and the DATCP Board approves the scope statement.

In accordance with Wis. Stat. § 227.135 (2), the Governor approved this scope statement for emergency rule changes, thereby allowing DATCP to submit this scope statement for publication and to seek approval of the scope statement by the DATCP Board. Before seeking the board's approval of the scope statement, DATCP wants to hold a preliminary public hearing on the scope statement.

Under Wis. Stat. § 227.136 (2), an agency may, at its own initiative, schedule a preliminary public hearing on a scope statement before asking its board to approve the scope statement. Rather than wait up to 10 days for the Joint Committee for the Review of Administrative Rules to issue a written directive requiring such a preliminary public hearing (*See* Wis. Stat. sec. 227.136 (1)), the Department wants to schedule such a hearing promptly due to the urgent nature of this emergency.

DATCP will formally publish this draft scope statement in the March 30, 2020 *Wisconsin Administrative Register* and has filed a copy with the Department of Administration (DOA). If the DATCP board approves the Notice of a Preliminary Public Hearing and Comment Period, DATCP will then hold that **preliminary public hearing** on **Friday, April 3, 2020, at 1 p.m.** Public **comments** will be **due Monday, April 6**.

If the Board approves the notice of preliminary public hearing, the Department will consider public comments before requesting the board's formal approval of the scope statement at a later date.
