REQUESTED ACTION:

At the July 23, 2020, Board meeting, the Department will request approval of a preliminary hearing and comment period for the attached scope statement, regarding ch. ATCP 16 (Dog Sellers and Dog Facility Operators).

SUMMARY:

The objective of the proposed rule is to evaluate whether to change fee amounts for dog sellers and dog facility operators. These fees include license fees and reinspection fees. The department would form an advisory group to assist in writing the proposed rule, pursuant to Wis. Stat. s. 173.41 (14).

The Governor approved the scope statement on July 1, 2020. The Department anticipates that the Joint Committee for Review of Administrative Rules will direct DATCP to hold a preliminary public hearing and comment period, pursuant to Wis. Stat. § 227.136 (1).
