**Commercial feed**, as defined by Wis. Stats. § 94.72(1)(b) and Wis. Admin. Code § ATCP 42.01(2), means any feed, including any custom-mixed or mill-formulated feed, that is sold or bartered, or offered for sale or barter, but does not include any of the following: (a) Unmixed whole seeds or grains identified in United States grain standards; (b) Unmixed ground corn, wheat, rye, barley, oats, buckwheat, flaxseed, kafir, milo, or other unmixed ground seeds or grain; (c) Whole hays, straws, cottonseed hulls, stover and silage, when unmixed with other materials; (d) Meat and other portions of animal carcasses in their raw or natural state without further processing except freezing or denaturing.

**Feed**, as defined by Wis. Admin. Code § ATCP 42.01(8), means any substance which is intended for use as food for animals other than humans. "Feed" includes commercial feed and feed ingredients.

**Feed ingredient**, as defined by Wis. Stats. § 94.72(1)(g) and Wis. Admin. Code § ATCP 42.01(9), means a constituent material, used in the manufacture of a commercial feed, that becomes part of the commercial feed.

**Wisconsin Inspection Fee – Wis. Stats. § 94.72(6)**

- If more than one manufacturer or distributor is involved in the chain of distribution, the one who first sells or distributes commercial feed for further sale is responsible for the payment of inspection fees for the feed, unless the licensee first sells or distributes the commercial feed to an Exempt Buyer.
  - *In other words, the original manufacturer is responsible for the inspection fees of a feed distributed in Wisconsin under their label. The subsequent manufacturer(s) or distributor(s) in the chain of distribution must report to the original manufacturer how many tons of the feed were sold in Wisconsin.*
  - *If the original manufacturer is not licensed in Wisconsin, the next entity in line licensed in Wisconsin is responsible for the inspection fees.*
  - *Each entity responsible for the inspection fee(s) must include a statement on the invoice for every subsequent transaction that the inspection fee(s) were paid to the Department [Wis. Stat. §94.72(6)(c)].*
- If a licensee distributes zero tons of commercial feed in/into Wisconsin (distributions of 1 lb. to 2,000 lbs. are equal to 1 ton), the licensee must complete a tonnage report and explain on Page 1 why the firm's tonnage is zero.
- Report commercial feed tonnage on a calendar year period (January through December).
- Distributions to exempt buyers must be reported.
  - Tonnage of commercial feed sold to an Exempt Buyer must be included as a distribution on your tonnage report (Schedule A), and as a credit on your tonnage report (Schedule B). Credit is **only** given for distributions to Exempt Buyers registered with the Department.
  - The Exempt Buyer list is on page 4 of this report.
  - Exempt Buyers assume responsibility for Wisconsin inspection fees on commercial feed tons they purchase and distribute.
- Retain the detailed, written documentation to support all totals and calculations used in filing the annual Commercial Feed Tonnage & Inspection Fee Report.

**(Step 1) Schedule A: Total Commercial Feed Distributed**

- Itemize all commercial feed or feed ingredients **your firm was first to distribute** during the calendar year, in Wisconsin.
