### Instructions for completing the Grain Dealer License Application

"Grain dealer" means a person who buys producer grain or who markets producer grain as a producer agent. "Grain dealer" does not include any of the following:

- a) A person who merely brokers a contract between a grain producer and a grain dealer without becoming a party to the contract, taking control of grain, or accepting payment on behalf of the grain producer.
- b) A person who merely buys or sells grain on a board of trade or commodity exchange.

"Procure producer grain in this state" means to buy producer grain for receipt in this state or to acquire the right to market producer grain grown in this state.

Page 1 Indicate whether application is an Original or a Renewal by checking the appropriate box.

Legal Name: Please enter full name of applicant (Articles of Incorporation, Partnership Agreement, etc.) including punctuation. If a sole proprietorship, enter the individual's name and provide a social security number by contacting the department.

"Trade Name" – Optional, please complete this only if you are using a d/b/a different from the legal name. Please check appropriate box indicating the type of business operation (Individual, Corporation, etc.). Enter State of Formation.

Mailing Location: Please enter contact person and address where you want all correspondence to be sent. Please provide telephone number(s), fax and email of contact person.

Enter corporation or cooperative officers, partners, trustees, managers or members of an LLC (include titles). Individuals applying as a sole proprietor should enter themselves and the title owner.

- Page 2 Please complete a line for each location engaged in the business of buying or procuring grain from producers (as defined in Wis. Stat. ch. 126, Subchapter III). Please enter the "Primary Location" in the box provided.
- Page 3 Question 1) Enter applicant's month and day for their fiscal year end.

Question 2) Enter the total dollar amount paid (including purchases through barter transactions and/or credits against account receivables) for producer grain procured in this state in your most recently completed fiscal year. If you have no previous purchases or have not completed a fiscal year since you began procuring grain in Wisconsin, please estimate and enter the total amount expected to be paid to producers for grain procured in this state during a full fiscal year. This amount must be greater than zero.

Question 3) Enter the dollar amounts included in Question 2 for grain procured from producers using deferred payment. Deferred payment occurs when procured grain is not paid in full within 7 days of taking custody and title. Please separate the deferred payments according to whether the "High" (.0035), "Low" (.000875) or no assessment rate was applied (see Wis. Admin. Code § ATCP 99.126(3)). The no assessment rate only applies to the producer / owner who has filed a Default Claim Waiver with DATCP. Please enter a zero if this is an Original application or deferred payment was not used to procure producer grain in your most recently completed fiscal year.

Question 4) Enter the bushel amount that corresponds with the dollar amount entered in Question 2. If you have no previous purchases from producers or have not completed a fiscal year since you began procuring grain in Wisconsin, please estimate and enter the total bushel amount expected to be purchased during a full fiscal year. This amount must be greater than zero.

Question 5) Yes or No. Has the applicant used deferred payment to procure producer grain since the beginning of the applicant's last completed fiscal year? The response would also include the use of deferred payment contracts entered into after amounts in Question 3.

Question 6) Yes or No. Is all grain procured from producers exclusively using cash payment? Cash payment includes currency, cashier check, wire transfer or simultaneous barter. Cash payment must occur prior to or on delivery of grain (Company or a personal check is not considered cash). A grain dealer license is not required if your answer to this question is yes.

Question 7) Yes or No. Is all grain procured from producers used solely by applicant to feed their own livestock or as seed for planting? Is the cost of grain solely used by applicant for feed or seed less than \$400,000 a license year? A grain dealer license is not required if your answer to both questions is yes.

Complete Section B if the applicant is a producer who owns greater than 50% of both the farm selling the grain and the dealer who is buying the grain and wishes to have these purchases exempt from fund assessments and financial statement requirements. A Grain Dealer Default Claim Waiver must be on file or filed with the application.

#### Page 4 Complete Section C to calculate standard license fees. Fees include:

- a) There is a non-refundable basic license fee of \$25.00.
- b) There is a supplementary license fee obtained by multiplying the number of bushels reported in Section A Question 4 by 0.1 cent per bushel, and then rounding (up or down) the product to the nearest \$100. The supplementary fee may not be less than \$100 or more than \$10,000.

#### Examples:

Total bushels 459,459.59 bu. x \$0.001 = \$459.46, license fee due is \$500.00

Total bushels 220,140.00 bu. x \$0.001 = \$220.14, license fee due is \$200.00.

**FOR RENEWAL ONLY:** A license fee credit is available when the combined balance of the Agricultural Producer Security Fund (see Wis. Stat. ch. 126, Subchapter III) contributed by grain dealers and grain warehouse keepers exceeds \$2,300,000 on May 31 of any license year. The department will insert the available fee credit amount. The license fee credit can only be used to offset the supplementary license fee.

 For each additional business location (in excess of the primary location), there is an additional fee of \$100.00.

- d) A license surcharge of \$500.00 for operating without a license. Other fees and surcharges may also be applied for activities during unlicensed periods [see Wis. Stat. § 126.11(4)(e)], if applicable.
- e) FOR RENEWAL ONLY: A license surcharge of \$100 for failure to renew dealer license by the expiration date of August 31.
- f) FOR RENEWAL ONLY: A license surcharge of \$100 for failure to file a required annual financial statement by the applicable deadline date.
- g) Total the applicable fees (add lines a through f). Enter total amount due on this line. The applicant has authorized the signing person to execute this application. All statements contained in this application are true, complete and accurate.
