## License, Labeling and Confidential Tonnage Report Requirements for Lime Manufacturers and Distributors

Businesses must obtain a license prior to selling or distributing liming materials in Wisconsin, unless they are only selling or distributing liming materials produced by a license holder. Liming material is defined in §. 94.66(1)(am), Wis. Stats. All liming material shall be sold and guaranteed on the basis of the index zone of the material, unless the material is marl or paper mill refuse lime (§. ATCP 41.02, Wis. Admin. Code).

### LICENSE (Form ARM-ACM-308):

List all index zones and the quarries you expect to be active and will be covered by the license. Submit copies of each label for **packaged** liming material and/or copies of invoices/bills of lading for **bulk** lime products with your license application.

The annual liming materials license expires on December 31. Operating without a license is a violation of Wisconsin Law, and subjects you to enforcement action.

### APPLICATION TO SELL LIMING MATERIALS BY VOLUME (Form ARM-ACM-311):

Complete this application if you distribute liming materials by volume rather than weight, when weighing facilities are not readily available. Submit the form with the license application. You will be notified by mail if your application to sell liming materials by volume is approved.

Do not use this form if you sell liming materials by weight.

### TONNAGE (Form ARM-ACM-310):

This form is for reporting the annual tonnage for all liming materials distributed in Wisconsin during January 1 through December 31. The liming materials tonnage fee is one and one quarter cent (\$0.0125) per ton for liming materials distributed in the state. The minimum tonnage fee is \$1.00 for any sales up to 80 tons. The confidential report and fees are due on February 1.

**Failure to file a correctly completed license application will delay the issuance of your license.**

**94.66(6)(a)** Every person engaged in the business of selling or distributing liming material shall furnish each purchaser on final delivery of a lot or order of liming material a written statement showing total amount delivered in tons and the grade thereof as defined in par. (b). A written statement setting forth the grade of the liming material being transported shall accompany each vehicle when making delivery. All liming material shall be distributed on a scale weight basis, except that where no weighing facilities are readily available and on prior approval of the department, liming materials may be distributed by volume if each vehicle transporting liming materials is accurately and conspicuously marked to show cubic yard capacity from which the seller must guarantee a ton weight equivalent based on rules established by the department. This paragraph does not apply to marl or paper mill refuse lime as these materials are distributed on an equivalent cubic yard basis as prescribed by department rule.

**ATCP 41.05 Sale by ton weight equivalent.** (a) Each person distributing liming material by volume on a ton weight equivalent basis shall be responsible for the correct cubic yard capacity marking of all vehicles used to distribute liming material.

(2) Persons desiring authority to distribute liming material by volume rather than weight, where weighing facilities are not readily available, shall submit requests for approval in writing to the department with the following information:

- (a) Name and address of applicant,
  - (b) Number of vehicles to be employed in hauling liming materials,
  - (c) Ownership of vehicles,
  - (d) Cubic yard capacity of each vehicle,
  - (e) Location of loading sites and location of scales closest to such loading sites, and
  - (f) Business locations from which the vendor wishes to sell by ton weight equivalent.
- (3) Unless otherwise specified in the notice of approval, all approvals for sale by volume shall expire on December 31 of each year. In the event of any change in vehicle usage or other data specified under subsection (2) during the period for which approval was granted, the department shall be notified of such fact and a supplemental request for approval shall be submitted within 15 days after such change. All temporary replacement vehicles used shall be marked to show cubic yard capacity as required by sec. 94.66, Wis. Stats.
- (4) The ton weight equivalent per cubic yard of each different liming material shall be determined by weighing one or more loads of known cubic volume of such material. The total weight is then divided by the cubic yards weighed to arrive at the ton weight equivalent per cubic yard.

A research fee of one and one-quarter cents per ton (\$0.0125) on all liming materials (or the equivalent amount of marl and paper mill refuse lime) sold within the state shall be paid to the Wisconsin Department of Agriculture, Trade and Consumer Protection annually for the preceding calendar year. If more than one distributor or seller is involved in the chain of distribution, the person who first sells or distributes liming material for further sale is responsible for the payment of research fees on that material. The minimum fee is \$1. However, if NO SALES were made, the \$1 fee is not required.

If another licensee has paid the research fee, you are entitled to a credit for that tonnage by completing the Credit Section found in Section B.
