The above nursery enters into this Systems Approach to Nursery Certification (SANC) agreement with the Wisconsin Department of Agriculture, Trade and Consumer Protection (Department) in order to produce, handle and ship plant materials under systems approach methodology. This nursery agrees to abide by all of the conditions identified in the Facility SANC Manual for this firm, the SANC Standards and any compliance agreement(s) accompanying this agreement. The Department agrees to provide staff support to implement and carry out the SANC program for the timeframe indicated below.

**Issuing State Authority:** Wisconsin Statutes Chapter 93 and 94 authorizes the Department to enter into compliance agreements with persons engaged in the growing, handling, or moving of plants or plant products.

**Terms:** This Agreement is subject to Wisconsin Statutes Chapter 93 and 94. This Agreement becomes effective when signed and will remain in effect until February 20, 20xx unless rescinded for non-compliance, or at the request of either signatory. The agreement may be revised upon approval of both authorities. Any certificates issued for use by xxxxxxxxxxxxxxxx remains the property of the Department and may not be distributed for use by any other entity, and must be returned upon request of the inspector or any other authorized representative of the State. No liability shall attach to the Department or to any representative of the Department with respect to this certificate.

**SANC Logo and Statements:** The SANC Logo is the registered property of the National Plant Board (NPB) and the logo may only be used by McKay Nursery Company while the SANC agreement is valid. While the agreement is valid, this logo may be reproduced, published or publicly displayed, and public statements or references to the SANC certification of McKay Nursery Company may be made. Use of this logo is at the discretion and approval of the NPB. No liability shall attach to the NPB or to any representative of the NPB with respect to this logo or use of this logo.

I, xxxxxxxxxxx undersigned, agree to handle, pack, process, and move plant material in accordance with the Facility SANC Manual for this firm, nursery laws and regulations; use all permits, certificates and SANC logo and statements in accordance with instructions; maintain and offer for inspection facilities and records as may be required; and abide by SANC Standard and accompanying compliance agreement(s). If this agreement is revoked, authorization for use of the SANC logo and references to SANC certification is also revoked. This agreement is effective upon signing by authorized representative of establishment and the certifying authority.
