Who needs a Seed Labeler's License?

- ➔ Any person or business responsible for labeling any agricultural seed (includes crop seed, vegetable seed, lawn or turf seed, flower seed and native species seed) offered for sale, or displayed or distributed in Wisconsin.
- ➔ Any person or business in Wisconsin who opens a labeled bag of seed and then offers the contents for sale in mixed or unmixed form.

You do not need a Seed Labeler's License if you sell seed that you have produced and the transaction takes place on your farm premises, or if you sell seed in unopened bags that have been labeled by a person holding a valid Seed Labeler's License.

Please indicate below the type of operation that best applies to you:

- Our business name and address is required to appear on the seed label as producer or packager.
- Our business opens bags of seed and sells the seed in mixed and/or unmixed form.
