SUMMARY SPECIAL ORDER

The State of Wisconsin Department of Agriculture, Trade and Consumer Protection (Department), by the State Veterinarian, based upon its efforts to protect Wisconsin's domestic bird industry from the spread of highly pathogenic avian influenza (HPAI) virus, a deadly, communicable virus among domestic birds, makes the following Summary Special Order quarantining domestic bird premises and domestic bird products.

FINDINGS OF FACT

(1) The Department, in cooperation with the United States Department of Agriculture (USDA), has detected highly pathogenic avian influenza (HPAI) on premises throughout the State of Wisconsin.

(2) HPAI is an extremely infectious fatal bird disease that, once established, can spread rapidly from flock to flock. There is no known treatment that cures the HPAI virus, and all domestic birds are susceptible.

(3) Domestic birds means any avian species held in captivity, including poultry, ratites, farm-raised gamebirds that have not been released to the wild, and pet birds. See Wis. Stats. § 95.001(1)(ad), and Wis. Admin. Code § ATCP 10.02.

(4) Transmission can be minimized by limiting the movement and commingling of domestic birds and domestic bird products (including but not limited to eggs, meat, feathers, and manure) between premises, and by using proper biosecurity methods, including washing trucks and trailers between loads, washing and disinfecting boots and clothing, and establishing a line of separation between clean and dirty areas.

(5) A quarantine of domestic birds near infected premises is necessary to minimize HPAI disease spread.

CONCLUSIONS OF LAW

(1) Under Chapters 93 and 95 of the Wisconsin Statutes, the Department is authorized to take this action to protect domestic bird health in Wisconsin. The Department has jurisdiction over the protection of the health of animals in this state and the authority to prevent, control, and eradicate communicable diseases among animals through quarantines and other measures.

(2) The Department is responsible for administering Wisconsin's animal health program under Wis. Stats. ch. 95. The program is designed to protect the health of animals in this state and to prevent, control, and eradicate communicable diseases among animals. See Wis. Stats. § 95.20.

(3) To protect the health of animals located in this state and of humans residing in this state, the Department may establish, maintain, enforce, and regulate quarantines and other measures relating to the importation, movement, and care of animals and their products, the disinfection of suspected localities and articles, and the disposition of animals, as the Department determines are necessary. See Wis. Stats. §§ 93.07(10) and 95.20.

ORDER

Based upon the above stated findings of fact and conclusions of law, and, in accordance with Wis. Stats. §§ 93.07(10) and 95.20, IT IS HEREBY ORDERED that:

(1) The following Wisconsin locations, identified by township, range, and section under the Public Land Survey System (PLSS), are quarantined:

(2) Premises located within the identified areas may not move or allow movement of domestic birds or domestic bird products (including but not limited to eggs, meat, feathers, and manure) on or off the premises, without written Department approval.

(3) This order will remain in effect until the Department releases the control area or modifies the order in writing.

Pursuant to s. ATCP 10.89(6), Wis. Admin. Code, a person adversely affected by a quarantine order under sub. (1) may, within 30 days after the quarantine order is served, request a hearing before the department to review the quarantine. The department shall conduct an informal hearing as soon as reasonably possible, and not later than 10 days after receiving a request for hearing. If the matter is not resolved after informal hearing, the person requesting the hearing may seek a formal hearing under ch. 227, Wis. Stats., and ch. ATCP 1. A request for hearing does not stay a quarantine order.
