Explore and discuss updates to Nutrient Management, Prescribed Grazing, Residue Management, Riparian Buffers, and Subsurface Drains. DATCP staff will provide an update on cost sharing from contracting to reimbursement as well as considerations for the implementation monitoring and maintenance of updated practices included in the ATCP 50 administrative rule effective June 1, 2024.

Tuesday September 17 from 10-11 a.m.: New Practice Standard - Cover Crops

Formerly referred to as cropland cover, ATCP 50.68 was updated to provide options consistent with the USDA cover crop practice standard. Updates offer more flexibility to counties providing cost sharing for producers to implement nutrient management and conservation plan goals. Discuss considerations for implementation, monitoring, maintenance, required documentation, and eligibility for reimbursement.
