Dear Staff and ATCP 72 Advisory Committee Members,

Thank you for serving on this committee. My comments for October 31, 2023 are about the rule revision process and specific to tourist rooming houses/short term rentals.

#### **REQUEST for ACCESS**

Please advocate for a DATCP webpage where the public, those owning, operating and affected by these lodging businesses, can learn and contribute to the work. Agendas, materials and recordings for each meeting would aid municipalities and counties engaged in updating their own zoning and licensing ordinances. Please see the links to the current efforts in Sawyer County copied at the end of this message. The county provides the public with agendas, materials, minutes and video recordings.



#### **RURAL CONSIDERATIONS – PUBLIC HEALTH, SAFETY AND WELFARE**

The Northwoods has long been experiencing a growth in conversion of residences and second residence vacation homes to Tourist Rooming Houses / Short Term Rentals. The impacts range from reduction of already limited housing stock, inflated housing prices making homes unaffordable to local residents, to increased nuisances affecting neighbors' property enjoyment and increased enforcement costs passed on to taxpayers.

Lack of capacity limits for these lodging options contributes to increased problems with traffic, parking, trespass, fireworks, lights, noise, smoke and dust. There may also be related violations of local and county ordinances and DNR rules related to ATV/UTV, snowmobile and watercraft use. These are primarily public safety and welfare concerns.



#### **RURAL CONSIDERATIONS – PUBLIC HEALTH, SAFETY AND WELFARE CONT.**

Public health concerns are not adequately addressed in ATCP 72. Public water and sewer systems are fairly rare in rural areas, especially in the northern counties. With most development occurring along lakeshores, on essentially 100' wide by 200' deep, 20,000 square feet lots, each dwelling is served by its own private well and private onsite wastewater treatment system (POWTS). This concentration of private wells and POWTS systems impacts on drinking water (ground water) has not been adequately addressed. Prior Legislature's bills have tied the hands of local and county governments on being more restrictive (larger lot dimensions, setbacks, lower densities) to protect lakes and rivers (surface waters) and failed to consider the considerable public health consequences.

POWTS systems that are not properly maintained, or are used by large groups to exceed the capacity of the systems, endanger the ground water which is the drinking water supply of neighboring properties as well as the TRH/STR.



#### **DEFNITIONS**

The definitions outlined in the October 31, 2023 materials do not adequately address the private well water and POWTS systems that serve many tourist rooming houses. Private well and POWTS construction should be a factor in setting a capacity for lodging facilities.



#### **CONSISTENCY AND CLARITY**

Beyond these definitions, the proposed list and ATCP 72 are not clear on when separate TRH licenses are required for separate properties. In recently phone conversations with four different people involved with licensing TRH's, I received three different interpretations of license requirements where multiple TRH properties are held in common ownership.

(7) "Hotel" means all places wherein sleeping accommodations are offered for pay to transients, in 5 or more rooms, and all places used in connection therewith. "Hotelkeeper", "motelkeeper", and "innkeeper" are synonymous and "inn", "motel" and "hotel" are synonymous. (29) "Hotel" means a place where sleeping accommodations are offered for pay to transients, in 5 or more rooms, and all related rooms, buildings and areas.

Additional terms defined: "sleeping accommodations offered for pay", "tourist or transient", "room", "individually keyed unit."

- It is a best practice to cross-reference an existing definition, if possible.



#### Condensed cross-reference

(51) "Public water system" has the meaning given in s. NR 809.04 (67).

#### Expanded cross-reference

# (51) "Public water system" has the meaning given in s. <u>NR 809.04 (67)</u>.

**Note:** Section NR 809.04 (67) reads "Public water system" or "PWS" means a system for the provision to the public of piped water for human consumption through pipes or other constructed conveyances, if the system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year. A public water system is either a "community water system" or a "non-community water system." A public water system:

(a) Includes any collection, treatment, storage and distribution facilities under control of the water supplier for the public water system and used primarily in connection with the system.

(b) Includes any collection or pretreatment storage facilities not under the control of the water supplier for the public water system, which are used primarily in connection with the system.(c) Does not include any "special irrigation district."
