## Wisconsin Department of Health Services Secretary Kirsten Johnson

# Wisconsin Agricultural Statistics Survey Update Greg Bussler

Greg Bussler, State Statistician from the USDA National Agricultural Statistics Service presented his 2022 Census of Agriculture report to the Board on farms and land in farms, Wisconsin conservation and crop insurance, economics, value of production, farm income and expenses, dairy farms, farms with internet access, and the demographics of farm producers. #### Commercial Animal Feed Program Division of Agricultural Resource Management

Jordyn Johnston, Feed Program Manager presented on the Commercial Animal Feed Program, state license holders, Wisconsin Statute s. 94.72 and Wis. Admin. Code ch. ATCP 42, commercial feeds sampling, and education and outreach.

### 2023 Consumer Complaints Summary Division of Trade and Consumer Protection

Michelle Reinen, Division Administrator for Trade and Consumer Protection, presented the 2023 Division Highlights. In 2023, the Bureau of Consumer Protection received 10,882 written complaints returning \$3.3 million dollars to Wisconsin consumers; while the Bureau of Weights and Measures conducted over 226,000 inspections at more than 5,500 locations. She also presented on the top ten complaint categories of 2023, as well as the consumer confidence data on a variety of weights and measure devices.

### 2023 Public Outreach Summary Bureau of Consumer Protection, Division of Trade and Consumer Protection

Michael Domke, Director, Bureau of Consumer Protection, presented the Public Outreach Summary for 2023. He discussed ways the Bureau of Consumer Protection protects Wisconsin consumers and businesses, how they are the first line of defense against fraud information, and how the Department provides education on Wisconsin's consumer laws and helps the consumer learn how to prevent and protection against fraud. One way the Bureau does this is by giving free presentations to the public.

## Weights and Measures Program Highlights Bureau of Weights and Measures, Division of Trade and Consumer Protection

Joseph Smith, Director, Bureau of Weights and Measures, and Greg Bareta, Internal Operations Manager for Storage Tank Regulation, presented on the Weights and Measures Petroleum Program Highlights. They talked about how the Bureau of Weights and Measures is responsible for regulating petroleum and hazardous liquid storage tanks that are both above and below ground, discussed the fundamentals of the petroleum storage tank program, tank regulation, and collaborative programs they have with Wisconsin Department of Natural Resources and Environmental Protection Agency.

## Agricultural Producer Security Program Bureau of Business Trade Practices, Division of Trade and Consumer Protection

Jeremy McPherson, Director, Bureau of Business Trade Practices, presented on the Agricultural Producer Security Program. He presented on the Wisconsin Department of Agriculture, Trade and Consumer Protection administration of the agricultural producer security program under Wis. Stat. ch. 126and how it is designed to protect agricultural producers in the milk, grain, and vegetable industries from financial defaults by those purchasing the producer's products. He also discussed license types, grain warehouse keeper program information, milk contractors, information on the vegetable program, revenue and expenses, funds and credits, and security.

## Agricultural Export Highlights 2023 Year-End Report Division of Agricultural Development

Mark Rhoda-Reis, Director, Export and Business Development Bureau, presented a 2023 recap of agricultural exports to the Board. Wisconsin food, forestry, and agriculture product exports reached \$3.87 billion in 2023, the third highest level on record. Since 2021, the Wisconsin Initiative for Agricultural Exports' (WIAE) base year, the state's export of dairy, meat, and crop products has grown a net of \$210 million, or 5.3%. U.S. agriculture exports in 2023 were \$199 billion, down -9.7% from 2022.

### ATCP 161 Something Special from Wisconsin Division of Agricultural Development Statement of Scope

Julie Schmidt, Program and Policy Analyst and Lois Federman, Marketing and Outreach from the Division of Agricultural Development requested approval of Statement of Scope for ATCP 161 from the Board.

The Laboratory provides weights and measures standard calibration services for city and state regulatory officials, state licensed weights and measures service companies, and businesses and maintains the State of Wisconsin's standards of mass and volume. The Lab also tests fuel sold in Wisconsin to ensure it meets the specifications and octane ratings required under Wisconsin law.
