The Contribution of Agriculture to the Wisconsin Economy: An Update for 2024

Wisconsin Agricultural Statistics Survey Update Greg Bussler

Greg Bussler, State Statistician from the USDA National Agricultural Statistics Service presented his December 2024 report to the Board on milk production, chicken and eggs, October prices received, labor, and other noteworthy items.

Agricultural Export Highlights Year to Date Third Quarter Division of Agricultural Development

Mark Rhoda-Reis, Export and Business Development Bureau Director, Division of Agricultural Development presented the Quarter 3 export highlights:

- Wisconsin food, forestry, and agriculture product exports reached \$3.05 billion year-to-date in the third quarter, a 4.0% growth year over year, and 6.6%, above 2021.
- While Wisconsin agricultural exports are up 3.97% year to date, the U.S. is down 0.81%. Wisconsin is the 12th largest exporter of agricultural products in the U.S., up from 13th in previous years.
- The Q3 YTD 2024 exports of \$3.05 billion in agricultural products are tracked in three product groups:
 - o Dairy: cheese, whey, lactose, and milk proteins 16% of all Wisconsin agricultural exports
 - Meat: livestock, bovine genetics, hides, and furs 19% of all Wisconsin agricultural exports
 - Crop: grains, forestry, processed foods, and beverages 65% of all Wisconsin agricultural export

Office of the Secretary Report

Deputy Secretary Aileen Switzer presented the Office of the Secretary update to the Board on the following:

- Thank you, Dr. Deller and Dr. Hadachek for their presentation on The Contributions of Agriculture to the Wisconsin Economy.
- Thank you, Paul Bauer, for your service on the Board. Paul recently resigned from the Board. We appreciate Paul's dedication to the Board and agricultural industry.
- H5N1 dairy cattle disease. On December 6th USDA announced the start of its national milk testing strategy. DATCP continues to communicate with USDA to develop a plan to fit their model as our state's industry is unique. We have also been in contact with industry regarding this mandate.
- The Growing Wisconsin Magazine 2024-25 edition is now available. Earlier this year Governor Evers announced 2025 is the year of the worker. This year's magazine edition focuses on our State's agricultural workforce and contains stories on Wisconsin's colleges and universities, the Department of Corrections, and agricultural career pathways. Physical copies of the magazine will be available at the January Board meeting. Please feel free to distribute magazine widely. - DATCP announced this week that seven Wisconsin companies will receive a Dairy Processor grant. The next application period is open until January 17, 2025.
