PRELIMINARY 2026 JOINT ALLOCATION PLAN

- After being presented today, the Preliminary Joint Allocation Plan is released to counties and other interested parties for a 30-day comment period, ending September 5, 2025
- Comments received will be included in the Final Joint Allocation Plan, which will come before this board at the October 2025 meeting.

JOINT ALLOCATION PLAN

- Six different DATCP grants included in SWRM:
 - Staffing
 - Cost-share
 - NMFE
 - Innovation
 - Cooperator
 - Engineering Reserve

Funding to all 72 counties Goals:


- 100% of 1st position
- 100% of 2nd position (at 70%)
- 71% of 3rd position (at 50%)

Total Proposed Award: \$14,589,500

2026 STAFFING AND SUPPORT ALLOCATION INCREASE

- Planning for the 2026-2028 budget began in early 2025
- DATCP provided the latest complete set of staffing requests(2025) as a baseline for what would be needed to fully fund three (100/70/50%) staff positions per county
 - 2025 requests equaled \$14,589,496
- The 2026 allocation total for staffing is \$14,589,500
- 2026 requests were \$15,362,388
- Total allocation did not fully fund a third position because 2026 requests were higher than 2025 requests




Structural cost-share 72 awarded





- Cost-share Grants
 - Structural \$3,536,993 (54% of requests)
 - SEG \$2,299,950 (82% of requests)
 - Eng Reserve \$300,000
- Cooperator Grants
 - Statewide projects \$969,845 (90% of requests)
 - Innovation \$0 (0% of requests)
 - NMFE \$405,205 (100% of requests)



ENVIRONMENTAL ASSESSMENT

The environmental effects of the proposed allocation plan are positive. Through support for conservation staff and landowner cost-sharing, the proposed allocation plan will result in actions on farms and other areas that reduce soil erosion, prevent farm runoff, improve soil health, increase nutrient management planning, and minimize pollution of surface and groundwater.
