



Instructions for the Wisconsin Hemp Program Grower License and 2021 Annual Registration Application Form:

Please note, there is inherent risk associated with participation in a research program focusing on a new crop and with participation in the Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP) Hemp Research Program (hemp program). There is no guarantee that a crop will pass DATCP's regulatory analysis of total delta-9 tetrahydrocannabinol (total delta-9 THC).

DATCP's hemp program is authorized by the [2014 Farm Bill](#), the [2018 Farm Bill](#), [Wis. Stat. § 94.55](#), [2017 Wisconsin Act 100](#), and [2019 Wisconsin Act 68](#). The hemp program regulates the growth, cultivation and marketing of hemp, pursuant to [Wis. Stat. § 94.55](#) and [Wis. Admin. Code ch. ATCP 22](#). DATCP conducts regulatory sampling and testing to confirm that the total delta-9 tetrahydrocannabinol (total delta-9 THC) content in hemp crops is 0.3 percent or below, and certifies the crop to be hemp or requires its destruction.

Future of the Hemp Program:

There will be significant changes to the hemp program in the upcoming year:

On October 1, 2020, Congressional action extended the authority of states to operate hemp pilot research programs until September 30, 2021. Due to this action, DATCP has converted and extended the current hemp program operated under the authority of the 2014 Farm Bill to September 30, 2021. Under federal rules, the hemp pilot research program was scheduled to end on October 31. The recently signed [Continuing Appropriations Act, 2021 and Other Extension Act, \(Public Law No: 116-159\)](#) allows states to extend their hemp pilot research programs until September 30, 2021.

Under state law ([Wis. Stat. § 94.55](#)), DATCP must regulate the Wisconsin hemp industry to the extent required under federal law and in a manner that allows the greatest opportunity to “plant, grow, cultivate, harvest, produce, sample, test, process, transport, transfer, take possession of, sell, import, and export hemp in this state to the greatest extent allowed under federal law.” DATCP has determined that the hemp research program currently provides the Wisconsin hemp industry the greatest opportunity and has made the decision to continue implementing the state hemp program under the authority of the 2014 Farm Bill, instead of operating under the authority of 2018 Farm Bill and the federal Interim Final Rule. With support from Wisconsin's hemp industry, DATCP continues to focus on ways to best serve and support the hemp grower and processor communities.

In Wisconsin, a new hemp emergency rule is effective October 29, 2020. This emergency rule for [Wis. Admin. Code ch. ATCP 22](#) converts the Wisconsin hemp pilot research program to the hemp program. The hemp



program is consistent with the pilot program and allows Wisconsin’s hemp growers to plant, grow, and process hemp. The hemp program continues to operate under the 2014 Farm Bill research program.

General Information

This is the application packet for the research program grower license and registration. This initial application will cover a new hemp grower license and 2021 annual registration. To grow hemp in Wisconsin requires **both** a grower license and annual registration for each year in which you plan to grow hemp.

Invoiced Fees for Future Modifications to a Hemp Grower License / 2021 Annual Registration

In addition to your licensing and annual registration fees, there are several hemp program fees that will be invoiced as appropriate. Any changes to your Hemp Grower License after it has been issued, will result in the following fees.

Fee Type	Fee Amount	Fee Purpose
License amendment	\$50	Any amendment to the application made after the license is issued, including growing location changes. Each license amendment will incur a license amendment fee of \$50. Additional license fees may be assessed if changes add growing acreage above the amount stated on the license application. <i>This does not apply to Hemp Growers who later decide not to plant.</i>
Additional acreage fee	\$5/acre not to exceed \$850	For each additional acre a licensed grower wants to plant that was not included in the initial license application. A license amendment fee will not be charged if the additional acreage is requested and paid for during the annual registration period. The initial application fee is not refundable for acreage equal to or less than the area registered on your license.
Sampling and analytical fee	\$250	For the actual cost of a sample and composite test. One (1) sample and test is required <u>per</u> lot of hemp grown. The sampling and analytical fee will be invoiced after the lot of hemp has been sampled.
Re-Sampling and analytical test fee	\$250	For the actual cost of an optional sample and composite retest to be conducted if the original test result is between 0.3 percent and 1.0 percent THC. This charge only applies to each lot of hemp that is re-sampled and tested. The re-sampling and analytical test fee will be invoiced after the lot of hemp in question has been re-sampled.
Change of operations manager	\$15	For the actual cost of a new background check if a licensed grower changes the operation manager named on the license. Only a license holder that is a business can change an operations manager.

Consider your current needs and your future plans when completing this application packet.

You must complete the hemp grower application form. Hemp program staff will provide instructions for submitting your 2021 hemp program research agreement (research agreement) and background check consent form after your completed hemp grower application form is received. A 2021 research agreement is required for each existing licensee or new applicant who will be growing hemp in 2021. A background check consent form



is required for each new applicant and those existing business licensees changing their operations manager for the 2021 license year.

Instructions for submitting a background check consent form and 2021 research agreement will be sent to the existing license holder or new applicant upon receipt of the completed license application form. Detailed instructions for completing the hemp grower license/ annual registration application form:

Section 1 – Business and Contact Information

In the section marked “*Applicant Type*”, specify which of the two applicant types you are. In the field marked “*Legal Name of Applicant*”, provide the applicant's legal name or legally formed business name. Provide your principal Wisconsin business location address in the following fields: “*Business Headquarters County*”, “*Business Headquarters Address*”, “*City*”, “*State*”, and “*Zip*”. If you do business under any other name, provide that in the field marked “*Doing Business as Name or Trade Name*”. If you are applying as an individual, your operations manager must be the same person as the individual who is applying for this license. If you are applying as a legally formed business, provide the full name of the individual who is authorized to sign on behalf of your business entity in the field marked “*Operations Manager*”. Also provide the operations manager’s phone number and their email address. If you are applying as a legally formed business entity, the individual named in the field marked “*Operations Manager*” must later complete the background check consent form. If you are applying as individual, the person applying for this license will later complete the background check consent form.

Section 2 – Consent to Publically Share License Holder Information

Use the check boxes to indicate which information you will allow DATCP to make publically available. You do not have to select anything. DATCP will only share the information you specify by checking the specific box. The specified information will be shared on our website, and updated regularly.

Section 3 – Summary Information

Please indicate if you plan to grow hemp during the 2021 license year. If you plan to grow hemp in 2021, make sure to pay for the license **and** the 2021 annual registration. To grow hemp in Wisconsin in the 2021 license year, you need a hemp grower license and 2021 annual registration.

Section 4 – Growing Location(s)

If you have more than two locations, use additional sheets to include the location information as indicated on the application form.

This section is required if you are growing hemp in the 2021 license year. In the field marked “*Location Name*”, provide the field or greenhouse name that you use for each hemp growing location. Provide the Address, City,



State, ZIP, Town or Municipality, and County of your hemp growing locations. The GPS coordinates (Latitude and Longitude, in decimal degrees) of the center of your growing location are required in the field marked “*Growing Location GPS Points*”. At the field marked “*Acreage*” provide the area, in acres, of your growing location. When calculating the area of a greenhouse, convert greenhouse area measured in Square Feet to Acres using 43,560 square feet = 1 Acre. In the field marked “*Exact Road Directions to Growing Location*”, provide the driving directions from a major intersection to your growing location. Attach plat maps or other maps on a separate sheet. Specify if this property is a Field or a Greenhouse. Specify if you own or lease the property on which your field or greenhouse is located. If the location's property owner is different from the applicant for this license, specify their name in the field marked “*Name of the Property Owner*”. Include the property owner's email address and phone number in the fields marked “*Property Owner Phone* and *Property Owner Email*”.

Section 5 – Applied Research Information

Affiliation with a college or university:

Indicate if you are affiliated with a college or a university, and name the institution. You may need to work with the college or university governing board to complete the application materials. Hemp program staff will follow up with you about this.

Participation in another state or tribal hemp program:

Indicate if you have been a participant in another state or tribal pilot hemp program, USDA-approved state program, or USDA program. If so, please specify which state or tribe, and which program.

Applied research description and research summary:

The applied research description and research summary are mandatory if you are growing in hemp in 2021. Under “*Applied Research Description*”, check all the boxes which apply to the nature of your proposed research. Under “*Research Summary*”, provide a brief, overall summary of the hemp research you are conducting, attach additional pages if needed. If you are growing hemp in the 2021 license year, hemp program staff will contact you with instructions for submitting your research agreement, which is separate from the research summary.

Section 6 – License Fee / Registration Fee and Calculation

If you intend to grow hemp in the 2021 license year, pay the hemp grower initial application fee in Table 1 **and** the hemp grower annual registration fee in Table 2. Please note that the initial application fee for hemp growers, as indicated in Table 1, is required of all new applicants regardless of whether or not a license is issued. The initial application fee for 0 to 30 acres is not refundable. In Table 1, determine which initial application fee tier applies to you, and assess your fee accordingly. If your total acreage is 0 to 30 acres, your initial application fee will be \$150. If your Total Acreage is 31 to 199 acres, your initial application fee will be \$5 per acre. If you total acreage is 200 acres or more, your initial application fee will be \$1,000. If you plan on growing hemp in 2021, your annual registration fee is \$350. The supplemental federal background check fee only applies to new applicants or a new operations manager. If you are a new applicant and if you have not already paid this fee as part of a hemp grower application, hemp program staff will invoice you for \$21.25 for the federal background check later on in the application process.
