2025 FSIS Onsite Audit



- > Every 3 years
- > Approximately 16 establishments
- Establishment selections based on a number of criteria
- ➤ Scheduled for July 27 August 8, 2025

FSIS Notice 50-24 FSIS Testing For Non-Listeria Monocytogenes Listeria Species

- FSIS published Notice 50-24 adding testing for non-Lm Listeria species to all ready-to-eat (RTE), routine Listeria monocytogenes (RLm) and intensified verification testing (IVT) sampling projects.
- > BMBP has implemented this testing as of April 1, 2025.



Generic E. Coli Testing

- Generic E. coli sampling begins this week
- Weekly sampling of the predominant species slaughtered during the previous year
- Sampling continues until a total of 13 samples have been collected

Examples of noncompliance 9 CFR 310.25

Not having written procedures

Not collecting 13 samples

Not graphing or charting the results

Not keeping the results for 12 months



Formulations

- Formulations are required to be submitted and approved by BMPB before the product is produced.
- Be sure to include casing information on the formula at the time of submittal.
- Best practice is to monitor incoming ingredients to ensure the supplier did not change the formulation and introduce or change the allergen(s) present.

License Renewals

- License renewals are due by June 30, 2025
- If you wish to add a new product in a new HACCP category that would affect your license, making the change at renewal is not the proper way to communicate this change.

Value of a Weekly Meeting

- Dedicated time to speak to your inspector
- Review any open NRs
- Discuss plans for future production/products, facility improvements, etc.
- Discuss inspection needs*
- Sample results
- Changes to FSIS directives or BMPB policy



Appeal Process

- The appeal processor mirrors that of FSIS as outlined in FSIS Directive 13000.3 Revision 2 Responding in PHIS to Industry Appeal of a Noncompliance Record.
- Establishments have 30 days to appeal a noncompliance record or order
- Appeal process follows the Bureau's chain of command

When to Hire a Consultant

- 9 CFR 417.7 requires an individual to have successfully completed a course of instruction in the application
 of the seven HACCP principles to meat, poultry, or egg products processing, including a segment on the
 development of a HACCP plan for a specific product and on record review to perform the following
 functions:
- (1) Development of the HACCP plan, in accordance with § 417.2(b) of this part, which could include adapting a generic model that is appropriate for the specific product; and
- (2) Reassessment and modification of the HACCP plan, in accordance with § 417.3 of this part.
- Reassessment and modification of the HACCP plan in accordance with 9 CFR 417.4(a)(3)(i)
- Assistance with corrective actions and HACCP plan modification related to an enforcement action



Best practices when Hiring a Consultant

- Speak to multiple consultants verify experience as well as "fit"
- On-site the HACCP plan needs to fit your process

MEAT AND POULTRY RESILIENCY GRANT PROGRAM Governor Evers created the Meat and Poultry Supply Chain Resiliency Grant, investing up to \$10 million to continue to grow Wisconsin's meat processing industry and improve the long-term viability of the state's livestock industry. Grants were capped at \$150,000.



INDUSTRY INPUT INFORMED THE PROCESS



A series of virtual stakeholder meetings were held precipitated by supply chain challenges brought on by COVID-19



Need for investment in Wisconsin's Meat Sector became apparent

Meat Processors had strong feelings about requirements

Dollar for Dollar (100%) Match

Harvest and/or further processing capacity must meet a 20% threshold for each project



GOALS



- 100 applications received
- \$11.1 million requested
- 88 awardees were announced
- 48 Counties



AWARDEES

Establishmentsreceiving grants variedin size and businessmodel

Well known companies to start-ups



IMPACTS

- New equipment was able to cut labor costs
 - Employees trained to do other jobs within business
 - 78% of awardees added at least one full-time employee
 - New employees ranged from 1 to 25



HARVEST CAPACITY INCREASED

- All establishments that harvest increased capacity
 - Project increases ranged from 2 or 3 head weekly to 300 head/day
 - Even a 20% increase representing a small number of head makes a significant dent to the farmers in that area



Grant amounts ranged from \$25,000 to \$150,000

Project sizes ranged from \$50,000 to \$8 million

All establishments met the 1:1 match requirement

INVESTMENT

MEAT AND POULTRY SUPPLY CHAIN RESILIENCY GRANT IMPACTS

218 full-time and68 part-time jobscreated

Increased gross profits per year realized by projects: \$32,416,073

Dollars invested by meat processors on projects: \$41,138,875

Each grant dollar increased meat processor gross sales by \$3.97

Each grant dollar spurred **\$5.04** in industry investment




