LICENSE REQUIREMENTS

No person shall manufacture or distribute soil and plant additives in this state without an annual license from the Department and a soil or plant additive product permit issued by the Department for each product, except that no license is required of a person who only distributes a soil or plant additive for a license holder for which the Department has already issued a permit, provided the person:

1. Distributes the soil or plant additive under the name of the license holder and in the original container packaged and labeled by the license holder, and
2. Makes no content or performance claim for the soil and plant additive other than the written claim of the license holder.

If the location of any Wisconsin manufacturing facility changes, you must submit the new address(es) to DATCP.

Important: Before the Department can renew the license to distribute a soil or plant additive, you are required to submit your tonnage report and complete the update of soil or plant additive listing for products you are distributing in Wisconsin. If the product label has changed, submit a new label.
