2019 Export Highlights, 1st Quarter

Highlights

- Wisconsin exported over \$800 million in agricultural and food products to 147 countries in the first quarter of 2019, a decrease of 4.8 percent, or nearly \$40 million in value compared to the same period last year. Food and Agriculture Exports made up 14.8 percent of Wisconsin's overall Q1 exports of \$5.42 billion are down 0.6 percent from the same period last year. Total U.S. agricultural exports were valued at \$40.8 billion, a decrease of 4.57 percent compared to the same period last year.
- The top three export markets Canada, China and Mexico make up over 57% of total exports and contributed nearly \$49 million to the loss for the same period in 2018. Of the top five markets only Japan was up, 1.7 percent.
- Among the top 20 markets that make up nearly 89 percent of all Wisconsin exports, nine of those markets
 had double-digit increases totaling a little over \$25 million. The bright spots were: Thailand up over 71
 percent, Germany, up over 59 percent, Saudi Arabia up nearly 47 percent, Singapore and Italy up nearly 25
 percent. The top five markets are highlighted below
 - Canada Q1: \$349 million, down 6.2 percent
 - China Q1: \$56 million, down 31.3 percent
 - Mexico Q1: \$53 million, down 0.7 percent
 - Korea Q1: \$46 million, down 18.8 percent
 - Japan Q1: \$42 million, up 1.7 percent
- The top five product categories making up 43 percent of total exports totaled over \$346 million in Q1 of 2019 and declined nearly 6% from the same period last year. The top 20 products exported make up nearly 95% of total exports, totaling \$754 million, declining 6.5%. The top five products are highlighted below...
 - Misc. Preparations, Sauces, yeasts \$93 million, down 2.7 percent
 - Prepared Vegetables, Fruit, Nuts \$76 million, up 8.6 percent
 - Wood and Wood Articles
 - Dairy Cheese and Whey*
 - \$58 million, down 18.9 percent

- Wisconsin currently ranks 14th among U.S. states in agricultural exports, first in the export of ginseng roots, prepared/preserved cranberries, sweet corn prepared/preserved, raw fur skins and bovine semen. Wisconsin ranked second in the export of whey and third in the export of cheese.

Impact of China - Retaliatory Tariffs

- Nearly one-third, \$1.43 billion of Wisconsin agriculture and food exports are affected by the countervailing tariffs in China. The full list is over 40 items, identified by their Harmonized System (HS) code. An estimated one-quarter to one-half of the list are expected to receive the additional 15 percent tariff, pushing the tariff rates to 25% and above for some items
- Overall, there was a nearly 1.4 percent drop in exports of the tariffed items from 2017 to 2018 and in the first quarter of 2019 a nearly 21 percent drop of those same items compared with the same period last year.
- The major product categories of Dairy, Lumber, Ginseng, Cranberries, Prepared Foods, Beverages (ethanol), Cranberries, Hides and Skins (mink & bovine), Beverages and Animal Feed are all directly affected. Soybeans and corn are indirectly affected as those commodities are shipped to processing facilities in other states and counted as exports from those locations.
