Subchapter V General Provisions

Ted Tuchalski presented draft language for the following sections: ATCP 79.19 Building and premises maintenance, ATCP 72.20 Furnishings, equipment, and utensils, ATCP 72.21 Food, ATCP 72.22 Employee health, ATCP 72.23 Garbage and refuse, ATCP 72.24 Registration of guests, ATCP 72.25 Death, injury or illness reports, and ATCP 72.26 Closing criteria.

The following edits were suggested:

- Reed McRoberts asked that parking areas “maintained to minimize dust and dirt” be removed from the exterior premises paragraph.
- Bill Elliott and Greg Stillman raised a concern on the availability of a licensed pest control operator in rural areas if the department or agent health department ordered an operator to hire a licensed pest control operator. Bill and Greg will propose modified language at the next meeting.

- Craig Kratcha asked for additional canned signage language for utensil sanitization to address sanitizers other than chlorine/bleach.
- Trista Groth and Brandon McConnell had concerns over the interpretation of “free of stains” on mattresses.
- Brandon McConnell asked for commercial refrigeration to be added to the subdivision regarding grocery shopping requested by the guest.
- Bill Elliott and Brandon McConnell questioned the scope of the death, injury, or illness reports section. Bill and Brandon will propose modified language at the next meeting.
- Troy Sprecker suggested clarification on closing criteria as it relates to pests.
