REQUESTED ACTION:

At the March 2, 2023, Board meeting, the Department of Agriculture, Trade and Consumer Protection (DATCP) will ask the DATCP Board (Board) to approve a Preliminary Public Hearing Notice for a Statement of Scope for potential changes to ch. ATCP 72 relating to Hotels, Motels and Tourist Rooming Houses.

SUMMARY:

DATCP licenses hotel, motel, and tourist rooming house operators under the authority of ch. 97.613 of the Wisconsin Statutes. ACTP 72 Hotels, Motels and Tourist Rooming Houses has not been substantially updated since 1978. At the request of industry stakeholders, the department proposes to update the rule to reflect current industry standards and address emerging health and safety issues. At this time, the department also proposes to re-evaluate its licensing fee structure to reflect the department's responsibilities for conducting inspections and investigations. The department has not increased license fees since 2008. The current program revenue received from license fees has not kept pace with the increased costs for maintaining the lodging program, which includes internal and external education, licensing, inspections, and compliance.

Contingent upon Board approval, the Department has planned three public hearings on the Statement of Scope to be held in person on Wednesday, March 29, 2023, from 10:00 a.m. to 2:00 p.m. in Eau Claire, Thursday, March 30, 2023, from 10:00 a.m. to 2:00 p.m. in Stevens Point, and Tuesday, April 4, 2023, from 10:00 a.m. to 2:00 p.m. in Madison. A virtual option via Microsoft Teams will be offered at the Madison meeting.
