Statement Public Hearing Approval

REQUESTED ACTION:

At the September 22, 2022 Board meeting, the Department of Agriculture, Trade and Consumer Protection (DATCP) will ask the DATCP Board to approve a public hearing for proposed technical amendments to three current DATCP rules related to fair packaging and labeling, selling commodities by weight, measure or count, and weights and measures.

A scope statement spells out the general purpose and scope of a proposed rule. In accordance with Wis. Stat. § 227.135 (2), the Governor approved this scope statement for permanent rule changes on August 25, 2022, thereby allowing DATCP to submit this scope statement for publication and to seek approval of the scope statement by the DATCP Board.

DATCP formally published this scope statement in the August 29, 2022 *Wisconsin Administrative Register* and filed a copy with the Department of Administration at least 10 days before the Board could approve the scope statement. After publication, the Joint Committee for the Review of Administrative Rules required DATCP to hold a public hearing on the scope statement under Wis. Stat. § 227.136 (1). DATCP plans to hold that hearing on Thursday, October 13, 2022, at 11:00 a.m. in the DATCP Board Room with an electronic attendance option.

If the Board approves the scope statement hearing, the Department will consider any public comments to the scope statement and seek approval of it at a future Board meeting.
