Wisconsin Agricultural Statistics Survey Update Greg Bussler

Greg Bussler, State Statistician from the USDA National Agricultural Statistics Service presented his November 17, 2022 report to the Board on the October Crop Production Report; 2022 Small Grain Summary; Milk Production; Chicken & Eggs; Prices Received; Crop Progress as of November 6, 2022; and other noteworthy items.

Agricultural Producer Security Update Division of Trade and Consumer Protection

Jeremy McPherson, Bureau Director from the Division of Trade and Consumer Protection presented an agricultural producer security update to the Board. The Department administers an agricultural producer security program under Wis. Stat. ch. 126 which is designed to protect agricultural producers from financial defaults by those purchasing the producer's products.

Agricultural Enterprise Areas Division of Agricultural Resource Management

Wednesday Coye, Environment Analysis & Review Specialist from the Bureau of Land & Water Resources, presented the Agricultural Enterprise Areas (AEA) and the 2022 Petition Cycle overview to the Board. AEAs are an area of productive agriculture and local communities can voluntarily pursue designation of an AEA by submitting a petition to the Department. On August 10, 2022, the petition evaluation committee recommended to the Secretary the designation of the Stanton Farmland Heritage Preservation AEA in St. Croix County and the Town of Princeton AEA in Green Lake County.

Agrichemical Management: Online Certification Exam Process and EPA State Plan Updates Division of Agricultural Resource Management

Robby Personette, Bureau Director of Agrichemical Management presented on overview of Agrichemical Management online certification exam process and the EPA State Plan updates to the Board. The Bureau's pesticides responsibility includes certifying and licensing pesticide applicators; licensing businesses that manufacture, sell or apply pesticides; operating the Landscape Pesticide Notification Registry; administering agrichemical storage and spill laws; funding some Clean Sweep hazardous waste and prescription drug collections; and enforcing the Worker Protection Standard and other pesticide, feed and fertilizer laws. Its fertilizer responsibilities include licensing the manufacture and distribution of fertilizers; distribution of soil and plant additives and lime; and regulation of fertilizer labeling. Finally, the Bureau's feed authority includes licensing manufacture, labeling and distribution of livestock feed and pet food; and issuing certificates of free sale for feed exports.

Q3 Ag Export Highlights Division of Agricultural Development Presentation

Mark Rhoda-Reis, Bureau Director of the International Agribusiness Center, gave the Q3 agriculture export highlights to the Board. Wisconsin's export of food, forestry, and agricultural products reached an all-time high of \$3.94 billion in 2021. YTD Q3 2022 exports are \$3.23 billion which is up 13.6% from the same period in 2021. Wisconsin's top five export markets posted gains in the third quarter, including Canada, China, Mexico, and Korea. Canada and Korea recorded double digit gains. Dairy is up nearly 38%, crops are up over 14%, and meat is down nearly 2%.

Secretary Randy Romanski presented the Office of the Secretary update to the Board on:

- Port Milwaukee staff on water levels in Lake Michigan.

- Signed a \$2.94 million cooperative agreement with the U.S. Department of Agriculture's Agricultural Marketing Service to create the Wisconsin Local Food Purchasing Assistance Program.
- Dairy Processor Grants open now through January 30th.
- HPAI outbreaks.
- Trips to UW River Falls regarding Humane Handling Institute and Dairy Summit.
